The walls defended the city against intruders, including Attila the Hun, before finally being breached by European knights during the Fourth Crusade in 1204 and, ultimately, destroyed by Turkish artillery in 1453.

Byzantine Constantinople

Byzantium. Was it Greek or Roman, familiar or hybrid, barbaric or civilized, Oriental or Western? In the late eleventh century Constantinople was the largest and wealthiest city in Christendom, the seat of the Byzantine emperor, Christ's vice-regent on earth, and the center of a predominately Christian empire, steeped in Greek cultural and artistic influences, yet founded and maintained by a Roman legal and administrative system. Despite the amalgam of Greek and Roman influences, however, its language and culture was definitely Greek. Constantinople truly was the capital of the Roman empire in the East, and from its founding under the first Constantine to its fall under the eleventh and last Constantine the inhabitants always called themselves Romaioi, Romans, not Hellenists, Greeks. Over its millennium long history the empire and its capital experienced many vicissitudes that included several periods of waxing and waning and more than one golden age. Its political will to survive is still eloquently proclaimed in the monumental double land walls of Constantinople, the greatest city fortifications ever built, on which the forces of barbarism dashed themselves for a thousand years. Indeed, Byzantium was one of the longest lasting social organizations in history. Very much part of this success story was the legendary Varangian Guard, the elite body of axe-bearing Northmen sworn to remain loyal to the true Christian emperor of the Romans. There was no hope for an empire that had lost the will to prosecute the grand and awful business of adventure. The Byzantine empire was certainly not of that stamp.

Ottoman Fortifications

The Ottoman Empire was heir to the architectural traditions not only of the Byzantine Empire but also to those of the medieval Islamic Middle East. Having learned from these, the Ottomans created a fusion of military architectural styles to which they added what they learned from their later medieval and early

modern European rivals. This book explores the historical background, socio-political circumstances and purposes of Ottoman military architecture, and reveals the incorporation of many different traditions that led to specific developments in form, function and decoration of these remarkable constructions. Among the areas covered are urban fortifications and the role of cities, frontier fortresses and the role of the Janissaries, garrison citadels as seats of power, and the role of small forts in protecting major communications, trade and pilgrimage routes.

A prelude chapter sets the stage for the hegemonic conflict, which was divided into three distinct phases by interludes of relative peace between the contending parties, during which Bulgaria's domestic, foreign, and cultural developments shaped the nature and conduct of the fighting in each successive phase.

Ottoman Fortifications 1300–1710

The Avar Siege of Constantinople in 626

The late Byzantine period was a time characterized by both civil strife and foreign invasion, framed by two cataclysmic events: the fall of Constantinople to the western Europeans in 1204 and again to the Ottoman Turks in 1453. Mark C. Bartusis here opens an extraordinary window on the Byzantine Empire during its last centuries by providing the first comprehensive treatment of the dying empire's military. Although the Byzantine army was highly visible, it was increasingly ineffective in preventing the incursion of western European crusaders into the Aegean, the advance of the Ottoman Turks into Europe, and the slow decline and eventual fall of the thousand-year Byzantine Empire. Using all the available Greek, western European, Slavic, and Turkish sources, Bartusis describes the evolution of the army both as an institution and as an instrument of imperial policy. He considers the army's size, organization, administration, and the varieties of soldiers, and he examines Byzantine feudalism and the army's impact on society and the economy. In its extensive use of soldier companies composed of foreign mercenaries, the Byzantine army had many parallels with those of western Europe; in the final analysis, Bartusis contends, the death of Byzantium was attributable more to a shrinking fiscal base than to any lack of creative military thinking on the part of its leaders.
