Meanwhile, Japan and others still have low prevalence rates, but need to remain vigilant and active if they are to avoid an epidemic. The varied responses by each society to the rising threat offer critical and practical lessons. Rural Workers' Contribution to the Fight Against HIV/AIDS

Human Rights Watch a Dose of Reality: Women's Rights in the Fight Against Hiv/aids

The 1992 creation of the National HIV/AIDS Program was a fundamental step for Argentina to reach the second lowest burden of HIV/AIDS in South America. From 2000 to 2010, Argentina further reduced the already low HIV/AIDS incidence of 15.9 per 100,000 by 25 percent and reduced the burden by 21 percent. This study analyzes the national and inter-provincial burden of disease, the demographics of new HIV cases, the demand and supply-sides of service delivery, and conducts a cost-benefit analysis of the National HIV/AIDS Program over the last decade. Though the National HIV/AIDS Program was an instrumental step towards these achievements, this book also examines other key programmatic innovations that have been essential to the country's success in the fight against HIV/AIDS, including the introduction of universal free antiretroviral treatment; a comprehensive legal framework for sexual and reproductive rights; the introduction of incentives and results-based financing in the HIV/AIDS program; electronic monitoring of supplies and medicines; and implementation of an electronic clinical governance system for improving the quality of care and patient follow-up, among others. Despite high costs of the Program, this study found the Argentine National HIV/AIDS Program is cost-beneficial. From 2000 to 2010, 4,379 potential lives were saved. Nonetheless, the fight against this epidemic poses continuous challenges, including a stubbornly high number of new infections among young men who have sex with men, inequalities in HIV/AIDS rates between provinces, insufficient coverage of HIV diagnostic testing, insufficient HIV testing of tuberculosis patients, low expenditure on HIV prevention, high comparative cost of antiretroviral treatment, and questions regarding the long-term financial sustainability of the AIDS program, considering the increasing number of patients in treatment. 'Thirty Years of the HIV/AIDS Epidemic in Argentina: An Assessment of the National Health Response' delves into the combination of factors that make Argentina a success story in combating HIV/AIDS.

Walking Together, Walking Far

Employers' Handbook on HIV/AIDS

This book aims to contribute to these efforts by offering a demographic and epidemiological perspective on emerging and reemerging infections in sub-Saharan Africa.

Strategies for Overcoming HIV/AIDS Challenges

Between 2002 and 2013, bilateral donors spent over \$64 billion on AIDS intervention in low- and middle-income countries. During the same period, nearly 25 million died of AIDS and more than 32 million were newly infected with HIV. In this book for students of political economy and public policy in Africa, as well as global health, Kim Yi Dionne tries to understand why AIDS interventions in Africa often fail. The fight against AIDS requires the coordination of multiple actors across borders and levels of governance in highly affected countries, and these actors can be the primary sources of the problem. Dionne observes misaligned priorities along the global chain of actors, and argues this misalignment can create multiple opportunities for failure. Analyzing foreign aid flows and public opinion polls, Dionne shows that while the international community highly prioritizes AIDS, ordinary Africans view AIDS as but one of the many problems they face daily.

HIV, Resurgent Infections and Population Change in Africa

HIV/AIDS infections are transmitted mainly through behaviour which is private, secret and often hidden. As such, the infection or even the suspicion of infection leads to stigma and discrimination. Discrimination practices have targeted persons that are subsumed under "high-risk" groups (like prostitutes, drug-users and homosexuals). These persons are categorised according to the presumed risk that they are identified with. Such categorisation not only challenges the rights of the individuals but the categorised persons are also victimised under the guise of preventing HIV/AIDS. This undermines efforts to reach these persons and seek their active cooperation in the fights against HIV/AIDS. In order to prevent the spread of this disease various welfare organisations and programmes have also been set up by the Government Organisations. But setting up of the project alone will not help, until and unless we all participate in fighting against the cause of prevention of HIV/AIDS. If we want to set up a HIV/AIDS free society, every one of us should join hands and make a little effort to remove the roots of this dreadful disease from the threshold of our society. The study is confined to the role of government organisations of the high prevalence states- Karnataka and Manipur. Finding funds to fight HIV/AIDS is a serious problem in both the states because the potential costs are staggering. On one hand, diverting funds from other problems to HIV/AIDS control may distort health priorities, while on the other hand, if proper funds are not made available, the economic consequences may be more devastating. The efforts made so far in dealing with the HIV infection/AIDS epidemic cannot be described as totally inadequate and certain issues can be faced socially by creating the required social environment and providing certain social services.

Doomed Interventions

This edited volume analyzes African state responses to the AIDS epidemic. Institutionally weak, limited in resources and lacking power in the international system, the African state has been characterized as inefficient, corrupt and illegitimate. The volume questions how aspects of the African state have affected policy responses to AIDS. It highlights how African states must initiate, develop and/or implement the long-term policy solutions necessary to combat AIDS. It employs empirical studies from the international and national arena to illustrate why some African states have been able (and willing) to address AIDS while others have not. Contributions analyze how international actors, civil society organizations, state ideology, patriarchy and state capacity have influenced policies to fight AIDS. Examining AIDS policies through the prism of African state development and linkages to domestic and international actors, this book provides a nuanced understanding of the variety of responses to AIDS in Africa.

He, along with others, fought for the government to recognize the cause of the disease, allowing antiretroviral medications to be approved for those who were HIV-positive and educating the population about HIV/AIDS. The Political Economy of HIV/AIDS in Developing Countries

As global health institutions and aid donors expanded HIV treatment throughout Africa, they rapidly "scaled up" programs, projects, and organizations meant to address HIV and AIDS. Yet these efforts did not simply have biological effects: in addition to extending lives and preventing further infections, treatment scale-up initiated remarkable political and social shifts. In Lesotho, which has the world's

second highest HIV prevalence, HIV treatment has had unintentional but pervasive political costs, distancing citizens from the government, fostering distrust of health programs, and disrupting the social contract. Based on ethnographic observation between 2008 and 2014, this book chillingly anticipates the political violence and instability that swept through Lesotho in 2014. This book is a recipient of the Norman L. and Roselea J. Goldberg Prize from Vanderbilt University Press for the best book in the area of medicine.

Amnesty International and the Fight Against HIV/AIDS

Research Paper from the year 2012 in the subject Communications - Journalism, Journalism Professions, language: English, abstract: This study is a contribution to development in the field of journalism in Malawi and neighbouring countries of Malawi, Zambia and Tanzania, at a time of growing concern about the developmental challenges being posed by the spread of the HIV/AIDS pandemic in Southern Africa. For Malawi in particular, it examines the struggle against the pandemic that has been underway since 1993 and how the interventions to check its spread have included calls for projects and information that would lead to behaviour change and lowering of infection rates. The campaign along this line has targeted the media, among key stakeholders. To gauge the extent to which journalists are playing their role in the campaign in question, a survey was carried out in Malawi and then also in Zambia and Tanzania. This revealed that journalists in all the three countries covered are currently somewhat hampered in their advocacy of HIV/AIDS issues, and that is due to several factors. These include the dearth of communication research in the region, as well as the related lack of relevant education and training opportunities for journalists. They also encompass the absence of laws granting journalists access to relevant government information about epidemiology; the culture of silence which surrounds the exchange of news about HIV/AIDS related deaths and competition in the media posed by popularity of stories about politics, economics and religion. As a way forward, it is proposed and recommended that journalists should be linked to projects that directly address the needs of local communities in the national campaign against HIV/AIDS. These would be projects like those which incorporated the citizen participation tradition, by empowering even the least respected members of the society. For the media, these include community radio stations, and vernacular newspapers. For

The Quest of HIV/AIDS Preventive Measures.

This book studies the role of civil society organisations in the fight against HIV/AIDS in Russia. It looks at how Russia's HIV/AIDS epidemic has developed into a serious social, economic and political problem, and how according to the United Nations Programme on HIV/AIDS (UNAIDS), Russia is currently facing the biggest HIV/AIDS epidemic in all of Europe with an estimated number of 980,000 people living with HIV in 2009. The book investigates civil society organisations' contribution to social change and civil society development in post-Soviet Russia, and thus situates a specific type of civil society actors into a broader socio-political context and questions their ability to represent civic interests, particularly in the field of social policy-making and health. When a scientific effort fails to independently confirm the computations or results of a previous study, some fear that it may be a symptom of a lack of rigor in science, while others argue that such an observed inconsistency can be an important precursor to new discovery. Rural Workers' Contribution to the Fight Against HIV/AIDS

From 2000 to 2010, Argentina further reduced the already low HIV/AIDS incidence of 15.9 per 100,000 by 25 percent and reduced the burden by 21 percent. This study analyzes the national and inter-provincial burden of disease, the demographics of new HIV cases, the demand and supply-sides of service delivery, and conducts a cost-benefit analysis of the National HIV/AIDS Program over the last decade. Nonetheless, the fight against this epidemic poses continuous challenges, including a stubbornly high number of new infections among young men who have sex with men, inequalities in HIV/AIDS rates between provinces, insufficient coverage of HIV diagnostic testing, insufficient HIV testing of tuberculosis patients, low expenditure on HIV prevention, high comparative cost of antiretroviral treatment, and questions regarding the long-term financial sustainability of the AIDS program, considering the increasing number of patients in treatment. 'Thirty Years of the HIV/AIDS Epidemic in Argentina: An Assessment of the National Health Response' delves into the combination of factors that make Argentina a success story in combating HIV/AIDS.

Walking Together, Walking Far

During the same period, nearly 25 million died of AIDS and more than 32 million were newly infected with HIV. In this book for students of political economy and public policy in Africa, as well as global health, Kim Yi Dionne tries to understand why AIDS interventions in Africa often fail. HIV, Resurgent Infections and Population Change in Africa

HIV/AIDS infections are transmitted mainly through behaviour which is private, secret and often hidden. As such, the infection or even the suspicion of infection leads to stigma and discrimination. Discrimination practices have targeted persons that are subsumed under "high-risk" groups (like prostitutes, drug-users and homosexuals). These persons are categorised according to the presumed risk that they are identified with. Such categorisation not only challenges the rights of the individuals but the categorised persons are also victimised under the guise of preventing HIV/AIDS. This undermines efforts to reach these persons and seek their active cooperation in the fights against HIV/AIDS. In order to prevent the spread of this disease various welfare organisations and programmes have also been set up by the Government Organisations. But setting up of the project alone will not help, until and unless we all participate in fighting against the cause of prevention of HIV/AIDS. If we want to set up a HIV/AIDS free society, every one of us should join hands and make a little effort to remove the roots of this dreadful disease from the threshold of our society. The study is confined to the role of government organisations of the high prevalence states- Karnataka and Manipur. Finding funds to fight HIV/AIDS is a serious problem in both the states because the potential costs are staggering. On one hand, diverting funds from other problems to HIV/AIDS control may distort health priorities, while on the other hand, if proper funds are not made available, the economic consequences may be more devastating. The efforts made so far in dealing with the HIV infection/AIDS epidemic cannot be described as totally inadequate and certain issues can be faced socially by creating the required social environment and providing certain social services.

Doomed Interventions

This edited volume analyzes African state responses to the AIDS epidemic. Institutionally weak, limited in resources and lacking power in the international system, the African state has been characterized as inefficient, corrupt and illegitimate. The volume questions how aspects of the African state have affected policy responses to AIDS. It highlights how African states must initiate, develop and/or implement the long-term policy solutions necessary to combat AIDS. It employs empirical studies from the international and national arena to illustrate why some African states have been able (and willing) to address AIDS while others have not. Contributions analyze how international actors, civil society organizations, state ideology, patriarchy and state capacity have influenced policies to fight AIDS. Examining AIDS policies through the prism of African state development and linkages to domestic and international actors, this book provides a nuanced understanding of the variety of responses to AIDS in Africa.

I was encouraged to get involved when I read about Dr. Hlengwa Smangalisio in the community of Hlabisa, South Africa, who stood up and did all he could to help the people in his community. He, along with others, fought for the government to recognize the cause of the disease, allowing antiretroviral medications to be approved for those who were HIV-positive and educating the population about HIV/AIDS. I encourage you to join The Caravan of Love; whatever you can do to fight against the spread of this disease, join in.

The Political Economy of HIV/AIDS in Developing Countries

As global health institutions and aid donors expanded HIV treatment throughout Africa, they rapidly "scaled up" programs, projects, and organizations meant to address HIV and AIDS. Yet these efforts did not simply have biological effects: in addition to extending lives and preventing further infections, treatment scale-up initiated remarkable political and social shifts. In Lesotho, which has the world's second highest HIV prevalence, HIV treatment has had unintentional but pervasive political costs, distancing citizens from the government, fostering distrust of health programs, and disrupting the social contract. Based on ethnographic observation between 2008 and 2014, this book chillingly anticipates the political violence and instability that swept through Lesotho in 2014. This book is a recipient of the

Amnesty International and the Fight Against HIV/AIDS

Research Paper from the year 2012 in the subject Communications - Journalism, Journalism Professions, language: English, abstract: This study is a contribution to development in the field of journalism in Malawi and neighbouring countries of Malawi, Zambia and Tanzania, at a time of growing concern about the developmental challenges being posed by the spread of the HIV/AIDS pandemic in Southern Africa. For Malawi in particular, it examines the struggle against the pandemic that has been underway since 1993 and how the interventions to check its spread have included calls for projects and information that would lead to behaviour change and lowering of infection rates. The campaign along this line has targeted the media, among key stakeholders. To gauge the extent to which journalists are playing their role in the campaign in question, a survey was carried out in Malawi and then also in Zambia and Tanzania. This revealed that journalists in all the three countries covered are currently somewhat hampered in their advocacy of HIV/AIDS issues, and that is due to several factors. These include the dearth of communication research in the region, as well as the related lack of relevant education and training opportunities for journalists. They also encompass the absence of laws granting journalists access to relevant government information about epidemiology; the culture of silence which surrounds the exchange of news about HIV/AIDS related deaths and competition in the media posed by popularity of stories about politics, economics and religion. As a way forward, it is proposed and recommended that journalists should be linked to projects that directly address the needs of local communities in the national campaign against HIV/AIDS. These would be projects like those which incorporated the citizen participation tradition, by empowering even the least respected members of the society. For the media, these include community radio stations, and vernacular newspapers. For
