The 2019 World Development Report presents an analysis of these issues based upon the available evidence.

The 16 papers in this special issue of ToPNoC cover topics ranging from the formal (mostly Petri-net based) foundations of PAISs to more applied topics such as flexibility and process mining. Thus, this volume gives a good overview of the state of the art in PAIS research.
