Combat Interviews of the 38th Armored Infantry Battalion, 7th Armored Division

A comprehensive, photo-filled account of the six-week-long Battle of the Bulge, when panzers slipped through the forest and took the Allies by surprise. In December 1944, just as World War II appeared to be winding down. Hitler shocked the world with a powerful German counteroffensive that cracked the center of the American front. The attack came through the Ardennes, the hilly and forested area in eastern Belgium and Luxembourg that the Allies had considered a "quiet" sector. Instead, for the second time in the war, the Germans used it as a stealthy avenue of approach for their panzers. Much of US First Army was overrun, and thousands of prisoners were taken as the Germans forged a fifty-mile "bulge" into the Allied front. But in one small town, Bastogne, American paratroopers, together with remnants of tank units, offered dogged resistance. Meanwhile, the rest of Eisenhower's "broad front" strategy came to a halt as Patton, from the south, and Hodges, from the north, converged on the enemy incursion. Yet it would take an epic, six-week-long winter battle, the bloodiest in the history of the US Army, before the Germans were finally pushed back. Christer Bergström has interviewed veterans, gone through huge amounts of archive material, and performed on-the-spot research in the area. The result is a large amount of previously unpublished material and new findings, including reevaluations of tank and personnel casualties and the most accurate picture yet of what really transpired from the perspectives of both sides. With nearly four hundred photos, numerous maps, and thirty-two superb color profiles of combat vehicles and aircraft, it provides perhaps the most comprehensive look at the battle yet published.

The 106th Cavalry's Story

When the German Ardennes Offensive of December 1944 ruptured the front of the U.S. First Army, Major General Troy Middleton committed his VIII Corps to the defense of selected transportation bottlenecks in the path of the German advance. St. Vith, located in the central sector of the Ardennes battleground, was one of these. Although by passed by German spearheads bound for the Meuse River, the 7th Armored Division (plus major elements of three other divisions) held the position against major elements of two German Panzer armies. After six days of tenacious defense while practically encircled, the St. Vith force was ordered to withdraw. The defenders of St. Vith prevented the Germans from effectively supplying their armored spearheads, drew off their follow-on forces, and bought time for the U.S. First Army to consolidate its position on the north flank of the German penetration.

Armored Infantry Battalion

The U.S. Cavalry, which began in the nineteenth century as little more than a mounted reconnaissance and harrying force, underwent intense growing pains with the rapid technological developments of the twentieth century. From its tentative beginnings during World War I, the eventual conversion of the traditional horse cavalry to a mechanized branch is arguably one of the greatest military transformations in history. Through Mobility We Conquer recounts the evolution and development of the U.S. Army's modern mechanized cavalry and the doctrine necessary to use it effectively. The book also explores the debates over how best to use cavalry and how these discussions evolved during the first half of the century. During World War I, the first cavalry theorist proposed combining arms coordination with a mechanized force as an answer to the stalemate on the Western Front. Hofmann brings the story through the next fifty years, when a new breed of cavalrymen became cold war warriors as the U.S. Constabulary was established as an occupation security-police force. Having reviewed thousands of official records and manuals, military journals, personal papers, memoirs, and oral histories—many of which were only recently declassified—George F. Hofmann now presents a detailed study of the doctrine, equipment, structure, organization, tactics, and strategy of U.S. mechanized cavalry during the changing international dynamics of the first half of the twentieth century. Most accounts of the Battle of the Bulge give short-shrift to the interval during which the German forward progress stopped and the American counterattack began. This narrative centers on the 7th Armored Division for the entire length of the campaign, in so doing reconsidering the story of the whole battle through the lens of a single division and accounting for the reconstitution of the Division while in combat.

Christer Bergstršm har intervjuat krigsveteraner, gŒtt igenom stora mŠngder akrivmaterial samt rest och forskat i omrŒdet. Resultatet Šr en stor mŠngd tidigare opublicerat material och nya ršn som presenteras i denna genomgripande skildring av det dramatiska Ardennerslaget vintern 1944/1945. Armor

By 1943, the war was lost, and most German officers knew it. Three quarters of a century later, the question persists: What kept the German army going in an increasingly hopeless situation? Where some historians have found explanations in the power of Hitler or the role of ideology, Robert M. Citino, the world's leading scholar on the subject, posits a more straightforward solution: Bewegungskrieg, the way of war cultivated by the Germans over the course of history.
