Parents are unable or unwilling to make daily decisions for their children.

Parents have voluntarily left the child in the care of another adult

Information about the parent's whereabouts.

Notify parents the place and time of guardianship hearing.

Parent or legal guardian dies.

Parent or legal guardian consents.

Parent is willing or able to resume care for the children.

Must provide notice to parents of hearing.
