### Housing for Older People in Singapore: An Annotated Bibliography

In the early-1980s, the ten million people of retirement age in the UK figured prominently among the disadvantaged and deprived. They were heavily over-represented in sub-standard housing and among those in most need of support from the personal social services. One form of social provision which gained rapidly in popularity in the 1960s and 1970s was sheltered housing. It was seen to combine housing with care; provided support while fostering independence; and gave scope for flexibility and experimentation in adapting schemes to local circumstances. By the late 1970s hundreds of schemes were administered, and they were occupied by half a million elderly tenants. Sheltered housing was called 'the greatest breakthrough in the housing scene since the war'. Extravagant expectations were aroused, and sheltered housing was regarded by some as the solution to all manner of complex problems. Taking the country as a whole, however, relatively little was known about the numbers of schemes and where they were located; who owned them and how they were managed; the aims and assumptions of those who provided or advocated sheltered housing; how the schemes functioned and whether they achieved what they were set up to do; the role, experience and attitudes of wardens; what kinds of people lived in sheltered housing, their history, and how they became tenants; their assessment of the scheme; and much else. The Leeds study, on which this book is based, originally published in 1983, was the most comprehensive and detailed to have been conducted into sheltered housing. It evoked widespread interest in Britain and abroad at the time. It sought to answer some of the important questions about the growth and proliferation of sheltered housing, to evaluate sheltered housing from different points of view – including those of tenants, and to consider the scope for future development. While sheltered housing is the focal topic of the book it should be viewed in the broader context of social policy, administration, professional practice and client experience. The book describes in detail an innovatory and evolving form of social provision and, in doing so, illuminates the operation and impact of policy in action at several levels – from the policy-maker to the consumer, from the organisation of policy to its object. There was significant evidence from the study that many tenants were provided with a service which was not the one they sought, or even needed, but they were given what the agency happened to have – or made – available. Among other topics, the book examines sheltered housing as a response to, or reflection of, myths and prejudices about ageing. It discusses whether elderly people should be compelled to move from familiar surroundings late in life – and how they cope when they do move. The usefulness or otherwise of alarm systems is assessed – with conclusions that throw considerable doubt on their value or reliability. The evolution and modifications taking place in sheltered housing are reported on and the scope for future initiatives is discussed.

The authors of this groundbreaking textbook demonstrate convincingly how the physical and social characteristics of a neighborhood can shape the health of its residents. Drawing on the expertise of a renowned cast of researchers, this book presents a state-of-the art account of the theories, methods, and empirical evidence linking neighborhood conditions to population health. Represented in the volume are contributions from the world's leading investigators in the field, including social epidemiologists, demographers, medical

### Sheltered Housing for the Elderly

*Environmental Practice in the Human Services* points to the need for the human services to return to their historic mission of environmental change. It moves beyond the more general conceptual emphasis on person-in-environment toward the development of an environmental practice technology based on an intervention model which prescribes specific micro and macro roles and functions. The book's scope includes practice at the direct service, administration, planning, and social policy levels; it integrates micro and macro practice and shows how these two levels of practice are interdependent. This enables human service practitioners to create and/or modify social environments to enhance the functioning of clients being served in human service programs. Topics covered include: important skills in environmental practice, including decisionmaking, negotiating, and leadership community practice and resource coordination social support the impact of organizational environments on practice environmental practice for the chronically disabled Author Neugeboren's approach is unique in its in-depth focus on environmental practice, applying concepts of social environment to specific practice roles. This practice-specific content, which provides tools needed for environmental practice, is in contrast to existing texts on the social environment which are very theoretical and not integrated with practice. He includes material from the field of social ecology which has not been included in existing texts. It shows how practitioners and administrators, planners, and policymakers can facilitate and support each other's work. *A Generation of Change* is an exceptional study of the nation's elderly, a population that has undergone profound changes in the years since World War II. As modern medicine extends the average life span and the baby boom generation begins to approach middle age, the number of older Americans is expected to more than double in the next century. Currently, 75 percent of U.S. health care expenditures go toward the elderly. But as national trends toward early retirement and low birthrate continue, an aging American population could face crises in meeting their financial and physical needs. According to Jacob S. Siegel in *A Generation of Change*, astute public planning must be informed by an understanding of the demographic, social, and economic characteristics of the older population, as it is today and as it will be in the coming years. Siegel employs census and survey data from 1950 through the mid-1980s to describe a population constantly shifting in its ethnic and gender composition, geographic distribution, marital and living arrangements, health, employment, and economic status. Surprisingly, there is tremendous disparity in the quality of life among the elderly. Although their average poverty rate is below that of the general population, there are dramatic levels of poverty among older women, who are far more likely than men to live alone or in institutions. As the elderly progress from the

"young old" to the "aged old"—those over 85—sharp differences emerge as income and employment decrease and degrees of chronic illness increase. In addition, residential location influences the quality of health care and public assistance available to the elderly, an effect that may account for the marked migration of older people to Florida and Arizona. Siegel analyzes the full range of characteristics for this heterogeneous population and, through comparisons with other age groups as well as with the elderly of the previous decades, portrays the crucial influence of social and economic conditions over the life course on the quality of later life. With our elderly population growing more numerous and long lived, accurate information about them is increasingly essential. A Generation of Change will serve as a valuable resource for policymakers seeking more effective solutions in critical areas such as housing, long-term health care, and the funding of Social Security and retirement programs. #### Geographies of Ageing

American society is facing some very tough decisions concerning housing for the elderly--decisions that will be both financially and socially costly to all Americans if they are delayed too long. Given the current trends and present programs, the demand for elderly housing is going to far outstrip the supply within the next 15 years. There simply will not be enough roofs to cover appropriately the heads of the elderly. The solutions to the elderly housing crunch are complex and tangled in the political maze of American social and economic policies. Housing demand--the numbers alone--is a significant problem. However, the situation becomes more complex when the demand is coupled with concerns about housing availability, appropriateness, and affordability. This book examines the problem of housing the elderly, first looking at the demand for housing and then examining the housing supply or alternatives available to the elderly. The abilities of the elderly to help themselves by influencing public policy and obtaining the housing and assistance they need are discussed next, followed by an analysis of the current programs and the emerging trends and proposals. Finally, the elderly housing situation is summarized, and pending congressional legislation is examined in an effort to sort out some recent thinking on this problem. Three common threads run through the articles: The elderly should be encouraged to live independently for as long as possible; they must have a wide range of housing options; and, there must be closer coordination between elderly housing and the services the elderly need.

#### Family and Aging Policy

In an ageing society, where people over 65 will outnumber those aged under 16 by 2014, one of the main challenges for policy makers is to provide a range of housing options that recognise the increasing need for support as the population becomes older, without simply about providing housing settings in which older people can be cared for. This book presents a comprehensive overview of the most recent evidence related to new and emerging models of housing with care for later life. It examines and contrasts existing knowledge about a range of different models of housing and care for later life, including fixed-site housing in which older people live communally. It also looks at work about innovative schemes providing more flexible services than traditional sheltered housing schemes, including the UK's first Continuing Care Retirement Community, developed by the Joseph Rowntree Housing Trust, and the recent developments of 'extra care' housing schemes that cater for 'fit and frail' older people. Housing with care for later life draws out key messages for services providers and commissioners on how best to meet the housing and care needs of older people in an ageing society.

## Business, Politics, and Society

How much power does business exercise in Britain and the United States? Are giant firms that operate on a global scale beyond the control of elected governments? Are political parties in the pocket of business interests? All these questions go to the heart of the viability of a modern democracy, and have been given increased urgency since the end of 2007 and the economic crisis that has reverberated around the world. *Business, Politics, and Society* compares business and politics in two of the most important capitalist democracies: the United States and the United Kingdom.
