However, Article 7 does make an exception for CRIMES AGAINST HUMANITY.

CRIMINAL LAWS can't be too broad. (Kokkinakis case, 1993)

A crime must be CLEARLY DEFINED in law. (SW case, 1996)

A person can be tried for WAR CRIMES committed in the past. (Kononov case, 2011)
