Put simply it means that everyone, including the government, is bound by the law. Nobody is above it.

It means laws can't be made in secret, without us knowing.

And it means that new laws should not criminalise things that have already happened.

It's the role of judges to apply the law

For example, the police are not allowed to stop and search you without having reasonable grounds and if they do you should be able to hold them to account under the rule of law.

Ultimately, when used properly, the rule of law can be a powerful tool to protect us against injustice. It should ensure we are not treated unfairly or deprived of our rights for no reason
