Dhammapada

Meditation is an essential part of the Buddhist way of life and Buddhist meditation practices cannot be explained apart from the fundamental doctrines of Buddhism. Buddhaghosa, the author of the Visuddhimagga (The Path of Purification), gave elaborate expositions of these fundamental doctrines. As such his work has served not only as a manual of meditation but also as the standard work on Theravada Buddhism as a whole. No other school of Buddhism has handed down to us a work of such importance. Therefore the Visuddhimagga occupies a unique position in the field of Buddhism in particular and the religious literature of the world in general. What is to the advantage of the scholar is sometimes to the disadvantage of the layman. While going through the elaborate explanations of a certain topic in the Visuddhimagga, one is liable to lose its thread and become confused. This book gives a clear outline of the system and its essential points so that the details can be understood without much difficulty.

The Bhagavad Gita

The Secret Sayings of Ye Su: A Silk Road Gospel provides a translation of, introduction to, and commentary upon an extraordinary, previously unknown manuscript. This Christian gospel, though written in koine Greek, was obviously influenced by both Buddhist and Daoist ideas and probably derives from Tang dynasty China (8th or 9th century). The account of how the manuscript emerged in 1994 and how it came to be translated by Dr. Jay G. Williams is, in itself, quite fascinating. The author also describes the nature of the text and why he thinks it should be placed in the Tang dynasty period. He provides a concise introduction not only to the history of Buddhism and the indigenous religions of China during this period but also to the "Religion of Light," a form of Christianity that entered China in 638 A. D. The work ends with a line-by-line commentary on each of the seventy-two verses of this gospel. Although undoubtedly ancient, the work seems amazingly contemporary in its ideas, offering a unique and quite radical vision of Ye Su (Jesus) and his teachings. Neither orthodox nor gnostic, The Secret Sayings comments about such topics as the place of women and gays within the community, the nature of the kingdom, and the source of Christian hope in the "Source." Although faith is emphasized,

doctrines and dogmas are not. A place is found for both the Heavenly Father and the Earthly Mother but alone neither is regarded as "ultimate." The fellowship of believers is emphasized, but value of the Church as an institution is seriously questioned.

Our intention is that these slides, or pages, will inspire meditators and nonmeditators alike. They are written from the

authentic experience of the troubling human condition, and they speak from the standpoint of suffering and the Path out of suffering. They are insights that have crossed the bridge of time from ancient India to today. We hope you will find wisdom flowing through time on the river of words that originates in the ancient spring of the Pali Canon. —Paul R. and Susan K. Fleischman
