Domesticity is generally treated as an aspect of women's history. In this fascinating study of the nineteenth-century middle class, John Tosh shows how profoundly men's lives were conditioned by the Victorian ideal and how they negotiated its many contradictions. Tosh begins by looking at the

experience of boyhood, married life, sex, and fatherhood in the early decades of the nineteenth century—illustrated by case studies representing a variety of backgrounds—and then contrasts this with the lives of the late Victorian generation. He finds that the first group of men placed a new value on the home as a reaction to the disorienting experience of urbanization and as a response to the teachings of Evangelical Christianity. Domesticity still proved problematic in practice, however, because most men were likely to be absent from home for most of the day, and the role of father began to acquire its modern indeterminacy. By the 1870s, men were becoming less enchanted with the pleasures of home. Once the rights of wives were extended by law and society, marriage seemed less attractive, and the bachelor world of clubland flourished as never before. The Victorians declared that to be fully human and fully masculine, men must be active participants in domestic life. In exposing the contradictions in this ideal, they defined the climate for gender politics in the next century. /DIV

In reference to the former, it may be affirmed, that piety, while it would raise their enjoyment to a sublimer kind, and a higher degree of happiness in this world, would also perpetuate it through eternity. While in reference to the latter, it may be remarked, that their disquietude is not produced by religion, but occasioned by the lack of it. A mere profession of the Christian faith, is rather a hindrance to felicity than a help-nothing short of real religion can be expected to yield its joys. A Help to Domestic Happiness

This study is the first treatment devoted to Sir Arthur Helps (1813–1875), who was a prominent figure in the mid-Victorian world. Readers will discover that from the 1840s until his death, Helps was influential

and well-known to many key figures: Carlyle, Ruskin, Froude and the Queen were among those whom he befriended. In fact, it was almost certainly these relationships which Helps sought to protect by directing that the bulk of his private papers and correspondence be destroyed upon his death. Making use of extensive primary and secondary sources, this book begins the process of recovering this once eminent Victorian. Helps did become a forgotten figure, but, nevertheless, during the course of his career he made notable impacts upon many areas of British life. At once a social activist and literary figure, Helps labored to promote social reform while also lifting his pen to educate his readers about the complexity of both societal problems and the difficulties inherent in adequately addressing them. He looked well beyond Britain as well: it would be Helps who authored a four volume history of the Spanish conquest of the New World, while developing unrivaled expertise on the history and practice of slavery in the Americas. As Clerk of the Privy Council, Helps played a decisive role in addressing the problems caused by the 'Cattle Plague' which shocked Britain in the middle of the 1860s. Most important, perhaps, it would be as Clerk that Helps served Queen Victoria not only as an informal confidant, but by making decisions which refashioned the monarchy's public image. The book, then, reintroduces Helps by documenting and assessing his contributions to Victorian Britain.

First published in 1981, this book brings together different types of work by numerous fragmented groups in the field of Marxist history and puts them in dialogue with each other. It takes stock of then recent work, explores the main new lines, and looks at the political and ideological circumstances shaping the direction of historical work, past and present. The scope of the book is international with contributions on African history, fascism and anti-fascism, French labour history, and the transition from feudalism to capitalism. It also incorporates feminist history and gives attention to some of the leading questions raised for social history by the women's movement.

Hundreds of provocative notices such as this one ran in New England newspapers between 1790 and 1830. These elopement notices--advertisements paid for by husbands and occasionally wives to announce their spouses' desertions as well as the personal details of their marital conflicts--testify to the difficulties that many couples experienced, and raise questions about the nature of the marital relationship in early national New England. *Stray Wives* examines marriage, family, gender, and the law through the lens of these elopement notices. In conjunction with legal treatises, court records, and prescriptive literature, Mary Beth Sievens highlights the often tenuous relationships among marriage law, marital ideals, and lived experience in the early Republic, an era of exceptional cultural and economic change. Elopement notices allowed couples to negotiate the meaning of these changes, through contests over issues such as gender roles, consumption, economic support, and property ownership. Sievens reveals the ambiguous, often contested nature of marital law, showing that husbands' superior status and wives' dependence were fluid and negotiable, subject to the differing interpretations of legal commentators, community members, and spouses themselves.
