National, Post-National and European Identities in Germany

More and more non-state actors are entering the international arena and are influencing political outcomes in ways that were unthinkable a few years ago. Consequently the state has to cope with a rapid dissolution of its powers. The rules of state sovereignty, which went basically unchallenged from the 17th until the 20th century, are now put under great pressure. Traditional concepts of statehood and state sovereignty - that is, the final right of decision - are called into question. Telecommunication and media have long crossed borders, financial markets are globalized, and non-governmental organizations are influencing political agendas. Later, when the former Yugoslavia started to fall apart, this antinationalist discourse gained vehemence. Already in 1955 Erich Fromm said with regards to nationalism: This incestuous fixation not only poisons the relationship of the individual to the stranger, but to the members of his own clan and to himself. The person who has not freed himself from the ties to blood and soil is not yet fully born as a human being... Nationalism is our form of incest [and] insanity...

Peace and democracy did score some successes, however, particularly in Europe: the centre-left's victory in Croatia, sweeping former President Tudjman's party off the scene, the democratic party's triumph in Bosnia, and the fall of the Milosevic regime in Serbia.

Deterrence in American Foreign Policy: Theory and Practice

Thus, the United States became involved militarily in various Third World conflicts more to deter the Soviet Union than to protect any specific U.S. interest. Peripheral Visions argues that this policy was unnecessary and counterproductive.

Peripheral Visions

To say that the world changed drastically on 9/11 has become a truism and even a cliché. But the incontestable fact is that a new era for both the world and US foreign policy began on that infamous day and the ramifications for international politics have been monumental. Jervis brings his acute analysis of international politics to bear on several recent developments that have transformed international politics and American foreign policy including the War on Terrorism; the Bush Doctrine and its policies of preventive war and unilateral action; and the promotion of democracy in the Middle East (including the Iraq War) and around the world. Taken together, Jervis argues, these policies constitute a blueprint for American hegemony, if not American empire. All of these events and policies have taken place against a backdrop equally important, but less frequently discussed: the fact that most developed nations, states that have been bitter rivals, now constitute a "security community" within which war is unthinkable. Deterrence in American Foreign Policy

As the world's only superpower, America's foreign policy inevitably has a major impact Ð be it positive or negative - on contemporary international affairs. Since the terrorist attacks of 9/11, George W. Bush's decision to move away from multilateral decision-making toward a more aggressive, pre-emptive style of foreign policy attracted widespread debate, and criticism, throughout the world. Reversing direction, the Barack Obama presidency is placing greater emphasis on constructive or peaceful engagement within multilateral frameworks, relying on special envoys to deal with some of the thorniest problems. In this book, Paul Viotti explores American foreign policy from the founding of the republic in the late 18th Century to the present day. Part 1 examines the broad policy options available to the US government: namely, peaceful engagement, containment through deterrence or coercive diplomacy, and armed intervention. Part 2 looks at the American experience in foreign policy. By exploring early precedents and elite practices, the moralism of American exceptionalism as well as the roots of an expansionist American foreign policy, the discussion draws out the continuities running from the 18th century to the present. Part 3 concludes with an analysis of the politics of interest on the Potomac with analysis of the interplay of contending policy elites, factions and parties influencing foreign policy making today. Assessing alternatives, the author concludes that even though containment and armed intervention will remain part of the way the United States conducts its foreign policy, diplomatic engagement options are the most promising course of action for the coming decades.

The Necessity for Choice

Deterrence as a strategic concept evolved during the Cold War. During that period, deterrence strategy was aimed mainly at preventing aggression against the United States and its close allies by the hostile Communist power centers—the Union of Soviet Socialist Republics (USSR) and its allies, Communist China and North Korea. In particular, the strategy was devised to prevent aggression involving nuclear attack by the USSR or China. Since the end of the Cold War, the risk of war among the major powers has subsided to the lowest point in modern history. Still, the changing nature of the threats to American and allied security interests has stimulated a considerable broadening of the deterrence concept. *Post-Cold War Conflict Deterrence* examines the meaning of deterrence in this new environment and identifies key elements of a post-Cold War deterrence strategy and the critical issues in devising such a strategy. It further examines the significance of these findings for the U.S. Navy and Marine Corps. Quantitative and qualitative measures to support judgments about the potential success or failure of deterrence are identified. Such measures will bear on the suitability of the naval forces to meet the deterrence objectives. The capabilities of U.S. naval forces that especially bear on the deterrence objectives also are examined. Finally, the book examines the utility of models, games, and simulations as decision aids in improving the naval forces' understanding of situations in which deterrence must be used and in improving the potential success of deterrence actions.

The Stupidity of War

For decades, the rational actor model served as the preferred guide for U.S. deterrence policy. It has been a convenient and comforting guide because it requires little detailed knowledge of an opponent's unique decision-making process and yet typically provides confident generalizations about how deterrence works. The model tends to postulate common decision-making parameters across the globe to reach generalizations about how deterrence will function and the types of forces that will be "stabilizing" or "destabilizing." Yet a broad spectrum of unique factors can influence an opponent's

perceptions and his calculations, and these are not easily captured by the rational actor model. The absence of uniformity means there can be very few deterrence generalizations generated by the use of the rational actor model that are applicable to the entire range of opponents. Understanding Deterrence considers how factors such as psychology, history, religion, ideology, geography, political structure, culture, proliferation and geopolitics can shape a leadership's decision-making process, in ways that are specific and unique to each opponent. Understanding Deterrence demonstrates how using a multidisciplinary approach to deterrence analysis can better identify and assess factors that influence an opponent's decision-making process. This identification and assessment process can facilitate the tailoring of deterrence strategies to specific purposes and result in a higher likelihood of success than strategies guided by the generalizations about opponent decision-making typically contained in the rational actor model. This book was published as a special issue of Comparative Strategy.

Conspiracy Theory and American Foreign Policy

Zachary C. Shirkey argues that the United States is overly reliant on the active use of force and should employ more peaceful foreign policy tools. Force often fails to achieve its desired ends for both tactical and strategic reasons and is relatively inflexible, making it an inappropriate tool for many US foreign policy goals. Rather than relying on loose analogies or common sense as many books on US grand strategy do, American Dove bases its argument directly on an eclectic mix of academic literature, including realist, liberal, and constructivist theory as well as psychology. Shirkey also argues against retrenchment strategies, such as offshore balancing and strategic restraint as lacking a moral component that leaves them vulnerable to hawkish policies that employ moral arguments in favor of action. US withdrawal would weaken the existing liberal international security, economic, and legal orders—orders that benefit the United States. Rather, the book argues the United States needs an energetic foreign policy that employs passive uses of force such as deterrence and nonmilitary tools such as economic statecraft, international institutions, international law, and soft power. Such a policy leaves room for a moral component, which is necessary for mobilizing the American public and would uphold the existing international order. Last, Shirkey argues that to be successful, doves must frame their arguments in terms of strategy rather than in terms of costs and must show that dovish policies are consistent with national honor and a broad range of American values. American Dove offers a framework for US grand strategy and a plan for persuading the public to adopt it.

Pivotal Deterrence

In *The Military Lens*, Christopher P. Twomey shows how differing military doctrines have led to misperceptions between the United States and China over foreign policy—and the potential dangers these might pose in future relations. Because of their different strategic situations, histories, and military cultures, nations may have radically disparate definitions of effective military doctrine, strategy, and capabilities. Twomey argues that when such doctrines—or "theories of victory"—differ across states, misperceptions about a rival's capabilities and intentions and false optimism about one's own are more likely to occur. In turn, these can impede international diplomacy and statecraft by making it more difficult to communicate and agree on assessments of the balance of power. When states engage in strategic coercion—either to deter or to compel action—such problems can lead to escalation and war. Twomey assesses a wide array of sources in both the United States and China on military doctrine, strategic culture, misperception, and deterrence theory to build case studies of attempts at strategic coercion during Sino-American conflicts in Korea and the Taiwan Strait in the early years of the Cold War, as well as an examination of similar issues in the Arab-Israeli conflict. After demonstrating how these factors have contributed to past conflicts, Twomey amply documents the persistence of hazardous miscommunication in contemporary Sino-American relations. His unique analytic perspective on military capability suggests that policymakers need to carefully consider the military doctrine of the nations they are trying to influence.

American Foreign Policy Since World War II

Military Strategy: A Very Short Introduction adapts Clausewitz's framework to highlight the dynamic relationship between the main elements of strategy: purpose, method, and means. Drawing on historical examples, Antulio J. Echevarria discusses the major types of military strategy and how emerging technologies are affecting them. The American Threat

As a concept, deterrence has launched a thousand books and articles. It has dominated Western strategic thinking for more than four decades. In this important and groundbreaking new book, Lawrence Freedman develops a distinctive approach to the evaluation of deterrence as both a state of mind and a strategic option. This approach is applied to post-cold war crisis management, and the utility and relevance of the concept is addressed in relation to US strategic practice post-9/11, particularly in the light of the apparent preference of the Bush Administration for the alternative concept of pre-emption. The study of deterrence has been hampered by the weight of the intellectual baggage accumulated since the end of the Second World War. Exaggerated notions of what deterrence might

achieve were developed, only to be knocked down by academic critique. In this book, Freedman charts the evolution of the contemporary concept of deterrence, and discusses whether - and how - it still has relevance in today's world. He considers constructivist as well as realist approaches and draws on criminological as well as strategic studies literature to develop a concept of a norms-based, as opposed to an interest-based, deterrence. This book will be essential reading for students of politics and international relations as well as all those interested in contemporary strategic thought.

US Foreign Policy since 1945

China's recent reforms have led to unprecedented economic growth; if this continues, China will be able to turn its great potential power into actual power. The result could be, in the very long term, the rise of China as a rival to the United States as the world's predominant power; in the nearer term, China could become a significant rival in the East Asian region. In this context, the issue for U.S. policy is how to handle a rising power, a problem that predominant powers have faced many times throughout history. It is the contention of this report that the future Sino-U.S. context will illustrate many of the problems of deterrence theory that have been discussed in recent decades; deterrence theory will be, in general, more difficult to apply than it was in the U.S.-Soviet Cold War context. The key may be to seek nonmilitary means of deterrence, i.e., diplomatic ways to manipulate the tension to China's disadvantage.

Second Anglo-American Symposium on Deterrence and European Security

Deterrence is the most basic concept in American foreign policy today. But past practice indicates it often fails to work - and may increase the risk of war. *Psychology and Deterrence* reveals this strategy's hidden and generally simplistic assumptions about the nature of power and aggression, threat and response, and calculation and behavior in the international arena. Most current analysis, the authors note, ignore decisionmakers' emotions, perceptions, and domestic political needs, assuming instead that people respond to crisis in highly rational ways. Examining the historical evidence from a psychological perspective, *Psychology and Deterrence* offers case studies on the origins of World War I, the 1973 Arab-Israeli conflict, and the Falklands Wars as seen by the most important participants. These case studies reveal national leaders to be both more cautious and more reckless than theory would predict. They also show how deterrence strategies often backfire by aggravating a nation's sense of insecurity, thereby calling forth the very behavior they seek to prevent. The authors' conclusions offer important insights for superpower bargaining and nuclear deterrence.

Bridging the Gap

In this 1994 book Bradley Klein draws upon debates in international relations theory to raise important questions about the nature of strategic studies. He argues that post-modern critiques of realism and neorealism open up opportunities for new ways of thinking about nuclear deterrence. In clear and uncluttered language, he explores the links between modernity, state-building and strategic violence, and argues that American foreign policy, and NATO, undertook a set of dynamic political practices intended to make and remake world order in the image of Western identity. Klein warns against too facile a celebration of the end of the Cold War, concluding that it is even more imperative today to appreciate the scope and power of the Western strategic project. The book will be of interest to students of international relations theory, strategic studies, peace studies, and US foreign policy.

Complex Deterrence

In 2020, America will elect a president, deciding not just the trajectory of its national politics but the future of American foreign policy. Will the Alt-Right, nationalist, and mercantilist approaches to international trade that characterized Donald Trump's rise to power maintain its hold? Deterrence

This volume, a comprehensive review of forty years of public opinion data, shows Americans do not support initiating use of nuclear weapons to defend allies in Western Europe, but they strongly support NATO, internationalist policies, and the defense of Western Europe. Since the advent of standardized public opinion polling in the mid-1930s, a large academic literature has been produced on public

attitudes and American foreign policy. Three theoretical ideas have taken hold in universities, and hold sway, at least indirectly, with a number of foreign policy experts. First, some scholars posit that America's attitudes towards foreign policy are unstable. A second relevant concept suggests that many Americans have little interest or knowledge about foreign policy, and so their attitudes are strongly influenced by a small elite. Finally, many public opinion analysts argue that there was a 'consensus' in public attitudes during the Cold War. This volume examines the validity of these three theories. Deterrence Theory and Chinese Behavior

This new study challenges the widely held view that many current US adversaries cannot be deterred, maintaining that deterrence is not a relic of the Cold War period and that it should shape US policies toward so-called 'rogue states' and terror groups. James Lebovic argues that deterrence principles continue to apply, and focuses upon the 'three pillars' of the Bush administration's national security policy: missile defence, which preoccupied the administration until September 11, 2001 pre-emption, which became the US focus with the September 11 attacks and US success in overthrowing the Taliban regime in Afghanistan homeland security, which the administration has portrayed as more a natural response to threat than an aspect of policy that must be reconciled with the other pillars. *Deterring International Terrorism and Rogue States* asserts that bad offences and defences have been endemic to the current US policy approach, leading US policy makers to pursue policies that require them to do everything without adequate concern for resource trade-offs, overreach, and unintended consequences. This book will be of great interest to students of US foreign policy, national and international security, terrorism and international relations in general.

Psychology and Deterrence

The year 1953 represented a pivotal moment in the Cold War and set the course of global affairs for the next sixty-five years. The cessation of hostilities in the Korean War resulted in the creation of two opposing countries separated by a contentious demilitarized zone. This book presents how Great Britain's Ambassador to the US, Sir Roger Makins, provided the British Foreign Office with weekly summaries of American political and diplomatic affairs throughout 1953. Examining the events of this critical year through the eyes of this British diplomat provides a fresh perspective on the Cold War.

Strategic Studies and World Order

The United States confronts a host of foreign policy problems in the 21st century, yet the Republic's security strategy is increasingly muddled and counterproductive. Disagreements over Iraq policy as well as other matters have soured Washington's relations with its long-time European allies. It remains to be seen whether Washington's strategy of using multilateral negotiations involving North Korea's neighbors to induce Pyongyang to end its quest for nuclear weapons will succeed. The more hardline strategy of imposing economic sanctions and considering the use of military force is clearly not working with regard to Iran's nuclear ambitions. Other problems, such as the Taiwan issue, are just clouds on the horizon at present, but they have the potential to cause serious trouble in the coming years. The Taiwan problem highlights the danger inherent in Washington's habit of making ill-advised security commitments to small, vulnerable client states that are not crucial to America's own security and well being. In the case of Taiwan, such an obligation could lead to armed confrontation between the United States and China. Ted Galen Carpenter examines these and other foreign policy challenges that America confronts in the 21st century and diagnoses what is wrong with Washington's current approach. Throughout these essays, he outlines an alternative strategy that would protect America's security while avoiding unnecessary and unrewarding military adventures.
