Assessments cover broad subject areas and monitor the overall education system, and examinations certify individuals' mastery of specific high school courses. The provinces have not found it necessary to attach high stakes to all tests. Examination results are used in conjunction with teacher-assigned grades, and assessments have no consequences for individual students. Safeguards have been developed for each type of test; and provincial school funding formulas, which are independent of the testing process, tend to level resources among schools within a province. Most Canadian educators and the public support the testing programs, but they have no hard evidence that the programs lead directly to improved instruction. Appendixes list characteristics of the provincial programs, participants in site and telephone interviews, and major contributors to the report. The study presents findings in the areas of prevention and screening, cancer, chronic illness, hospital-based care, and general health status. The committee looked at the consequences of being uninsured for people suffering from cancer, diabetes, HIV infection and AIDS, heart and kidney disease, mental illness, traumatic injuries, and heart attacks. It focused on the roughly 30 million-one in seven-working-age Americans without health insurance. This group does not include the population over 65 that is covered by Medicare or the nearly 10 million children who are uninsured in this country. The main findings of the report are that working-age Americans without health insurance are more likely to receive too little medical care and receive it too late; be sicker and die sooner; and receive poorer care when they are in the hospital, even for acute situations like a motor vehicle crash.
