Las fuentes del derecho

There is no one definition of case law, but rather a plurality of meanings. In this respect, after an analysis of Roman iurisprudentia and Anglo-Saxon case law, this work considers the Spanish legal system, as an example of a Continental jurisdiction.

Case Law in Roman, Anglosaxon and Continental Law

La jurisprudencia ha sido un tema ampliamente estudiado. Se plantean una serie de interrogantes. El primero de ellos es dar un concepto de la misma, puesto que de la jurisprudencia no se puede hablar en un solo sentido. No existe una única acepción del término, sino una pluralidad de significados dependiendo de la época histórica y del sistema jurídico de que se trate. Así, no significó lo mismo la jurisprudencia en el antiguo Derecho romano, en el que se concebía como Ciencia del Derecho, que en la actualidad. Tampoco son en absoluto equivalentes las nociones de jurisprudencia en los países anglosajones, en los que el precedente judicial es la principal fuente del Derecho, y en los sistemas de Derecho continental. En éstos resulta fundamental, a modo de segundo interrogante, dar respuesta a la intrincada cuestión de saber si la jurisprudencia es fuente del Derecho. En este sentido, en la presente obra, tras analizar los Derechos romano y anglosajón, se distingue, en lo que se refiere al ordenamiento jurídico español, entre la jurisprudencia del Tribunal Supremo y la del Tribunal Constitucional, sin olvidar el papel jugado en nuestro país por los Tribunales europeos el Tribunal Europeo de Derechos Humanos de Estrasburgo, el Tribunal de Justicia de las Comunidades Europeas de Luxemburgo y la Corte Penal Internacional, así como por los Tribunales Superiores de Justicia de las Comunidades Autónomas. Estas materias, entre otras muchas, son analizadas, de una manera a la vez clara y profunda, en este trabajo, siguiendo un enfoque histórico, de Derecho comparado y de Teoría general del Derecho, de gran interés y valor científico.

Teoría del derecho

La historia del derecho colombiano refleja exactamente la forma cómo las instituciones y los gobernantes se han amoldado a las nuevas realidades de la sociedad. En este sentido, muchos cambios, han sido fruto de reclamaciones violentas, otras pacíficas, por reformas al gobierno, a la administración, a las instituciones jurídicas, políticas y sociales en general, reclamando justicia, igualdad y la protección de los derechos de las personas. Lo cual se puede evidenciar en la Ley 1437 de 2011 en la que el legislador intervino en la materialización del concepto de precedente judicial en la Jurisdicción Contencioso Administrativa, con la creación de las sentencias de unificación y la posibilidad de extender los efectos de las mismas. Lo novedoso de la publicación es que la discusión sobre la alteración de la jerarquía de las fuentes del derecho, se aborda desde una perspectiva teórica,

pero desarrolla puntualmente, mecanismos como las sentencias de unificación y la extensión de jurisprudencia.
