Why Study a Cash Flow Tax? • Policy makers have expressed a clear interest in reforming the U.S. tax system

Why Study a Cash Flow Tax? Origins trace back to the Meade Committee (1978) • "Blueprints for Basic Tax Reform" (1977) . President's Advisory Panel on Federal Tax Reform (2005)

Cash flow tax is a flow of funds tax applied to not receipts accruing to a given business

What is the Border Adjustment? Destination basis: the domestic sale of goods and services less the domestic expenses incurred • Purchases from foreign parties are no longer deductible • Sales to foreign purchasers are no longer taxed

Issues to Focus On 1. How comparable are the tax bases?

Simulating a Cash Flow Tax Goal compare the cash flow tax base to the current income tax base for a historical panel of firms

Microsimulation Details: Border Adjustment • Tax data does not broadly allow for identification of domestic vs foreign income and expenses

Impact of the Border Adjustment Income Tax vs Business Cash Flow

Conclusions . With limited real-world experience, there is little to guide policy makers on design and pressure points of a cash flow tax
