Many academics consider Obama to have been a master foreign policy strategist and shrewd practitioner of the art of realpolitik. The Obama administration's heavy-handed interference in Ukraine led to effective Russian counter-moves, promoting a strategic alliance with China and regional integration that is moving the world towards multi-polarity. Obama's *Unending Wars* provides the first critical, comprehensive and highly documented history of the foreign policy of America's forty-fourth president - the drone king who ordered the bombing of seven Muslim countries, backtracked on a pledge to reduce America's nuclear arsenal, and helped fuel a new Cold War with Russia. During his years in office Obama provided billions of dollars in arms sales to Saudi Arabia as it assisted in the crushing of pro-democracy demonstrators in Bahrain and invaded Yemen. He sanctioned a coup in Honduras which plunged that country into chaos, perpetuated a failed drug war policy and contributed to the recolonization of Africa. While any Democratic Party president would have faced peril in confronting the Pentagon which had carried out a slow coup d'etat over the decades, Obama was rather, in many ways, the most perfect spokesman for the military-industrial complex. Who else but this articulate constitutional law professor could pull off a pro-war speech after winning the Nobel Peace Prize while ramping up drone assassinations and America's network of military bases in Africa and still retain the support of liberal-progressives? As many in the time of Trump now glance nostalgically back to the Obama presidency, this book will help them to see the continuity -- and continuous failure -- of American foreign policy irrespective of the party or figurehead representing it.

Dealing with Bioethical Issues in a Globalized World

This book addresses the complexity of talking about normativity in bioethics within the context of contemporary multicultural and multi-religious society. It offers original contributions by specialists in bioethics exploring new ways of understanding normativity in bioethics. In bioethical publications and debates, the concept of normativity is often used without consideration of the difficulties surrounding it, whereas there are many competing claims for normativity within bioethics. Examples of such competing normative bioethical discourses can be perceived in variations and differences in bioethical arguments within individual religions, and the opposition between bioethical arguments from specific religions and arguments from bioethicists who do not claim religious allegiance. We also cannot merely assume that a Western understanding of normative bioethics will be unproblematic in bioethics in non-Western cultures and religions. Through an analysis of normativity in Christian, Hindu, Buddhist, Islamic, and Jewish bioethics, the book creates awareness of the complexity of normativity in bioethics. The book also covers normative bioethics outside an explicitly religiously committed context, and specific attention is paid to bioethics as an interdisciplinary endeavor. It reveals how normativity relates to empirical and global bioethics, which challenges it faces in bioethics in secular pluralistic society, and how to overcome these. By doing that, this book fills an important gap in bioethics literature.

The Debasing of Human Rights

The idea of human rights began as a call for individual freedom from tyranny, yet today it is exploited to rationalize oppression and promote collectivism. How did this happen? Aaron Rhodes, recognized as "one of the leading human rights activists in the world" by the University of Chicago, reveals how an emancipatory ideal became so debased. Rhodes identifies the fundamental flaw in the Universal Declaration of Human Rights, the basis for many international treaties and institutions. It mixes freedom rights rooted in natural law—authentic human rights—with "economic and social rights," or claims to material support from governments, which are intrinsically political. As a result, the idea of

human rights has lost its essential meaning and moral power. The principles of natural rights, first articulated in antiquity, were compromised in a process of accommodation with the Soviet Union after World War II, and under the influence of progressivism in Western democracies. Geopolitical and ideological forces ripped the concept of human rights from its foundations, opening it up to abuse. Dissidents behind the Iron Curtain saw clearly the difference between freedom rights and state-granted entitlements, but the collapse of the USSR allowed demands for an expanding array of economic and social rights to gain legitimacy without the totalitarian stigma. The international community and civil society groups now see human rights as being defined by legislation, not by transcendent principles. Freedoms are traded off for the promise of economic benefits, and the notion of collective rights is used to justify restrictions on basic liberties. We all have a stake in human rights, and few serious observers would deny that the concept has lost clarity. But no one before has provided such a comprehensive analysis of the problem as Rhodes does here, joining philosophy and history with insights from his own extensive work in the field.

What Happened

Childhood in America has changed, and not for the better. From day care for babies, to the exhausting array of activities for children, to the storm of lurid and violent shows now deemed appropriate for the young, to the expectation that teenagers build resumes, childhood has been thoroughly redefined. Anne R. Pierce argues that this radical re-definition has been embraced with remarkably little discussion about what children, by nature, need. Pierce submits that we have latched onto opinions about child-rearing that are potentially harmful to children. If traditions are choices to be embraced or abandoned at our discretion, and adult self-fulfillment is a primary determinant in those choices, the fundamentals of the well-wrought childhood are easily forgotten. Steeped in intellectual permissiveness, we have convinced ourselves that parental substitutes are as good as parents themselves at caring for children, that the concepts of nurture and of the maternal are archaic and irrelevant, that more lessons and

sports are better than less and that the earlier one embarks upon them the better, and that innocence and knowledge are less important than worldly attitudes and competitive skills. Understanding and challenging the theories and agendas behind childrearing trends is a pressing need, and the subject of this book. Pierce takes an honest look at the evidence on the effects of daycare and of hyper-structuring children. She gives voice to the many intelligent and estimable educators, child-development experts, researchers, and social commentators who are ignored because their conclusions are hard to bear. Equally important, Pierce says, is attention to that inner tug of love and conscience, which many of us have been programmed to ignore. Modern American children are expected to adjust and to understand as adults would the complexities and vicissitudes of public as opposed to private life. For them, childhood is fast becoming a distant memory. Could it be that America's thrust forward leaves children without a solid foundation upon which to grow? This is the sobering question asked, and answered, in this challenging book.

Ships without a Shore

Recurring throughout our history are the ideas that repressive governments are doomed to failure; that liberty is a motivating force; that freedom comes with responsibilities and must be guided by principles; that the example of our democracy is a challenge to all forms of political repression and an inspiration to those desiring to be free. Wilson and Truman took these ideas as the starting point for their policy formulation and pronouncements. Truman both acknowledged his indebtedness to Wilson and learned from his mistakes. This study places the two presidents within the broader American tradition and explores the way they combined reverence for the past with innovative policies. Pierce provides a cohesive argument against those who simplify and categorize American ideals in order to demean them. Her findings show that the assumption that Wilson was an idealist while Truman was a realist distorts our understanding of these men and denies the seriousness of their positions. She reveals Truman's brilliance as a foreign policy strategist and his fervency as a spokesperson for American ideals. He was never willing to dispense with geopolitics for the sake of internationalism, nor with internationalism for the sake of geopolitics, but insisted that our mission and our power were combined threads in our work for freedom. Truman's wisely construed version of Wilsonianism, which itself was an interpretation of America's mission and power, holds great promise for the United States today.

Calculating Credibility

As President Trump's National Security Advisor, John Bolton spent many of his 453 days in the room where it happened, and the facts speak for themselves. The result is a White House memoir that is the most comprehensive and substantial account of the Trump Administration, and one of the few to date by a top-level official. With almost daily access to the President, John Bolton has produced a precise rendering of his days in and around the Oval Office. What Bolton saw astonished him: a President for whom getting reelected was the only thing that mattered, even if it meant endangering or weakening the nation. "I am hard-pressed to identify any significant Trump decision during my

tenure that wasn't driven by reelection calculations," he writes. In fact, he argues that the House committed impeachment malpractice by keeping its prosecution focused narrowly on Ukraine when Trump's Ukraine-like transgressions existed across the full range of his foreign policy—and Bolton documents exactly what those were, and attempts by him and others in the Administration to raise alarms about them. He shows a President addicted to chaos, who embraced our enemies and spurned our friends, and was deeply suspicious of his own government. In Bolton's telling, all this helped put Trump on the bizarre road to impeachment. "The differences between this presidency and previous ones I had served were stunning," writes Bolton, who worked for Reagan, Bush 41, and Bush 43. He discovered a President who thought foreign policy is like closing a real estate deal—about personal relationships, made-for-TV showmanship, and advancing his own interests. As a result, the US lost an opportunity to confront its deepening threats, and in cases like China, Russia, Iran, and North Korea ended up in a more vulnerable place. Bolton's account starts with his long march to the West Wing as Trump and others woo him for the National Security job. The minute he lands, he has to deal with Syria's chemical attack on the city of Douma, and the crises after that never stop. As he writes in the opening pages, "If you don't like turmoil, uncertainty, and risk—all the while being constantly overwhelmed with information, decisions to be made, and sheer amount of work—and enlivened by international and domestic personality and ego conflicts beyond description, try something else." The turmoil, conflicts, and egos are all there—from the upheaval in Venezuela, to the erratic and manipulative moves of North Korea's Kim Jong Un, to the showdowns at the G7 summits, the calculated warmongering by Iran, the crazy plan to bring the Taliban to Camp David, and the placating of an authoritarian China that ultimately exposed the world to its lethal lies. But this seasoned public servant also has a great eye for the Washington inside game, and his story is full of wit and wry humor about how he saw it played.

"The real fault line in American politics is not between liberals and conservatives.... It is, rather, in how we orient ourselves to the generations to come who will bear the consequences, for better and for worse, of our actions." The Room Where It Happened

The most profound change that the United States and China have experienced in their relations over the past 30 years is perhaps the onset of an apparent power transition between the two nations.
