Adverse Effects on the Balance of Payments There are two possible adverse effects of FDI on a host country's balance-of-payments: 1. The capital outflows as foreign subsidiaries repatriate earnings to the parent country 2. There is a debit on the current account of the host country's balance of payments associated with imports of input products by the foreign

National Sovereignty and Autonomy OFDI can mean some loss of economic independence The benefits of FDI to the home country include: 1. The effect on the capital account of the home country's balance of payments from the inward flow of foreign earnings 2. The employment effects that arise from outward FDI 3. The gains from learning valuable skills from foreign markets that can subsequently be transferred back to the home country

The balance-of-payments The balance of payments suffers from the initial capital outflow required to finance the FDI The current account is negatively affected if the purpose of the FDI is to serve the home market from a low-cost production location

OInternational trade theory - home country concerns about the negative economic effects of offshore production (FDI undertaken to serve the home market) may not be valid FDI may actually stimulate economic growth by freeing home country resources to concentrate on activities where the home country has a comparative

Now, 6 years later, we can clearly see that the process of European integration, both before and after 2004, was what enabled Europe to overcome the gaps between various parts of the continent. The enlargement made Europe a better and wealthier place and streng- ened its position in the world. Integration into the European Union has always been one of the strongest incentives for reform in the new Member States. Particularly important in my view have been the development of ?nancial markets through foreign direct investment and capital in?ows, and the opening of labour markets — which was a two-way phenomenon, with markets being opened up in acceding as well as the incumbent Member States. The Fifth Enlargement was thus an exercise of glo- lisation in miniature, a practice run for the Union to tackle the challenges of the ever smaller world.

Protection of Foreign Investments in an Intra-EU Context

FDI screening is a complex, controversial and highly topical subject at the intersection of law, politics and economics. This book analyzes the political rationale behind FDI screening in the EU, reveals the legal limitations of current FDI screening mechanisms based on security and public order, and identifies legislative options for broader screening mechanisms in accordance with EU and international economic law. In particular, the book identifies the four main concerns in the EU regarding FDI from third countries: distortive competition effects; the lack of reciprocity on FDI treatment between the EU and the investor's home country; objectives of the investor or their home country that may be detrimental to EU interests; and safety of private information. On this basis, the book analyzes the Screening Regulation (Regulation (EU) 2019/452) and its newly introduced screening ground "security or public order" and asks whether this and other similar screening grounds based on the notions of security, public order and public policy can address these concerns with regard to foreign investors. Based on an analysis of WTO law and EU primary law, it argues that they cannot. Thus, the question arises: Do the EU and Member States have the flexibility to adopt broader FDI screening mechanisms? To answer this question, the book examines the freedoms of capital movement and establishment in EU primary law, as well as various sources of international economic law such as, first and foremost, the WTO's General Agreement on Trade in Services, but also other bi- and plurilateral trade and investment treaties, including the EU-China Comprehensive Agreement on Investment. In closing, the book identifies various legislative options for broader FDI screening mechanisms—and their shortcomings.

Screening Foreign Direct Investment in the EU

This book examines how foreign direct investment (FDI) inflows to Central and Eastern Europe have changed after the Great Recession. It argues that beyond their cyclical effects, the economic crisis and the changing competitiveness of Central and Eastern European countries have had structural impacts on FDI in the region. The EU and the Economies of the Eastern European Enlargement

This paper brings out the special mechanism through which taxes influence bilateral FDI, when investment decisions are two-fold in the presence of fixed setup flows costs. For each pair of source-host countries, there is a set of factors determining whether aggregate FDI flows will occur at all, and a different set of factors determining the volume of FDI flows (provided they occur). We develop a two-country tax competition model which yield an asymmetric Nash-equilibrium with high corporate tax rate and high level of public good provision in the rich source country for FDI outflows and with low corporate tax rate and low level of public good provision in the poor host country for FDI outflows. This is akin to the asymmetry among the EU 15 and EU 10 in the enlarged European Union, as of 2004. We also demonstrate that the notion that the mere international tax differentials are a key factor behind the direction and magnitude of FDI flows, the traditional race to the bottom argument in tax competition are too simple.

The Impact of the Single European Market on Foreign Direct Investment in the United Kingdom

This publication provides analyses of standardised data for foreign direct investment (FDI) flows and income for the EU covering the period 1992-2000. It includes a CD-ROM containing a number of standardised tables for each reporting country. Findings include: the year 2000 saw an increase of 16 per cent on the previous year for FDI investment to countries outside the EU, representing four per cent of EU GDP. The United States of America remained the EU's main partner and strong FDI outward investment was recorded to Canada and South America. EU FDI inflows to the EU from the rest of the world grew by 59 per cent, with the United States and Switzerland continuing to be the main investors. FDI flows between EU member states more than doubled during the period from 1999 to 2000, comprising mainly of ten major deals in the telecommunications sector.
