Political Representation and Citizenship in Portugal

Representative democracies are facing huge challenges that stem from long trends of citizens' dissatisfaction and weakening of political legitimacy, on the one hand, and the effects of global economic and financial crisis on electoral alignments and the patterns of government, on the other. This volume uses the Portuguese case as an important case study to examine the long-term debate on the crisis of representative democracies with the attempt to assess the impact of the Great Recession. arguments in connection with case studies for understanding the contemporary interactions between media, culture and democracy.

Toward an Ethic of Citizenship

Citizenship is a core concept for the social sciences, and citizenship is also frequently interpreted, challenged and contested in different political arenas. *Shaping Citizenship* explores how the concept is debated and contested, defined and redefined, used and constructed by different agents, at different times, and with regard to both theory and practice. The book uses a reflexive and constructivist perspective on the concept of citizenship that draws on the theory and methodology of conceptual history. This approach enables a panorama of politically important readings on citizenship that provide an interdisciplinary perspective and help to transcend narrow and simplified views on citizenship. The three parts of the book focus respectively on theories, debates and practices of citizenship. In the chapters, constructions and struggles related to citizenship are approached by experts from different fields. Thematically the chapters focus on political representation, migration, internationalization, sub-and transnationalization as well as the Europeanisation of citizenship. An indispensable read to scholars and students, *Shaping Citizenship* presents new ways to study the conceptual changes, struggles and debates related to core dimensions of this ever-evolving concept.

Shaping Citizenship

This text contains an examination of processes of cultural citizenship in peninsular Malaysia. In particular, it focuses upon the diverse residents of the southwestern state of Melaka and their negotiations of belonging and incorporation in Malaysian society. Following political independence and the formation of the Federation of Malaysia in 1957 Malaysian citizenship was extended to most members of these diverse social identities. In this post-colonial context, Timothy P. Daniels examines how public celebrations and representations, religious festivals, and patterns of social relations are connected to processes of inclusion and exclusion.

Building Cultural Nationalism in Malaysia

This book highlights the gains that a citizenship approach offers to the study of democracy in Indonesia, demonstrating that the struggle for citizenship and the historical development of democracy in the country are closely interwoven. The book arises from a research agenda aiming to help Indonesia's democracy activists by unpacking citizenship as it is produced and practiced through movements against injustice, taking the shape of struggles by people at grassroots levels for cultural recognition, social and economic justice, and popular representation. Such struggles in Indonesia have engaged with the state through both discursive and non-discursive processes. The authors show that while the state is the common focal point, these struggles are fragmented across different sectors and subject positions. The authors thus propose that developing chains of solidarity is highly important to motivating a democracy that not only has sovereign control over public affairs, but also robust channels and organisations for political representation. In advocating the development of transformative agendas, organisations, and strategies as an important need, and an enduring challenge, for the realization of citizenship, this book is timely and relevant to the study of contemporary Indonesia's socio-political landscape. It is relevant to students and scholars in political science, anthropology, sociology, human geography and development studies.

The Politics of Citizenship in Indonesia

This book is a study of the multiple meanings of European citizenship, which has been represented and publicly communicated by the European Commission in five distinctive ways – Homo Oeconomicus (1951-1972), A People's Europe (1973-1992), Europe of Transparency (1993-2004), Europe of Agorai (2005-2009) and Europe of Rights (2010-2014). The public communication of these five distinct representations of European citizenship reveal how the European Commission conceived of and attempted to facilitate the development of a Civil Europe. Ultimately this history, which is based upon an analysis of public communication policy papers and interviews with senior European Commission

officials past and present, tells a story about changing identities and about who we as Europeans might actually be and what kind of Europe we might actually belong to.

Citizenship, Markets, and the State

This book addresses the questions why citizenship education is an important subject for students in further and adult education and why we need democratic colleges to support the study of citizenship education. It investigates the historical roots of further and adult education and identifies how the adoption of citizenship education in the post-compulsory sector can enrich vocational studies in further education and programmes in adult education. It is argued that democratic colleges are vital to ensure that citizenship education informs the decision-making process throughout educational institutions (and as a means of establishing fair and equal representation for important stakeholders). The author has worked in both sectors for over a decade, and uses this experience to offer a blend of educational practice and philosophical investigation. The result is a work that appeals to both teachers in further and adult education as well as academics and students interested in philosophy of education.

Citizenship through learner voice and representation

This book challenges the assumptions behind the idea of digital citizenship in order to turn the attention to cases of innovation, social change and public good.

Citizenship and Democracy in Further and Adult Education

Citizenship and Identity offers an analysis of contemporary politics and of the scepticism and apathy which characterise the political life of modern democracies. Starting from exploration of liberal-democracy and a critique of the fragmentation of contemporary politics, this book develops a republican perspective as an alternative framework for political institutions and civic participation.

Negotiating Digital Citizenship

This book provides a broad overview of the main trends in mass attitudes towards domestic politics and European integration from the 1970s until today. Particularly in the last two decades, the "end of the permissive consensus" around European integration has forced analysts to place public opinion at the centre of their concerns. The book faces this challenge head on, and the overview it provides goes well beyond the most commonly used indicators. On the one hand, it shows how integration's deepening and enlargement involved polities and societies whose fundamental traits in terms of political culture - regime support, political engagement, ideological polarization - have remained anything but static or homogeneous. On the other hand, it addresses systematically what Scharpf (1999) has long identified as the main sources of the democratic deficits of the EU: the lack of a sense of collective identity, the lack of a Europe-wide structure for political accountability, and the lack of recognition of the EU

as a legitimate political authority. In other words, it focuses on the fundamental dimensions of how Europeans relate to the EU: identity (the sense of an "European political community"; representation (the perception that European elites and institutions articulate citizens' interests and are responsive to them); and policy scope (the legitimacy awarded to the EU as a proper locus of policy-making). It does so by employing a cohesive theoretical framework derived from the entire IntUne project, survey and macro-social data encompassing all EU member countries, and state-of-the-art methods. The IntUne series is edited by Maurizio Cotta and Pierangelo Isernia. In a moment in which the EU is facing an important number of social, economic, political and cultural challenges, and its legitimacy and democratic capacities are increasingly questioned, it seems particularly important to address the issue of if and how EU citizenship is taking shape. This series intends to address this complex issue. It reports the main results of a quadrennial Europe-wide research project, financed under the 6th Framework Programme of the EU. That programme has studied the changes in the scope, nature and characteristics of citizenship presently underway as a result of the process of deepening and enlargement of the European Union. The INTUNE Project - Integrated and United: A Quest for Citizenship in an Ever Closer Europe - is one of the most recent and ambitious research attempts to empirically study how citizenship is changing in Europe. The Project lasted four years (2005-2009) and it involved 30 of the most distinguished European universities and research centres, with more than 100 senior and junior scholars as well as several dozen graduate students working on it. It had as its main focus an examination of how integration and decentralization processes, at both the national and European level, are affecting three major dimensions of citizenship: identity, representation, and scope of governance. It looked, in particular, at the relationships between political, social and economic elites, the general public, policy experts and the media, whose interactions nurture the dynamics of collective political identity, political legitimacy, representation, and standards of performance. In order to address empirically these issues, the INTUNE Project carried out two waves of mass and political, social and economic elite surveys in 18 countries, in 2007 and 2009; in-depth interviews with experts in five policy areas; extensive media analysis in four countries; and a documentary analysis of attitudes toward European integration, identity and citizenship. The book series presents and discusses in a coherent way the results coming out of this extensive set of new data.

Citizenship and Identity

The House of Commons agreed unanimously in November 2008 to establish this Speaker's Conference. The Conference was asked to look into the reasons why women, members of the black and minority ethnic communities and disabled people are under-represented in the House of Commons, and to recommend ways in which the situation can be improved. Issues relating to the representation of gay, lesbian, bisexual and transgender communities were also considered. Currently most MPs are white, male, middle-aged and middle-class: the House of Commons should reflect more closely the diverse society in which we live. The Conference makes and draws 71 recommendations and conclusions. Individual chapters cover: the case for widening representation; citizenship and engagement; the importance of political parties; the role of the MP and how to become one; selection processes and barriers to selection; tackling supply-side barriers; changing the culture of Parliament. The Conference reports after a period of unprecedented diminishing of the House's reputation through the expenses scandal. This has combined with increasing dislocation between citizens and the democratic process. The need for change is recognised and this report outlines many practical steps that can be taken to correct under-representation. Broadening representation would also bring a positive benefit of improved effectiveness in the development of legislation and the scrutiny of Government performance.

Citizens and the European Polity

The continuing under-representation of women in political and public life remains a matter of concern across a wide range of countries, including the UK and Ireland. Within the UK it is a topical issue as political parties currently debate strategies, often controversial, which will increase women's representation. At the same time, devolution has ushered in significant change in the level of women's representation in Scotland and Wales and improved representation for women in Northern Ireland. That such increases in women's representation in political institutions have been slow in coming is indisputable, given that full enfranchisement of women on equal terms with men was achieved in Ireland in 1921 and in the UK in 1928.

Speaker's Conference (on Parliamentary Representation)

A study of the conditions of being a citizen, belonging and democracy in suburban Britain, this book focuses on understanding how a community takes on the social responsibility and pressures of being a good citizen through what they call 'stupid' events, festivals and parades. Building a community is perceived to be an important and necessary act to enable resilience against the perceived threats of neoliberal socio-economic life such as isolation, selfishness and loss of community. *Citizenship, Democracy and Belonging in Suburban Britain* explores how authoritative knowledge is developed, maintained and deployed by this group as they encounter other 'social projects', such as the local council planning committee or academic projects researching participation in urban planning. The activists, who call themselves the 'Seething Villagers', model their community activity on the mythical ancient village of Seething where moral tales of how to work together, love others and be a community are laid out in the *Seething Tales*. These tales include Seething 'facts' such as the fact that the ancient Mountain of Seething was destroyed by a giant. The assertion of fact is central to the mechanisms of play and the refusal of expertise at the heart of the Seething community. The book also stands as a reflexive critique on anthropological practice, as the author examines their role in mobilising knowledge and speaking on behalf of others. *Citizenship, Democracy and Belonging in Suburban Britain* is of interest to anthropologists, urban studies scholars, geographers and those interested in the notions of democracy, inclusion, citizenship and anthropological practice.

Women and Citizenship in Britain and Ireland in the 20th Century

This work offers a timely philosophical analysis of interrelated normative questions concerning immigration and citizenship in relation to the global context of multiple nation states. In it, philosophers and scholars from the social sciences address both fundamental questions in moral and political philosophy as well as specific issues concerning policy. Topics covered in this volume include: the concept and the role of citizenship, the equal rights and representation of citizens, general moral frameworks for addressing immigration issues, the duty to obey immigration law, the use of ethnic, cultural, or linguistic criteria for selective immigration, domestic violence as grounds for political asylum, and our duty to refugees in general. The urgency of the need to discuss these matters is clear. Several humanitarian crises involving human migration across national boundaries stemming from war, economic devastations, gang violence, and violence in ethnic or religious conflicts have unfolded. Political debates concerning immigration and immigrant communities are continuing in many countries, especially during election years. While there have always been migrating human beings, they raise distinctive issues in the modern era because of the political context under which the migrations take place, namely, that of a system of sovereign nation states with rights to control their borders and determine their memberships. This collection provides readers the opportunity to parse these complex issues with the help of diverse philosophical, moral, and political perspectives.

The authors report evidence of the levels of European identity, sense of EU representation and preferences for EU policy scope among European mass publics, which are the main dimensions of EU citizenship. The analysis uses a new comparative dataset on EU attitudes derived from a survey in 16 EU countries plus Serbia in 2007. This study shows that, despite initial expectations, levels of European identity, sense of EU representation, and preferences for EU policy scope among European mass publics did not display a strong trend in any particular direction during the period between 1975 and 2007. However, there are interesting variations in these measures of EU citizenship both across individuals and across countries that are described and explained by reference to a series of relevant hypotheses. The book pays particular attention to the inter-linkages among the three dimensions of citizenship itself. EU identity, representation and scope are all reciprocally related, but the representation dimension is key to the development of a generalised sense of a sense of citizenship at the EU level. The first dimension of the dialectic, the 'democratization of technology', addresses self-mediation from the perspective of the empowering potential of new technologies to invent novel discourses of counter-institutional resistance and activism (individual or collective); the second dimension, the 'technologization of democracy', addresses self-mediation from the perspective of the regulative potential of new technologies to control the discourses and genres of ordinary participation and, in so doing, to reproduce the institutional power relations that such participation seeks to challenge. This book was originally published as a special issue of *Critical Discourse Studies*.
