The Migration Policy Institute released a fact sheet in 2016, stating that children born in the U.S. of a parent or parents who are undocumented immigrants, are placed at a severe disadvantage in life. This data was collected from 5.1 million children who are living with an unauthorized immigrant parent. Researchers found that these children are likely not to be enrolled in preschool, are likely to be held in a socioeconomic level that keeps them from developing and gaining access to resources, and are likely to fail in English proficiency that is necessary to move ahead in life. Place on top of that, the stress that their parent might be deported at any minute. These children are at risk, without a doubt.

While U.S. policies on immigration and border control are hotly debated, this volume makes sure that we don't forget what's really at stake, the future of our young. The Children of Undocumented Immigrants

LOOKING BACK AND MOVING FORWARD is a book that entertains, amuses, enlightens, and touches our hearts. The author, Willie Gruenwald, son of German and Austrian Jews who were fortunate enough to escape Hitler's Europe, is both the son of immigrants, and himself an immigrant when he moved from Peru to the United States at the age of twenty. Gruenwald tells us his experiences as a child of immigrants. It is his story and, at the same time, the story of many other sons and daughters of immigrants. His parents, trying to escape the European hell to wherever they could, arrived in Peru, not by design but by accident, and were received by a generous people who opened their arms and hearts to them. It was not easy for immigrants to adapt to different countries, different languages, customs, and food. But they did it and reciprocated gratefully by working hard, building up businesses that provided work and income to many Peruvian families. Gruenwald's objective in this book is to remember, understand and appreciate the struggles and challenges faced by that first generation. This book is not an attempt to answer all questions. On the contrary, the author raises more questions hoping that the reader, immigrant or not, will have a more profound understanding of the circumstances of our times.

Looking Back and Moving Forward

More than twelve million immigrants, many of them children, passed through Ellis Island's gates between 1892 and 1954. Children also came through the "Guardian of the Western Gate," the detention center on Angel Island in California that was designed to keep Chinese immigrants out of the United States. Based on the oral histories of fifty children who came to the United States before 1950, this book chronicles their American odyssey against the backdrop of World Wars I and II, the rise and fall of Hitler's Third Reich, and the hardships of the Great Depression. Ranging in age from four to sixteen years old, the children hailed from Northern, Central, Eastern, and Southern Europe; the Middle East; and China. Across ethnic lines, the child immigrants' life stories tell a remarkable tale of human resilience. The sources of family and community support that they relied on, their educational aims and accomplishments, their hard work, and their optimism about the future are just as crucial today for the new immigrants of the twenty-first century. These personal narratives offer unique perspectives on the psychological experience of being an immigrant child and its impact on later development and well-being. Passages to America

These eight letters are in fact a personal account of my feelings as a father, an immigrant, and a poet, towards my son. They are an emotional register of the dilemma of alienation, exile and loneliness that faces every immigrant, Lebanese or not, who, for various circumstances, leaves his or her country and emigrates abroad. These letters are a private record, a personal portrayal of my inner struggle. I put it out there in hopes that it may mirror the experience of many other immigrants and highlight their attachment to their first born in a foreign country with the feeling of joy mixed with guilt of attempting to raise a child without the support of family while desperately trying to provide a connection with the customs, traditions and culture from which the immigrant descended. It is my hope that any Lebanese, Arab or other immigrant families read their own reflection in these letters. (Black and White Edition)

Letters to My Son

Now in the midst of the largest wave of immigration in history, America, mythical land of immigrants, is once again contemplating a future in which new arrivals will play a crucial role in reworking the fabric of the nation. At the center of this prospect are the children of immigrants, who make up one fifth

of America's youth. For immigrant children, the authors write, it is the best of times and the worst. A Child of Light

Son of a Reluctant Immigrant

Even more so than now, class politics will be ethnic politics, and national unity will be impossible. Salam offers a solution, if we have the courage to break with the past and craft an immigration policy that serves our long-term national interests. Rejecting both militant multiculturalism and white identity politics, he argues that limiting total immigration and favoring skilled immigrants will combat rising inequality, balance diversity with assimilation, and foster a new nationalism that puts the interests of all Americans—native-born and foreign-born—first.

An in-depth look at the challenges undocumented immigrants face as they raise children in the U.S. There are now nearly four million children born in the United States who have undocumented immigrant parents. In the current debates around immigration reform, policymakers often view immigrants as an economic or labor market problem to be solved, but the issue has a very real human dimension. Immigrant parents without legal status are raising their citizen children under stressful work and financial conditions, with the constant threat of discovery and deportation that may narrow social contacts and limit participation in public programs that might benefit their children. Immigrants Raising Citizens offers a compelling description of the everyday experiences of these parents, their very young children, and the consequences these experiences have on their children's development. Immigrants Raising Citizens challenges conventional wisdom about undocumented immigrants, viewing them not as lawbreakers or victims, but as the parents of citizens whose adult productivity will be essential to the nation's future. The book's findings are based on data from a three-year study of 380 infants from Dominican, Mexican, Chinese, and African American families, which included in-depth interviews, in-home child assessments, and parent surveys. The book shows that undocumented parents share three sets of experiences that distinguish them from legal-status parents and may adversely influence

their children's development: avoidance of programs and authorities, isolated social networks, and poor work conditions. Fearing deportation, undocumented parents often avoid accessing valuable resources that could help their children's development—such as access to public programs and agencies providing child care and food subsidies. At the same time, many of these parents are forced to interact with illegal entities such as smugglers or loan sharks out of financial necessity. Undocumented immigrants also tend to have fewer reliable social ties to assist with child care or share information on child-rearing. Compared to legal-status parents, undocumented parents experience significantly more exploitive work conditions, including long hours, inadequate pay and raises, few job benefits, and limited autonomy in job duties. These conditions can result in ongoing parental stress, economic hardship, and avoidance of center-based child care—which is directly correlated with early skill development in children. The result is poorly developed cognitive skills, recognizable in children as young as two years old, which can negatively impact their future school performance and, eventually, their job prospects. Immigrants Raising Citizens has important implications for immigration policy, labor law enforcement, and the structure of community services for immigrant families. In addition to low income and educational levels, undocumented parents experience hardships due to their status that have potentially lifelong consequences for their children. With nothing less than the future contributions of these children at stake, the book presents a rigorous and sobering argument that the price for ignoring this reality may be too high to pay.

Paper Son

In this book, while the author is translating his father's Greek manuscripts written some thirty years ago, he describes life, suffering, and struggle to survive in the cruel world of the twentieth century. His father and mother both born in Greek cities of Asia Minor escaped the Turkish brutality and the Hellenic Holocaust of 1916 to 1922. They came to Greece in 1922 and survived the difficult and inhumane conditions of the refugee settlements. There they met, were married some time in 1935, and after losing their first child to poverty and conditions unfit to human dignity, they brought to this world in 1937 the author of this book, who was followed by seven other children. The author and five of the siblings are still alive today.

"Unauthorized immigrants" are defined as all foreign-born non-citizens residing in the United States without permit of residence or valid visa (ibid.). They are also referred to as "illegal immigrants" or "aliens" (cf. Garcia 104). Most illegal immigrants in the United States live in families where the adults are undocumented, but the children were born in the USA and therefore legal U.S. citizens (cf. Passel). It is the story of Carlos Galindo, an illegal immigrant from Mexico, and his son Luis, who is a legal U.S. citizen, because he was born in the United States (cf. A Better Life 2011). The film was directed by Chris Weitz and published in the USA in June 2011 (cf. ibid.). The film is set in East Los Angeles, a district of the City of Los Angeles which is mainly inhabited by people of Mexican descent (cf. Garcia 82). This term paper concentrates on the father-son relationship between Carlos and Luis Galindo and its development over the course of the film. Following this introduction, the first part of the second chapter contains the characterizations of Carlos Galindo and his son Luis. The characterizations show the core characteristics and attitudes of the two main characters.
