Palais theorizes in his important book on Korea that the remarkable longevity of the Yi dynasty (1392–1910) was related to the difficulties the country experienced in adapting to the modern world. He suggests that the aristocratic and hierarchical social system, which was the source of stability of the dynasty, was also the cause of its weakness. Throughout history, Korea not only developed a culture that is unique and distinguished from that of China, but also transmitted many elements of its culture to Japan.

Introduction of Buddhism to Korea

He examines scholarly debates surrounding the cults of Maitreya and Amit bha, the practice of buddh nusm[ti, the recollection of Amit bha, the "ten recollections" within the larger Mah y na context of the bodhisattva's path of practice, the emerging Huayan intellectual tradition, and the influential interpretations of medieval Chinese Pure Land proponents Tanluan and Shandao. Finally, his work illuminates the legacy of the Silla Pure Land tradition, revealing how the writings of Silla monks continued to be of great value to Japanese monks for several centuries. South Korea's Minjung Movement

The Association began as a mass organisation of Korea historians that, according to its founding mission statement, sought to "actively participate in the creation of a truly democratic and independent Korean society by joining together with a new determination to establish and continuously implement a scientific historiography

based upon the correct worldview." The Korean Historical Research Association thus took up the goal of "contributing to the independence and democratisation of Korean society through the establishment of a scientific and practical historiography." The Association engages in joint research projects, spreading the results of historical research to the masses, and publishing and distributing academic journals and popular history texts. The Korean Historical Research Association now has more than 700 members and has created an efficient organisation that publishes and disseminates papers, books, and bulletins.

KOREA AND THE IMPERIALISTS Until the Korean War in 1950, except for evangelist Christian missionaries, Americans were not interested in Korea or considered it important in the scheme of things. Many did not know Korea had existed as an independent kingdom for centuries and others thought Korea might be a part of China or Japan. Nationalism, geopolitics, and imperialism were the major determinants of international events in the late nineteenth and early twentieth century. Greed and racism were the prime motivators of imperialism and non-White societies of the world were the victims. Korea was one of many countries that was invaded and made a "sphere of influence." With the support of America and Britain, Japan destroyed Korea's traditional national identity and made Korea a colony in the Japanese Empire. It was the perfect example of how imperialism profoundly affected the social, economic, and political life of countries subjugated by imperialist powers. After World War II, Korea was not granted independence because the Americans did not believe Koreans were capable of self-government. Korea was divided into two military occupation zones, resulting in the creation of a Russian and an American satellite state. In an effort to unite Korea, North Korea invaded South Korea. The U.S., China, and the two Korean states fought a meaningless war and Korea remains divided. Who are the Koreans? Why are there two Koreas? What is Korea's national identity? What role does imperialism and racism play in the destruction of national identities? Hopefully, this brief history of Korea and the Imperialists will provide some answers.

A History of Korea

William Elliot Griffis (1843 – 1928) graduated from Rutgers College in 1869 and taught four years in Fukui and Tokyo. After his return to the United States, he devoted himself to his research and writing on East Asia throughout his life. He authored 20 books about Japan and five books about Korea including, Corea: The Hermit Nation (1882), Corea, Without and Within: Chapters on Corean History, Manners and Religion (1885), The Unmannerly Tiger, and Other Korean Tales (1911), A Modern Pioneer in Korea: The Life Story of Henry G. Appenzeller (1912), and Korean Fairy Tales (1922). In particular, his bestseller, Corea: The Hermit Nation (1882) was reprinted numerous times through nine editions over thirty years. He was not only known as "the foremost interpreter of Japan" to the West before World War I but also the American expert on Korea. After his death, his collection of books, documents, photographs and ephemera was donated to Rutgers. The Korean materials in the Griffis Collection at Rutgers University consist of journals, correspondence, articles, maps, prints, photos, postcards, manuscripts, scrapbooks, and ephemera. These papers reflect Griffis's interests and activities in relation to Korea as a historian, scholar, and theologian. They provide a rare window into the turbulent period of late nineteenth- and twentieth-century Korea, witnessed and evaluated by Griffis and early American missionaries in East Asia. The Korea Letters in the William Elliot Griffis Collection are divided into two parts: letters from missionaries and letters from Japanese and Korean political
