On the Corruption of Morals in Russia, is the most celebrated work of the Russian historian, philosopher and publicist Prince M. M. Shcherbatov (1733-90). The work was not published during the author's lifetime; not surprisingly, since its contents were highly treasonable. The text, which is collated from the three primary manuscript copies of the original, is the first to include all important textual variants.

Boris Yeltsin's attempts at democratic reform have plunged a long troubled Russia even further into turmoil. This dramatic break with the Soviet past has left Russia politically fragmented and riddled with corruption, its people with little hope for the future. In a fascinating account for anyone interested in Russia's current political struggles, Tim McDaniel explores the inability of all its leaders over the last two centuries--tsars and Communist rulers alike--to create the foundations of a viable modern society. The problem then and now, he argues, is rooted in a cultural trap endemic to Russian society and linked to a unique sense of destiny embodied by the "Russian idea." In its most basic sense, the Russian idea is the belief that Russia can forge a path in the modern world that sets itself apart from the West through adherence to shared beliefs, community, and equality. These cultural values, according to McDaniel, have mainly reversed the values of Western society rather than having provided a real alternative to them. By relying on the Russian idea in their programs of change, dictatorial governments almost unavoidably precipitated social breakdown. When the Yeltsin government declared war on the Communist past, it broke with deeply held Russian values and traditions. McDaniel shows that in cutting people off from their pasts and promoting the West as the sole model of modernity, the reformers have simultaneously undermined the foundations of Russian morality and the people's sense of a future.

Religion and Enlightenment in Catherinian Russia defines the Russian Enlightenment as a response to the allure of European modernity, as an instrument of social control, and as the moral voice of an emergent independent society. Because Russia's enlightened intellectuals focused on the moral perfectibility of the individual human being, rather than social and political change, the originality of the Russian Enlightenment has gone unrecognized. This study corrects images of a superficial Enlightenment and crisis-ridden religious culture, arguing that in order to understand the humanistic sensibility and emphasis on individual dignity that permeate Russian intellectual history, and the history of the educated classes more broadly, it is necessary to bring Orthodox teachings into the discussion of Enlightenment thought. The result is a book that explains the distinctive origins of modern Russian culture while also allowing scholars to situate the Russian Enlightenment in European and global history.

The Russian Empire in the Eighteenth Century

In Russian politics reliable information is scarce, formal relations are of relatively little significance, and things are seldom what they seem. Applying an original theory of political language to narratives taken from interviews with 34 of Russia's leading political figures, Michael Urban explores the ways in which political actors construct themselves with words. By tracing individual narratives back to the discourses available to speakers, he identifies what can and cannot be intelligibly said within the bounds of the country's political culture, and then documents how elites rely on the personal elements of political discourse at the expense of those addressed to the political community. Urban shows that this discursive orientation is congruent with social relations prevailing in Russia and helps to account for the fact that, despite two revolutions proclaiming democracy in the last century, Russia remains an authoritarian state.

Russian rulers have also had to contend with the same immense physical challenges - a hugely dispersed population, a perennial dearth of means and men to govern, a primitive infrastructure. Plagued by natural disasters, hamstrung by structural problems, the Russian economy - whether pre-revolutionary capitalist, Soviet socialist, or post-Soviet semi-capitalist - has had enormous and disruptive difficulties adapting to the competitive world of international markets. Another immutable, elemental fact has been Russia's multinational composition, which continues to generate discontent and disorder. Yet Russia is a great survivor, as the years from 1995 show, charaterized by economic recovery, institution-building, and a new mood of self-assertion in world politics. For too long Russian history has been dominated by myths and counter-myths, concocted by those seeking either to legitimize the existing order or to destroy it. This book - containing many little-known illustrations - represents an important attempt to rethink Russian history and to provide a new understanding of Russia's complex but ever-fascinating historical development.
