The photograph of three men spattered with red paint, their arms linked, marching to protest the Vietnam War, is an icon of the 1960s movement for social justice. David Dellinger is on one side, Robert Moses on the other. In the middle is Staughton Lynd, chairperson of the first march on Washington against the war, and former director of the Mississippi Freedom Schools. Thirty years later, Staughton Lynd here reaffirms ideas central to the New Left of the sixties: nonviolence, participatory democracy, an experiential approach to education, and anti-capitalism. In essays written between 1970 and 1995, he passionately defends the intellectual contribution of a movement often dismissed as mindlessly activist. In addition, he advocates direct, sustained involvement in meeting the needs of the working class and the poor. Each section of the book identifies major influences on Lynd's life as teacher, historian, lawyer, and organizer. In the section entitled "Accompaniment," Lynd suggests the relevance to the United States of the concepts of liberation theology which have revolutionized Central America. In "Socialism with a Human Face," he expresses continued allegiance to the socialist ideals exemplified by Simone Weil and E. P. Thompson. The final section, "Solidarity Unionism," deals with the self-activity of rank-and-file workers. *Living Inside Our Hope* will reach out to everyone who remembers the ideals of the sixties with nostalgia and to those, too young to remember, who are seeking a foundation on which to build their own social activism.

Nederman, Texas A&M University Why has contemporary radical political theory remained virtually silent about the stunning rise in inequality in the United States over the past thirty years? Schwartz contends that since the 1980s, most radical theorists shifted their focus away from interrogating social inequality to criticizing the liberal and radical tradition for being inattentive to the role of difference and identity within social life. This critique brought more awareness of the relative autonomy of gender, racial, and sexual oppression. But, as Schwartz argues, it also led many theorists to forget that if difference is institutionalized on a terrain of radical economic inequality, unjust inequalities in social and political power will inevitably persist. Schwartz cautions against a new radical theoretical orthodoxy: that "universal" norms such as equality and solidarity are inherently repressive and homogenizing, whereas particular norms and identities are truly emancipatory. Reducing inequality among Americans, as well as globally, will take a high level of social solidarity--a level far from today's fragmented politics. In focusing the left's attention on the need to reconstruct a governing model that speaks to the aspirations of the majority, Schwartz provocatively applies this vision to such real world political issues as welfare reform, race relations, childcare, and the democratic regulation of the global economy.

### The Future Of Democratic Equality

This book describes how, after the Second World War, the Labour Party assumed leadership of the International Socialist Movement, thanks to the achievements of the Attlee Government. International Secretary Denis Healey guided the reconstruction of the Socialist International through the early Cold War, making the British vision for socialist internationalism prevail over the French and Belgian. At first, the provisional Socialist International (International Socialist Conference and Comisco) supported cohabitation with pro-communist socialists and the USSR, but with the Sovietisation of Eastern Europe it committed to militant anti-communism. Ambiguity between the Labour Party and Labour Government influenced British policy in Austria, Czechoslovakia, Greece, Italy and Poland, while the characterization and stereotypes of Eastern and Southern Europe shaped the language and actions of the British. Furthermore, the book shows how international contacts and the British and Swedish model encouraged the transition of socialist parties to responsible government parties fully embracing Western democracy and prepared the ideological revision of the 1950s.

experience. Padraic Kenney argues that the postwar takeover was also a social revolution, in which workers expressed their hopes for dramatic social change and influenced the evolution--and eventual downfall--of the communist regime. Kenney compares Łódź, Poland's largest manufacturing center, and Wrocław, a city rebuilt as Polish upon the ruins of wartime destruction. His account of dramatic strikes in the textile mills of Łódź shows how workers resisted the communist party's encroachment on factory terrain and its infringements of worker dignity. The contrasting absence of labor conflict among migrants in the frontier city of Wrocław holds important clues to the nature of stalinism in Poland: communist power was strongest where workers lacked organizational ties or cultural roots. In the collective reaction of workers in Łódź and the individualism of those in Wrocław, Kenney locates the beginnings of the end of the communist regime. Losing the battle for worker identity, the communists placed their hopes in labor competition, which ultimately left the regime hostage to a resistant work force and an overextended economy incapable of reform.
