Religious Freedom and the Neutrality of the State

The permanent presence of Islam and Muslims is a comparatively recent phenomenon in most countries of the European Union. Over the last few decades many initiatives have been launched by Muslim communities in the European Union to create infrastructural provisions for their religious life, within the existing legal and social frameworks. In fact, all countries of the European Union share the principles of religious freedom and non-discrimination in their respective Constitutions. However, the precise way in which these principles are interpreted and applied to Islam depends largely on the historical traditions concerning the relation between State and Religion, which differ from one country to another. These differences are reflected in recent developments in the communication between the States and their Muslim communities, both at national, regional and municipal levels. They are also reflected in recent developments in legislation and jurisprudence concerning the most essential Islamic core-values, such as dietary laws, the precepts on modest dress, Islamic burial practices and the possibilities to found Islamic cemeteries, as well as the observance of Friday prayers and annual holidays. Looking at the legal position of Islam in the countries of the European Union, the authors of this volume discuss the challenges posed by the presence of Islam to the Western European system of relationships between law and religion. They argue, that these challenges necessitate reforms within the relevant European legislation, but differ as to their precise nature. They also discuss the difficulties of this task, as these adjustments will alter a longstanding balance of rights and privileges recognised by different religious denominations. Legal reforms, however, are not sufficient. The creation of a truly multicultural Europe also necessitates fighting against the negative image of Islam and Muslims (anti-Muslimism or Islamophobia) prevailing in most of its member states.

Stemming from the authors firm conviction that both our nation and our community are experiencing a severe crisis, this book is prompted by his grave concern for the future as well as his unshakable resolve to significantly contribute towards the fundamental change that is needed right now within our society. His concerns and his resolve are shared by other Muslim Americans who will join in launching this project. We invite all Americans to participate. Even though Islam and Muslims have been present in the U.S. in one form or another for a long time, the Muslim American community is still regarded as a newcomer. One reason is that the connections with the greater American society have been weak and complicated. The Nation of Islam, which is largely comprised of United States-born African American Muslims, is widely viewed as a Black nationalist movement rather than an Islamic phenomenon. And even though immigrant Muslims began to establish Islamic centers as early as the beginning of the 20th century and also despite the establishment of the first chapter of the Muslim Student Association (MSA) in 1963 the organized presence of orthodox Islam did not truly emerge in America until the 1970s. The real proliferation of mosques, schools, and Islamic organizations took place as recently as the 80s and 90s. Furthermore, the integration of the Muslim American community into the greater American society stalled because of some typical factors that were exacerbated by religious and political issues and by some domestic and global events. As a result, the Muslim community was plunged into a deep crisis and became, for other Americans, a puzzle and a source of major challenge, especially after the 9/11 catastrophe. A huge divide was established between the community and American society at large, and a vicious action-reaction cycle is only reinforcing the divide and widening the gap. Redefining the Muslim Community

Writing in the cosmopolitan metropolis of Baghdad, Alfarabi (870-950) is unique in the history of premodern political philosophy for his extensive discussion of the nation, or Umma in Arabic. The term Umma may be traced back to the Qur' n and signifies, then and now, both the Islamic religious community as a whole and the various ethnic nations of which that community is composed, such as the Turks, Persians, and Arabs. Enlisting language experts, jurists, theologians, artists, and rulers in his philosophic enterprise, Alfarabi argued for a new Umma that would be less rigid and more creative than the Muslim community as it has often been understood, and therefore less inclined to force disparate ethnic and religious communities into a single mold. Redefining the Muslim Community demonstrates how Alfarabi's judicious combination of cultural pluralism, religious flexibility, and political prudence could provide a blueprint for reducing communal strife in a region that continues to be plagued by it today.

During the 1980s, Islamic activists in the Arab Middle East have challenged the definition of "legitimate" authority" and provided the means and rationale for revolutionary change, hoping to pressure established governments to alter domestic and foreign policies. No nation-state has been immune. Fearful Arab nationalist leaders, unwilling or unable to abandon decades of ideological baggage, have begun a gradual, if erratic, process of melding the spirit and letter of Islamic precepts into existing national laws and political rhetoric. Whether it is adequate to the challenge, the state nevertheless bears the onus of accommodation, because Islam and Arabism will not soon disappear. They will assume new form and substance in the changing realities of the region. Dilemmas inherent to this century and the gauntlet delivered to hitherto unquestioned political caveats will continue to exacerbate the competition between Islam and Arabism, their quest for political platforms and supporters, and the credibility of all other claimants, including the state. At the same time, these forces act like invisible sentinels in the mind, standing ready to cast a long shadow as unconscious motivators of political behavior. What Is an American Muslim?

Abdullah An-na'im offers a pioneering exploration of American Muslim citizenship and identity, arguing against the prevalent emphasis on majority-minority politics and instead promoting a shared citizenship that both accommodates and transcends religious identity. Many scholars and community leaders have called on American Muslims to engage with or integrate into mainstream American culture. Such calls tend to assume that there is a distinctive, monolithic, minority religious identity for American Muslims. Rejecting the closed categories that determine the minority status of a particular group and that, in turn, impede active, engaged citizenship, An-na'im draws attention to the relational nature of identity, emphasizing a common base of national membership and advancing a legal approach to a public recognition of a person's status as citizen. Rather than perceive themselves or accept being perceived by others as a monolithic minority, he argues, American Muslims should view themselves as American citizens who happen to be Muslims. As American citizens, they share a vast array of identities with other American citizens, whether ethnic, political, or socio-economic. But none of these identities qualify or limit their citizenship. An-na'im urges members of the American Muslim community to take a proactive, affirmative view of their citizenship in order to realize their rights fully and fulfill their obligations in social and cultural as well as political and legal terms. He shows that the freedom to associate with others in order to engage in civic action to advance rights and interests is integral to the underlying rationale of citizenship and not something that must be relinquished to become an American citizen. What Is an American Muslim? provides acute insight into the nature of citizenship and identity, the place of religious affiliation in American society, and what it means to share in a collective identity.

The Muslim Community in North America

This book consists of fifteen studies addressed to the relatively recent phenomenon of Muslims residing in North America, their adaptation to an often alien way of life, as well as the problem the larger North American community faces in not only accepting but also benefiting from the existence of this new group. Looking into the future, it provides guidelines for how community policing can play a proactive role in law enforcement and crime prevention.

Placing Farrakhan's life and leadership in historical context, she traces his evolution from a fiery Black Nationalist in 1960s Harlem to a respected leader in sections of the USA and abroad, and uncovers Farrakhan's work in rebuilding the NOI's reputation following Malcolm X's assassination. Archival material includes FBI's files on the NOI and its leaders, Farrakhan's writings in the Muhammad Speaks and The Final Call newspapers, and lectures and interviews from the late 1970s to the present day. Excerpts from first-hand interviews from NOI officials, pastors, imams, and community groups provide important insights into Farrakhan's religious life.

Muslim Minorities in the West

Although they are typically portrayed by the media as dangerous extremists in distant lands, Muslims in fact form a permanent, peaceful and growing population in nearly every Western country. While Westerners are now more commonly seeing mosques in their neighborhoods or scarved Muslim women in their streets, misperceptions and stereotypes remain. With expanding numbers and desires to protect their rights and identities, Muslims are coming into more and more into the public view. In Muslim Minorites in the West noted scholars Haddad and Smith bring together outstanding essays on the distinct experiences of minority Muslim communities from Detroit, Michigan to Perth, Australia and the wide range of issues facing them. Haddad and Smith in their introduction trace the broad contours of the Muslim experience in Europe, America and other areas of European settlement and shed light on the common questions minority Muslims face of assimilation, discrimination, evangelism, and politics. Muslim Minorities in the West provides a welcome introduction to these increasingly visible citizens of Western nations.

We God's People

Cesari argues that both religious and national communities are defined by the three Bs: belief, behaviour and belonging. By focusing on the ways in which these three Bs intersect, overlap or clash, she identifies the patterns of the politicization of religion, and vice versa, in any given context. Her approach has four advantages: firstly, it combines an exploration of institutional and ideational changes across time, which are usually separated by disciplinary boundaries. Secondly, it illustrates the heuristic value of combining qualitative and quantitative methods by statistically testing the validity of the patterns identified in the qualitative historical phase of the research. Thirdly, it avoids reducing religion to beliefs by investigating the significance of the institution-ideas connections, and fourthly, it broadens the political approach beyond state-religion relations to take into account actions and ideas conveyed in other arenas such as education, welfare, and culture.

Rediscovering the Umma

In Rediscovering the Umma, Ina Merdjanova discusses the conditions and role of Islam in relation to post-Ottoman nation-building, the communist period, and post-communist developments in the Balkans, focusing in particular on the remarkable transformations experienced by Muslim communities after the end of the Cold War. Amidst multiple structural and cultural transitions, they sought to renegotiate their place and reclaim their Islamic identities in formally secular legal and normative environments, mostly as minorities in majority-Christian societies. The rising political and cultural self-awareness of Muslims in Southeast Europe was frequently expressed by recourse to two frames of reference: the national and the transnational. Despite a certain level of tension between those two perspectives, they were closely intertwined. Moreover, transnational Islamic influences often reinforced Muslim ethnonational identities rather than prompting a radical redefinition of religious allegiances in

the key of a "universalist" Islam. Merdjanova explores the transformations of Muslim identities in the region under the influence of national and transnational, domestic and global factors, while also looking at the historical legacies that inform present complexities. Furthermore, she examines the evolving status and roles of Muslim women both in their religious communities and in the larger societies. The book challenges representations of Islam and Muslims as alien to Europe, which overlook the fact that Europe has considerable indigenous Muslim populations in its southeastern part as well as societies that have developed certain models of negotiating cultural differences.

This book is the product of more than twenty years of extensive research and interaction with communities across America. That background preparation has given the author, Dr. Souheil Ghannouchi, a deep understanding of Islam, of history, and of the reality in which all Americans (including Muslim Americans) live. Additionally, the text benefits from Dr. Ghannouchi's careful study and observation of world events, and from his comprehension of the universal rules that govern the rise and fall of both nations and movements. This volume was originally meant to be the intellectual foundation for a renaissance movement for all Americans, and it was to be aimed at reviving the American Dream and restoring America's fundamental values based on the founding fathers' vision. The idea of recruiting all Americans to the task was inspired by serious concerns about America's current situation and future risks, and by a firm belief that America can and should be the world's foremost champion for compassion, peace, justice, and prosperity. At the same time, the book was intended to spearhead the renaissance of the Muslim American community so that it would begin to play a meaningful role in making the needed change in America. However, even though both the entire country and, more specifically, the Muslim community are in dire need of fundamental change, it became clear to the author that the two objectives could not be adequately advocated with one publication. Thus, this book focuses mainly on Muslim Americans, and it constitutes a manifesto for a renaissance in the American Muslim community and a blueprint for our full integration into the greater American society. Stemming from the author's firm conviction that both our nation and our community are experiencing a severe crisis, this book is prompted by his grave concern for the future as well as his unshakable resolve to significantly contribute towards the fundamental change that is needed right now within our society. His concerns and his resolve are shared by other Muslim Americans who will join in launching this project. We invite all Americans to participate. Even though Islam and Muslims have been present in the U.S. in one form or another for a long time, the Muslim American community is still regarded as a newcomer. One reason is that the connections with the greater American society have been weak and complicated. The Nation of Islam, which is largely comprised of United States-born African American Muslims, is widely viewed as a Black nationalist movement rather than an Islamic phenomenon. And even though immigrant Muslims began to establish Islamic centers as early as the beginning of the 20th century and also despite the establishment of the first chapter of the Muslim Student Association (MSA) in 1963 the organized presence of orthodox Islam did not truly emerge in America until the 1970's. The real proliferation of mosques, schools, and Islamic organizations took place as recently as the 80's and 90's. Furthermore, the integration of the Muslim American community into the greater American society stalled because of some typical factors that were exacerbated by religious and political issues and by some domestic and global events. As a result, the Muslim community was plunged into a deep crisis and became, for other Americans, a puzzle and a source of major challenge, especially after the 9/11 catastrophe. A huge divide was established between the community and American society at large, and a vicious action-reaction cycle is only reinforcing the divide and widening the gap. Moreover, the attempts at healing undertaken by both sides are not really improving the situation because the efforts made are too few and too i

Muslim Minorities in Europe and India

Since the late 20th century, the issue of accommodation of religious minorities within the structure of nation-states has been a subject of intense discussions among scholars and policy makers across the world. Most societies and nation-states in the world are either experiencing strains in accommodating the social, economic, and political concerns of minority communities or facing difficulties in managing majority-minority relationship. More than any other community, it is the integration of minority Muslim communities that has been the subject of global debates and deliberations, particularly in the western hemisphere. The emergence of political radicalism within some sections of Muslim communities in the West, and a series of terrorist attacks, has further compounded this problem. These developments

have reinforced the pervasive thinking among a large section of non-Muslim host societies that Islam suffers from structural deficiencies for a meaningful integration in the host societies. This edited volume is a collection of 14 scholarly articles including an introduction, which deals with the problem of accommodation of Muslim minority communities in the European and Indian contexts. It interrogates the notion of modernity, Muslim modernity, secularism, pluralism and multiculturalism in both European and Indian settings.
