Harry the Plum Island Birdwatcher

This book was originally published in 1981 as a publication of the Cooper Ornithological Society and was based on the proceedings of a meeting of biologists and statisticians in Asilomar who gathered to examine the methods and assumptions used in estimating bird numbers. Counting birds has a long tradition. It is the currency of many ornithological studies. Bird counts have been seminal in our knowledge of bird migration, competition, ecology, population dynamics, environmental adaptation, impact of human alterations and island biogeography. Interest in estimating bird numbers remains high today but is often plagued by unasked or unanswered questions regarding sampling methods and treatment of the results. This book recorded the outcome of a meeting held to address these and other questions. It led to better understanding of what can and cannot be done with datasets. This volume remains a primary source of information on censusing of birds and other animals, and is frequently quoted in the primary literature of today. Since this volume went out of print some six years ago, demand has markedly increased for copies which are essentially unavailable, attesting to its currency today. C. John Ralph, received his Bachelors from the University of California, Berkeley and his doctorate from The Johns Hopkins University. Most of his early research was on bird migration and orientation. After a stint teaching at Dickinson College in Pennsylvania, he moved to Hawaii in 1976 where he began work on endangered forest birds for the Forest Service as a Research Ecologist. In 1981 he and his family moved to Arcata to join the Forest Service's Redwood Sciences Laboratory. One of his principal research topics there has been on an old-growth dependent bird, the Marbled Murrelet, involving extensive research from Alaska to California. His other principal work is on landbird monitoring, especially involving census and constant effort mist netting. Since 1994 he has directed research at a bird monitoring station in Costa Rica, now one of the longest running stations in Latin America. Beginning in 1980 he conducted research on an island off New Zealand involving monitoring and reintroduction of native birds. He has published more than 150 scientific articles and edited several books on bird monitoring and the Marbled Murrelet.

The Other Red Line is literally the connecting point between Scollay Square and the Combat Zone, the two preeminent adult entertainment districts in Boston. With burlesque houses such as the Old Howard and the Crawford House, movie palaces began to open, showing silent films accompanied by a pianist, news reels and comedy acts. The New Palace Theatre, the Star Theatre, the Theatre Comique and the Scollay Square Olympia offered vaudeville as well as silent films, which were a novelty at the time. With so many people seeking entertainment in Scollay Square, restaurants, bars and sandwich shops offered an entertaining evening out, and it became a destination. Burlesque was King, and the anointed Queens of Burlesque danced at both the Crawford House and the Old Howard, as well as smaller clubs, which were renowned not just in Boston, but incredibly even around the world, and had well-known performers who were beloved by their audience. However, so too was the Combat Zone, a vibrant area that beckoned Bostonians and service men for lurid entertainment. As Scollay Square's allure waned in the late 1950s, that of the Combat Zone took on a new shine in the 1960s, albeit a tawdry and garish shine that tried to emulate the other, but quickly devolved into a seedy, gritty place that offered vulgar and graphic entertainment. With bars, strip clubs and theaters beginning to show adult X-rated movies, the area increasingly became a place that one either went out of his way to avoid or found so alluring that the inevitability of joining in the irreverent fun of it quickly overcame one's reservations. The Other Red Line is a fascinating glimpse into the adult entertainment districts of twentieth-century Boston.

Strathbogie, the Gordons and the 'land O'cakes'

Mediterranean and West European pre-modern agriculture (agriculture before 1600) was by necessity 'organic agriculture'. Crop protection is part and parcel of this agriculture, with weed control in the forefront. Crop protection is embedded in the medieval agronomy text books but specialised sections do occur. Weeds, insects and diseases are described but identification in modern terms is not easy. The pre-modern 'Crop Portfolio' is well filled, certainly in the Mediterranean area. The medieval 'Pest Portfolio' differs from the modern one because agriculture then was a Low External Input Agriculture, and because the proportion of cultivated to non-cultivated land was drastically lower than today. The pre-modern 'Control Portfolio' is surprisingly rich, both in preventive and interventive measures. Prevention was by risk management, intensive tillage, and careful storage. Intervention was mechanical and chemical. Chemical intervention used natural substances such as sulphur, pitch, and 'botanicals'. Some fifty plant species are mentioned in a crop protection context. Though application methods look rather modern they are typically low-tech. Among them are seed disinfection, spraying, dusting, fumigation, grease banding, wound care, and hand-picking but also scarification, now outdated. The reality of pest outbreaks and other damages is explored as to frequency, intensity, and extent. Information on the practical use of the recommended treatments is scanty. If applied, their effectiveness remains enigmatic. Three medieval agronomists are at the heart of this book, but historical developments in crop protection from early Punic, Greek, and Roman authors to the first modern author are outlined. The readership of these writers was the privileged class of landowners but hints pointing to the exchange of ideas between them and the common peasant were found. Consideration is given to the pre-modern reasoning in matters of crop protection. Comparison of pre-modern crop protection and its counterpart in modern organic agriculture is difficult because of drastic changes in the relation between crop areas and non-crop areas, and because of the great difference in yield levels then and now, with several associated differences.

From the wreck of the Sparrow-Hawk in 1626 to the grounding of the Eldia in 1984, Cape Cod's outer beach--often referred to as the "Graveyard of Ships"--saw the demise of more than three thousand vessels along forty miles of shifting shoals. The October Gale of 1841 claimed the lives of fifty-seven sailors from Truro, a devastating toll for a small seaside community. Survivors from the 1896 wreck of the Monte Tabor in Provincetown were arrested for a suspected mutiny.
