In this brief volume, Stephen C. Russell introduces biblical scholars to the interdisciplinary study of space and its related concepts, including land and territory. He summarizes several approaches to the study of space, focussing especially on the work of Henri Lefebvre.

Israel's Tabernacle as Social Space

Space in the Hebrew Bible is increasingly studied from the perspective of critical spatiality, emphasizing the social and cultural dimension of space, how people experience space, and their creativity in constructing space. Zhenshuai Jiang investigates the discourses on space in Gen 1-11 and discusses the connection between social space and spatial narrative. He deals with various questions in different spatial terms, with a detailed textual analysis of Gen 1-11. How is space constructed in Gen 1-11? To what extent and how is this construction influenced by social and cultural elements? The author describes specifically how space in Gen 1-11 is constructed rhetorically, taking into account historical and social circumstances in which the texts were written.

Space, Land, Territory, and the Study of the Bible

In Anlehnung an Goffmans Rahmenanalyse, Sloterdijks Sphären-Hermeneutik und Kafkas Konzept einer panoptischen Moderne unterstellt Müller dem Stadtraum eine osmotische Aufspaltung der Lebenswelt. Mit Bezug auf Alfred Schütz Konzept der Lebenswelt und Heideggers Konzept des In-der-Welt-Seins entwickelt Müller eine sinnweltliche Topographie des Stadtraums. Making Home(s) in Displacement critically rethinks the relationship between home and displacement from a spatial, material, and architectural perspective. In *Beside You in Time* Elizabeth Freeman expands biopolitical and queer theory by outlining a temporal view of the long nineteenth century. Drawing on Foucauldian notions of discipline as a regime that yoked the human body to time, Freeman shows how time became a social and sensory means by which people assembled into groups in ways that resisted disciplinary forces. She tracks temporalized bodies across many entangled regimes—religion, secularity, race, historiography, health, and sexuality—and examines how those bodies act in relation to those regimes. In analyses of the use of rhythmic dance by the Shakers; African American slave narratives; literature by Mark Twain, Pauline Hopkins, Herman Melville, and others; and how Catholic sacraments conjoined people across historical boundaries, Freeman makes the case for the body as an instrument of what she calls queer hypersociality. As a mode of being in which bodies are connected to others and their histories across and throughout time, queer hypersociality, Freeman contends, provides the means for subjugated bodies to escape disciplinary regimes of time and to create new social worlds.

Making Home(s) in Displacement

During his lifetime Henri Lefebvre (1901-1991) was renowned in France as a philosopher, sociologist and activist. Although he published more than 70 books, few were available in English until *The Production of Space* was translated in 1991. While this work - often associated with geography - has influenced educational theory's 'spatial turn,' educationalists have yet to consider Lefebvre's work more broadly. This book engages in an educational reading of the selection of Lefebvre's work that is available in English translation. After introducing Lefebvre's life and works, the book experiments with his concepts and methods in a series of five 'spatial histories' of educational theories. In addition to *The Production of Space*, these studies develop themes from Lefebvre's other translated works: *Rhythmanalysis*, *The Explosion*, the three volumes of *Critique of Everyday Life* and a range of his writings on cities, Marxism, technology and the bureaucratic state. In the course of these inquiries, Lefebvre's own passionate interest in education is uncovered: his critiques of bureaucratised schooling and universities, the analytic concepts he devised to study educational phenomena, and his educational methods. Throughout the book Middleton demonstrates how Lefebvre's conceptual and methodological tools can enhance the understanding of the spatiotemporal location of educational philosophy and theory. Bridging disciplinary divides, it will be key reading for researchers and academics studying the philosophy, sociology and history of education, as well as those working in fields beyond education including geography, history, cultural studies and sociology.

The Museum of Rhythm

Table for one A critical reading of singlehood, gender and time is the first book to consider the profound relationship between singlehood and time. Drawing on a wide range of cultural resources - including web columns, blogs, advice columns, popular clichés, advertisements and references from television and cinema, the author challenges the conventional meaning-making processes of singlehood and time. Beginning with a powerful critique of historicism and its constraining effects on the geographical imagination, Edward Soja builds on the work of Foucault, Berger, Giddens, Berman, Jameson and, above all, Henri Lefebvre, to argue for a historical and geographical materialism, a radical rethinking of the dialectics of space, time and social being. Soja charts the respatialization of social theory from the still unfolding encounter between Western Marxism and modern geography, through the current debates on the emergence of a postfordist regime of "flexible accumulation." The postmodern geography of Los Angeles, exposed in a provocative pair of essays, serves as a model in his account of the contemporary struggle for control over the social production of space.

Beside You in Time

Through the focus on organizational space, using the reception and significance of the seminal work on the subject by sociologist Henri Lefebvre, this book demonstrates why and how Lefebvre's work can be used to inform and elaborate organisational studies, especially in view of the current interest in the "socio-material" dimension of organisations. As the "spatial turn" in organisational research exposed the importance of spatial design in inducing power and cultural relations, Lefebvre's perspective has become an inspiring, theoretical framework. However, *Organisational Space and Beyond* explores how Lefebvre's work could be of a much wider relevance, especially given his profound theoretical engagement with diverse schools of philosophical and sociological thought, including Nietzsche, Marx, Sartre and Foucault. This book brings together a range of authors that collectively develop a broader understanding of Lefebvre's relevance to organizational studies, including areas of management concern such as strategy and diversity studies, and ultimately draw on Lefebvre's work to rethink, reimagine and reshape scholarship in organisational studies. It will be of relevance to researchers, academics, students and organizational professionals in the fields of organisation studies, management studies, cultural studies, architecture and sociology.

Henri Lefebvre and Education

"That buildings are made of elements doesn't mean that architecture should be based on elementarism; on the contrary, we should strive for an architecture of continuity that fuses tectonics with textile, abstraction with empathy, and matter with expressivity." This is the crux of the argument Lars Spuybroek makes in this book, the first fully theoretical account of his innovative work. The state of contemporary architecture is the product of a 150-year battle between the Polytechnique and Beaux-Arts schools of design, which has forced us into a stalemate between the radically opposed positions of high-tech and sculpturism. Spuybroek aims to do no less than mend this rift through rethinking technology as an extension of our feeling senses, materiality as the realm of activity and agency, and structure as the result of genesis. Building on Gottfried Semper's materialist theory of architecture, he takes us from a philosophy of technology to a surprisingly historical argumentation that constantly revives the words of John Ruskin, William Hogarth and Wilhelm Worringer. Alongside a number of essays, the book contains extensive conversations in which we witness him refining and sharpening his arguments ("We will see a merging of Art Nouveau and Bauhaus, where empathy has been liberated from manual labor and machines have been liberated from uniform repetition"). In a period of theoretical tranquility in architecture, this book takes a refreshing turn back to the basics, one in which tools, methodology and architectural aesthetics are recalibrated.

A Table for One

What does it mean for human beings to exist in an era of dronified state violence? How can we understand the rise of robotic systems of power and domination? Focusing on U.S. drone warfare and its broader implications as no other book has to date, *Predator Empire* argues that we are witnessing a transition from a labor-intensive "American empire" to a machine-intensive "Predator Empire." Moving from the Vietnam War to the War on Terror and beyond, Ian G. R. Shaw reveals how changes in military strategy, domestic policing, and state surveillance have come together to enclose our planet in a robotic system of control. The rise of drones presents a series of "existential crises," he suggests, that are reengineering not only spaces of violence but also the character of the modern state. Instead of incarcerating us in prisons or colonizing territory directly, the Predator Empire locks us inside a worldwide system of electromagnetic enclosure—in which democratic ideals give way to a system of totalitarian control, a machinic "rule by Nobody." As accessibly written as it is theoretically ambitious, *Predator Empire* provides up-to-date information about U.S. drone warfare, as well as an in-depth history of the rise of drones.

Postmodern Geographies

Fun and Software offers the untold story of fun as constitutive of the culture and aesthetics of computing. Fun in computing is a mode of thinking, making and experiencing. It invokes and convolutes the question of rationalism and logical reason, addresses the sensibilities and experience of computation and attests to its creative drives. Fun is a form of production that touches on the foundations of formal logic and precise notation as well as rhetoric, exhibiting connections between computing and paradox, politics and aesthetics. From the formation of the discipline of programming as an outgrowth of pure mathematics to its manifestation in contemporary and contradictory forms such as gaming, data analysis and art, fun is a powerful force that continues to shape our life with software as it becomes the key mechanism of contemporary society. Including chapters from leading scholars, programmers and artists, *Fun and Software* makes a major contribution to the field of software studies and opens the topic of software to some of the most pressing concerns in contemporary theory.

Organisational Space and Beyond

This book offers a fundamental contribution to the literature on the creative industries and the knowledge-based economy by focusing on three aspects: urban spaces as key sites of capitalist restructuring, creative industries' policies as state technologies aimed at economic exploitation, and the role of networks of aesthetic production in inflecting these tendencies. It simultaneously goes beyond these debates by integrating a concern with the cultural and aesthetic dimensions of the creative

industries. As such, the book is relevant to researchers interested in the transdisciplinary project of a cultural political economy of creativity and urban change.

The Architecture of Continuity

Henri Lefebvre's three-volume *Critique of Everyday Life* is perhaps the richest, most prescient work by one of the twentieth century's greatest philosophers. The present study aims to rectify this by establishing which political-philosophical currents Marcos was exposed to during his formative years as a student at the National Autonomous University of Mexico, and then examining the Subcommander's discourse in order to ascertain the extent to which these persisted in his thinking years later. Concretely, what we discover is that in his youth Marcos was especially influenced by his reading of Louis Althusser, Michel Foucault, and Nicos Poulantzas, and that certain core components of their thinking helped to form, and indeed continued to inform, the Subcommander's political philosophy.
