Anatomy of Rebellion provides an understanding of four rebellions that will make clear the factors that are crucial in the development of other rebellions. Seeking a political pattern in the process of rebellion, Claude Welch, Jr., has investigated four large-scale rural uprisings that came close to becoming revolutions: the Taiping rebellion in China 1850-64, the Telengana uprising in India of 1946-51, the Mau Mau rebellion in Kenya of 1952-56, the Kwilu uprising in Zaire of 1963-65. Weaving the facts of these rebellions with theories about political violence, Welch follows the rebellions through the initial stages of discontent to the explosion of violence to the suppression of the uprisings. He then challenges explanations of political violence, both Marxist and non-Marxist, that other scholars have proposed. Rebellions have not been studied as thoroughly as the major successful revolutions, although the frequency of rebellions in the modern world is not likely to diminish. Rural dwellers' discontents are still clashing with central governments' ambitions; Anatomy of Rebellion clarifies how this volatile type of political violence occurs.

Preconditions of Revolution in Early Modern Europe

From 1795 through 1800, a series of revolts rocked Curaçao, a small but strategically located Dutch colony just off the South American continent. A combination of internal and external factors produced these uprisings, in which free and enslaved islanders particiapted with various objectives. A major slave revolt in August 1795 was the opening salvo for these tumultuous five years. While this revolt is a well-known episode in Curaçaoan history, its wider Caribbean and Atlantic context is much less known.

Connecting the achievements and failures of past revolutions to current political issues, Jonsson then situates our present moment in a long historical drama of popular unrest, making his book both a cultural history and a contemporary discussion about the fate of democracy in our globalized world.

In this stimulating study, Juan R. I. Cole challenges traditional elite-centered conceptions of the conflict that led to the British occupation of Egypt in 1882. For a year before the British intervened, Egypt's government and the country's influential European community had been locked in a struggle with the nationalist supporters of General Ahmad 'Urabi. The history of violence in England from the Jacobite uprising of 1715 to the Irish rebellion of 1798, taking in food riots, judicial murder, press-gangs, poaching, duelling and the military. The author also wrote "The Body Politic" and "Inside Right".

Rebellion and Revolution

When originally published in 1984, Revolutions and Rebellions in Afghanistan provided the first focused consideration of the 1978 Saur Revolution and the subsequent Soviet invasion and occupation of the country. Nearly four decades later, its conclusions remain crucial to understanding Afghanistan today. In this much-anticipated re-release, Revolutions and Rebellions in Afghanistan offers an opportunity for fresh insight into the antecedents of the nation's enduring conflicts. A new foreword by editors M. Nazif Shahrani and Robert L. Canfield contextualizes this collection, which relies on extensive fieldwork in the years leading up to the Soviet invasion. Specific tribal, ethnic, and gender groups are considered within the context of their region, and contributors discuss local responses to government decrees, Islamic-inspired grassroots activism, and interpretations of jihad outside of Kabul. Long recognized as a vital ethnographic text in Afghan studies, Revolutions and Rebellions in Afghanistan provides an extraordinary chance to experience the diversity of the Afghan people on the cusp of irrevocable change and to understand what they expected of the years ahead.

The Fourth Dimension of Warfare

1989 was one of the great Years of Revolution in history, and it was also the anniversary of many famous revolutions. As the world commemorated the two hundredth anniversary of the French Revolution, startling changes were occuring in an Eastern Europe whose political map had been drawn in the aftermath of the Second World War, the revolutionary consequences of which could hardly be imagined at its outbreak fifty years before in 1939. Although few of us can have expected to see the revolutionary changes of 1989 in our lifetime, it remains to be seen whether history will judge all of the upheavals in Eastern Europe as 'revolutions', or whether some will be categorized in later centuries as 'revolts', 'coups', 'failed revolutions', or indeed 'counter-revolutions'. The distinguished contributors to this volume, published in the Wolfson College Lectures series, enjoy the advantage of historical perespective regarding past revolutions and counter-revolutions. Their papers present a wide-ranging analysis both of the concepts of revolution and counter-revolution, and of particular upheavals of vastly different character.
