She highlights the forces that have shifted what we think of as masculine and feminine, delving into everything from clothing to psychology, history to neuroscience, and the connection between tomboyism, gender identity, and sexuality. Above all else, Davis's comprehensive deep-dive inspires us to better appreciate those who defy traditional gender boundaries, and the incredible people they become. ## Geneva Sommers and the Quest for Truth

Mental disorders arise from neural and psychological mechanisms that have been built and shaped by natural selection across our evolutionary history. Looking at psychopathology through the lens of evolution is the only way to understand the deeper nature of mental disorders and turn a mass of behavioral, genetic, and neurobiological findings into a coherent, theoretically grounded discipline. The rise of evolutionary psychopathology is part of an exciting scientific movement in psychology and medicine -- a movement that is fundamentally transforming the way we think about health and disease. *Evolutionary Psychopathology* takes steps toward a unified approach to psychopathology, using the concepts of life history theory -- a biological account of how individual differences in development, physiology and behavior arise from tradeoffs in survival and reproduction -- to build an integrative framework for mental disorders. This book reviews existing evolutionary models of specific conditions and connects them in a broader perspective, with the goal of explaining the large-scale patterns of risk and comorbidity that characterize psychopathology. Using the life history framework allows for a seamless integration of mental disorders with normative individual differences in personality and cognition, and offers new conceptual tools for the analysis of developmental, genetic, and neurobiological data. The concepts presented in *Evolutionary Psychopathology* are used to derive a new taxonomy of

mental disorders, the Fast-Slow-Defense (FSD) model. The FSD model is the first classification system explicitly based on evolutionary concepts, a biologically grounded alternative to transdiagnostic models. The book reviews a wide range of common mental disorders, discusses their classification in the FSD model, and identifies functional subtypes within existing diagnostic categories.

### Evolutionary Psychopathology

Masculinity without men. In *Female Masculinity* Judith Halberstam takes aim at the protected status of male masculinity and shows that female masculinity has offered a distinct alternative to it for well over two hundred years. Providing the first full-length study on this subject, Halberstam catalogs the diversity of gender expressions among masculine women from nineteenth-century pre-lesbian practices to contemporary drag king performances. Through detailed textual readings as well as empirical research, Halberstam uncovers a hidden history of female masculinities while arguing for a more nuanced understanding of gender categories that would incorporate rather than pathologize them. She rereads Anne Lister's diaries and Radclyffe Hall's *The Well of Loneliness* as foundational assertions of female masculine identity. She considers the enigma of the stone butch and the politics surrounding butch/femme roles within lesbian communities. She also explores issues of transsexuality among "transgender dykes"--lesbians who pass as men--and female-to-male transsexuals who may find the label of "lesbian" a temporary refuge. Halberstam also tackles such topics as women and boxing, butches in Hollywood and independent cinema, and the phenomenon of male impersonators. *Female Masculinity* signals a new understanding of masculine behaviors and identities, and a new direction in interdisciplinary queer scholarship. Illustrated with nearly forty photographs, including portraits, film stills, and drag king performance shots, this book provides an extensive record of the wide range of female masculinities. And as Halberstam clearly demonstrates, female masculinity is not some bad imitation of virility, but a lively and dramatic staging of hybrid and minority genders.

The Act protects you from discrimination, harassment and victimisation in different places such as:

at work, school, housing

Direct discrimination means treating one person worse than another because of a protected characteristic

For example, if you are refused access to a public service, such as a nightclub, because you are disabled

Indirect discrimination happens when a practice, policy or rule applies to everyone, but it has a worse effect on people who share a protected characteristic

For example, if a school had a rule against afro hairstyles, this could be indirect discrimination

because of race.

The Act also protects you from harassment. Harassment, including sexual harassment, occurs when unwanted behaviour related to a protected characteristic violates your dignity or creates an intimidating, degrading, hostile, offensive or humiliating environment for you.

However, it doesn't necessarily need to relate to your own protected characteristic. For example, you could be harassed because of jokes about gender reassignment even though you are not transgender yourself.

If you are making a complaint of discrimination or supporting someone who is, then you are also protected from victimisation. This means that people cannot treat you unfairly.

For example, if you were dismissed from your job because you made a complaint about sexual harassment at work, this would be victimisation.

If you are disabled, you have more rights, such as the right to reasonable adjustments. You can find out more about this and other important sections of the Equality Act through our website or our other videos.

## The Human Rights Watch Global Report On Women`s Human Rights

Human rights refers to the concept of human beings as having universal rights, or status, regardless of legal jurisdiction, and likewise other localising factors, such as ethnicity and nationality. For many, the concept of "human rights" is based in religious principles. However, because a formal concept of human rights has not been universally accepted, the term has some degree of variance between its use in different local jurisdictions -- difference in both meaningful substance as well as in protocols for and styles of application. Ultimately the most general meaning of the term is one which can only apply universally, and hence the term "human rights" is often itself an appeal to such transcended principles, without basing such on existing legal concepts. The term "humanism" refers to the developing doctrine of such universally applicable values, and it is on the basic concept that human beings have innate rights, that more specific local legal concepts are often based. Within particular societies, "human rights" refers to standards of behaviour as accepted within their respective legal systems regarding 1) the well being of individuals, 2) the freedom and autonomy of individuals, and 3) the representation of the human interest in government. These rights commonly include the right to life, the right to an adequate standard of living, the prohibition of genocide, freedom from torture and other mistreatment,



freedom of expression, freedom of movement, the right to self-determination, the right to education, and the right to participation in cultural and political life. These norms are based on the legal and political traditions of United Nations member states and are incorporated into international human rights instruments. ### Human Rights

The emergence of global governance in several key areas calls into question conventional understandings of world politics in terms of conflicts of interests between sovereign states under conditions of anarchy. At the same time the new phenomena of anti-globalisation demonstrations, transnational social movements and an emergent global civil society point to important developments in international relations. ### Sharpened Edge

This study is a critique of the institutional structures and cultural dynamics that pose obstructions to U.S. ratification. The United States is a liberal democratic state founded upon ideals of freedom and equality, thus the history of non-ratification of major international human rights treaties appears to be an anomaly. This book suggests that it is not. Liberal democracy, as it was conceived and has developed in the United States, is problematic as a model in the globalization of concern for women's human rights. This study is not a comparative examination of state exclusion and oppression of women. Neither is it an attempt to distinguish the United States in the larger sense from other Western liberal democratic regimes in its treatment of women. Rather, the study is a gender-sensitive examination of specific dynamics and characteristics inherent to the socio-political, economic, and legal systems of the United States which have precluded incorporation of the rights of women on an equal basis with the rights of men. The interaction of these dynamics and characteristics describes a uniquely American view of itself and its own history which serves to render the U.S. system troublesome as an exemplar for state

incorporation of the human rights of women. Unreserved ratification of CEDAW constitutes a strong indication of effort, by the ratifying state, to protect the human rights of women. The United States has refused to ratify CEDAW.

Sexual Harassment of Women

#### Russian Education and Society

This collection of essays addresses the challenge of modern nationalism to the tsarist Russian Empire. First appearing on the empire's western periphery this challenge, was most prevalent in twelve provinces extending from Ukrainian lands in the south to the Baltic provinces in the north, as well as to the Kingdom of Poland. At issue is whether the late Russian Empire entered World War I as a multiethnic state with many of its age-old mechanisms run by a multiethnic elite, or as a Russian state predominantly managed by ethnic Russians. The tsarist vision of prioritizing loyalty among all subjects over privileging ethnic Russians and discriminating against non-Russians faced a fundamental problem: as soon as the opportunity presented itself, non-Russians would increase their demands

and become increasingly separatist. The authors found that although the imperial government did not really identify with popular Russian nationalism, it sometimes ended up implementing policies promoted by Russian nationalist proponents. Matters addressed include native language education, interconfessional rivalry, the "Jewish question," the origins of mass tourism in the western provinces, as well as the emergence of Russian nationalist attitudes in the aftermath of the first Russian revolution.

### The Tsar, The Empire, and The Nation

Russian historiography has focused on the power of the central state. The national historiographies of the peoples that were once part of the empire, on the other hand, concentrate on their own nation, and the empire for them is only a burdensome context in which a particular nation was "waking up," and fighting for independence. Miller addresses the fabric of interaction between the imperial authority and local communities in the Romanov empire. How did the authorities structure the space of the empire? What were the economic relations between the borderlands and the centre? How was the use of different languages regulated? How did the central authorities and local officials implement policies regarding different population groups? How did the experience, acquired in particular borderlands, influence the policies elsewhere--among others--through officials who often changed their place of service during their careers? How did the local elites and communities react to the policies of the imperial authorities? How did they uphold their special interests if the empire encroached on them, but also--how did they collaborate with the empire and how did they use imperial resources for local interests?

### The Romanov Empire and Nationalism

With the ever dominating subject of nation-state formation receding, a new scope for considering empires as the much longer and pervasive alternative in European history opens up. ### Comparing Empires

In *Children of Rus'*, Faith Hillis recovers an all but forgotten chapter in the history of the tsarist empire and its southwestern borderlands. The right bank, or west side, of the Dnieper River—which today is located at the heart of the independent state of Ukraine—was one of the Russian empire's last territorial acquisitions, annexed only in the late eighteenth century. Yet over the course of the long nineteenth century, this newly acquired region nearly a thousand miles from Moscow and St. Petersburg generated a powerful Russian nationalist movement. Claiming to restore the ancient customs of the East Slavs, the southwest's Russian nationalists sought to empower the ordinary Orthodox residents of the borderlands and to diminish the influence of their non-Orthodox minorities. Right-bank Ukraine would seem unlikely terrain to nourish a Russian nationalist imagination. It was among the empire's most diverse corners, with few of its residents speaking Russian as their native language or identifying with the culture of the Great Russian interior. Nevertheless, as Hillis shows, by the late nineteenth century, Russian nationalists had established a strong foothold in the southwest's culture and educated society; in the first decade of the twentieth, they secured a leading role in local mass politics. By 1910, with help from sympathetic officials in St. Petersburg, right-bank activists expanded their sights beyond the borderlands, hoping to spread their nationalizing agenda across the empire. Exploring why and

how the empire's southwestern borderlands produced its most organized and politically successful Russian nationalist movement, Hillis puts forth a bold new interpretation of state-society relations under tsarism as she reconstructs the role that a peripheral region played in attempting to define the essential characteristics of the Russian people and their state.

### Children of Rus'

The essays in *Nationalizing Empires* challenge the dichotomy between empire and nation state that for decades has dominated historiography. The authors center their attention on nation-building in the imperial core and maintain that the nineteenth century, rather than the age of nation-states, was the age of empires and nationalism. They identify a number of instances where nation building projects in the imperial metropolis aimed at the preservation and extension of empires rather than at their dissolution or the transformation of entire empires into nation states. Such observations have until recently largely escaped theoretical reflection.

### Nationalizing Empires

Renowned academics compare major features of imperial rule in the 19th century, reflecting a significant shift away from nationalism and toward empires in the studies of state building. The book responds to the current interest in multi-unit formations, such as the European Union and the expanded outreach of the United States. National historical narratives have systematically marginalized imperial dimensions, yet empires play an important role. This book examines the methods discerned in the creation of the Habsburg Monarchy, the Ottoman Empire, the Hohenzollern rule and Imperial Russia. It inspects the respective imperial elites in these empires, and it details the role of nations, religions and ideologies in the legitimacy of empire building, bringing the Spanish Empire into the analysis. The final part of the book focuses on modern empires, such as the German "Reich." The essays suggest that empires were more adaptive and resilient to change than is commonly thought.

### Imperial Rule

Focusing on the Tsarist and Soviet empires of Russia, Lieven reveals the nature and meaning of all empires throughout history. He examines factors that mold the shape of the empires, including geography and culture, and compares the Russian empires with other imperial states, from ancient China and Rome to the present-day United States. ### Empire

Combining the talents and expert knowledge of an early modern historian of Russia and of a Soviet specialist, 'Russia's Empires' is a major study of the entire sweep of Russian history from its earliest formations to the rule of Vladimir Putin. Looking through the lens of empire, which the authors conceptualise as a state based on institutionalised differentiation, inequitable hierarchy, and bonds of reciprocity between ruler and ruled, Kivelson and Suny displace the centrality of nation and nationalism in the Russian and Soviet story.

### Russia's Empires

This pioneering work treats the Ukrainian question in Russian imperial policy and its importance for the intelligentsia of the empire. This territorial expansion evolved into a competition of mutually exclusive concepts of Russian and Ukrainian nation-building projects.

### The Ukrainian Question

If one were to pick a single explanation for the fall of the tsarist and Soviet empires, it might well be Russia's inability to achieve a satisfactory relationship with non-Russian nationalities. Perhaps no other region demonstrates imperial Russia's "national dilemma" better than the western provinces and Kingdom of Poland, an extensive area inhabited by a diverse group of nationalities, including Poles, Jews, Ukrainians, Belorussians, Russians, and Lithuanians. Taking an in-depth look at this region during an era of intensifying national feeling, Weeks shows that the Russian government, even at the height of its empire, never came to terms with the question of nationality. Drawing upon little-known

Russian and Polish archives, Weeks challenges widely held assumptions about the "national policy" of late imperial Russia and provides fresh insights into ethnicity in Russia and the former Soviet Union. He demonstrates that, rather than pursuing a plan of "russification," the tsarist government reacted to situations and failed to initiate policy. In spite of the Russians' great distrust of certain minority nationalities--especially Jews and Poles--the ruling elite was equally uncomfortable with the modern nationalism, even in its Russian form. Weeks demonstrates Russia's unwillingness (or inability) to use nationalistic policies to save the empire by examining its dilatory and contradictory actions regarding efforts to institute reforms in the western lands.
