For better or for worse, the often-disparaged politics of multiculturalism are here to stay, with profound implications for America's democracy. Americans have now entered a post-multiculturalist settlement in which the renewal of democracy continues to depend on groups battling it out in political trenches, yet the process is ruled by a newly invigorated and strengthened state. But Americans' resolute embrace of their distinctive identities has ramifications not just internally and domestically but on the world stage as well. The image of one-people American nationhood so commonly projected abroad camouflages the country's sprawling, often messy diversity: a lesson that nation-builders worldwide cannot afford to ignore as they attempt to accommodate ever-evolving group needs and the demands of individuals to be treated equally. Spanning the entire twentieth century and encompassing immigration policies, the nationalistic fallout from both world wars, the civil rights movement, and nation-building efforts in the postcolonial era, *The Liberty of Strangers* advances a major new interpretation of American nationalism and the future prospects for diverse democracies.

the body in comedy, the landscape in the western, and the face in melodrama. At the same time, it helped produce a new idea of character, embodied in the American movie star. Cohen's book offers a fascinating new perspective on American cultural history. It shows how nineteenth-century literature can be said to anticipate twentieth-century film--how Douglas Fairbanks was, in a sense, successor to Walt Whitman. And rather than condemning the culture of celebrity and consumption that early Hollywood helped inspire, the book highlights the creative and democratic features of the silent-film ethos. Just as notable, Cohen champions the concept of the "American myth" in the wake of recent attempts to discredit it. She maintains that American silent film helped consolidate and promote a myth of possibility and self-making that continues to dominate the public imagination and stands behind the best impulses of our contemporary world.

## Hmong and American

*Killing the Indian Maiden* examines the fascinating and often disturbing portrayal of Native American women in film. Through discussion of thirty-four Hollywood films from the silent period to the present, M. Elise Marubbio examines the sacrificial role of what she terms the "Celluloid Maiden" -- a young Native woman who allies herself with a white male hero and dies as a result of that choice. Marubbio intertwines theories of colonization, gender, race, and film studies to ground her study in sociohistorical context all in an attempt to define what it means to be an American. As Marubbio charts the consistent depiction of the Celluloid Maiden, she uncovers two primary characterizations -- the Celluloid Princess and the Sexualized Maiden. The archetype for the exotic Celluloid Princess appears in silent films such as Cecil B. DeMille's *The Squaw Man* (1914) and is thoroughly established in American iconography in Delmer Daves's *Broken Arrow* (1950). Her more erotic sister, the Sexualized Maiden, emerges as a femme fatale in such films as DeMille's *North West Mounted Police* (1940), King Vidor's *Duel in the Sun* (1946), and Charles Warren's *Arrowhead* (1953). The two characterizations eventually combine to form a hybrid Celluloid Maiden who first appears in John Ford's *The Searchers* (1956) and reappears in the 1970s and the 1990s in such films as Arthur Penn's *Little Big Man* (1970) and Michael Apted's *Thunderheart* (1992). *Killing the Indian Maiden* reveals a cultural iconography about Native Americans and their role in the frontier embedded in the American psyche. The Native American woman is a racialized and sexualized other -- a conquerable body representing both the seductions and the

dangers of the frontier. These films show her being colonized and suffering at the hands of Manifest Destiny and American expansionism, but Marubbio argues that the Native American woman also represents a threat to the idea of a white America. The complexity and longevity of the Celluloid Maiden icon -- persisting into the twenty-first century -- symbolizes an identity crisis about the composition of the American national body that has played over and over throughout different eras and political climates. Ultimately, Marubbio establishes that the ongoing representation of the Celluloid Maiden signals the continuing development and justification of American colonialism.

America is enormous: the third largest country in the world with a population of more than 300 million people.

Americans come in all colors, have all types of religions, and speak many languages from all over the world.

Americans are extremely independent, individualistic, and like to be different from each other.

66% of Americans are overweight; 37% of those are obese.

Americans believe in freedom of choice.

Americans need a lot of "elbow room", they like personal space around them.

Approximately 1% of Americans are homeless (3.5 million people).

Americans talk easily to the homeless but use good judgment and are careful with whom they talk.

Sadly, the streets of major cities are often dirty.

Many people, especially teenagers, wear strange clothes, and many have tattoos and body piercings

Americans follow the rule of law.

Littering (throwing garbage on the street), graffiti and tagging (writing on the walls), and loitering (standing around and doing nothing) are against the law and are punishable by a fine or jail.

Discriminating against or making any insulting statement about someone else's religion or ethnicity is against the law and could be punishable as a hate crime.

You must be over the age of 21 and you must have an identification card, with a photo to buy or drink alcohol.

In most states, it is illegal to buy cigarettes if you are under the age of 18 and often you can only smoke in certain places.

Americans are extremely informal and call most people by their first name or nickname.

Americans smile a lot and talk easily to strangers, sharing personal stories.

Asking "How are you?" is simply a greeting and is not a question about your health.

When Americans put their hands on their hips, they are usually relaxed; when they fold their arms tightly across their chests, they are angry or very serious (or cold). Americans don't push or stand too close to anyone in line. They always wait their turn. In a restaurant, the server is usually very friendly and helpful and often will tell you his or her name. When the service is good, tipping is expected to be 15-20% of the bill. Polite Americans eat with one hand while the other one is under the table on their laps. Usually, when friends meet at a restaurant they each pay their share of the bill or split the bill in half. It's called going Dutch.

If you have guests over to your house, turn off the television, make sure your music isn't too loud. Americans have parties for many reasons. Sometimes they are held for friends to get together and to meet new people.

26. There is rarely music or dancing at a typical American party. When you meet Americans, be sure to look them in the eye, smile, and shake hands. Make small talk at the beginning of a conversation. After a few questions, you will be asked, "What do you do?" (This means what is your job?)

For weddings and showers, people register for gifts at a specific place. Americans open presents and cards in front of people. Be sure you include a card with your gift. The person given the gift will send you a thank you card. At an American funeral, it is not normal to make loud sad sounds. Americans try to keep strong emotions inside. There is no traditional color or flower that symbolizes death. Any and all flowers can be used at funerals. We do not give money at a funeral. Sometimes, we send flowers or plants to the ceremony. After the funeral, there is usually a reception at the home of the family. There is usually a lot of food and sometimes alcohol. Do not make any racist or negative remarks about someone's religion, family background, or sexual preferences. Men should not make any "sexist" remarks to or about women anything that would make women unequal to men. Americans say that they don't want to talk about politics, but sometimes they do. Never go to someone's house without calling first to see if it is convenient. If you are invited to an American party, do not bring your children, friends, or family members without first asking the permission of the host. Time is money. Never be late to classes, employment interviews, appointments, parties (especially your wedding!), etc. Some Americans hug a lot. It is okay for women and men to hug even if they are not close friends. It is normal for American women to have male friends who are just friends (and vice versa). It is not uncommon for American men and women to share an apartment as roommates and not have a sexual relationship with each other. Most American women do not like possessive or jealous men. Most American women do not feel comfortable having the man pay for everything all of the time. Be careful: Meet new friends in a public place many times before you get into a car or give out your address. American parents speak to their children as adults and teach them how to be responsible for their actions. American parents encourage their children to question and always ask "Why?"

### John Morley and the Uses of History in Victorian Liberal Culture

In his ambitious study of John Morley (1838-1923), Marco de Waard retrieves the literary critic and intellectual historian's status as a prolific and versatile man of letters whose influence reshaped the nineteenth century's liberal culture of the past from the 1860s onwards. At the same time, by situating Morley's work in its many contexts, from the religious to the professional, de Waard uses Morley to explore the ways in which a distinctly nineteenth-century vision and practice of history helped transform Britain into a modern liberal culture and refashioned its identity as a liberal nation-state. Based on extensive archival research, de Waard's study combines a biographical framework with a close and historically informed analysis of John Morley's work and ideas. He pays strategic attention to Morley's relations with leading philosophers of the period like Auguste Comte, John Stuart Mill, and Herbert Spencer; to his friendships with Leslie Stephen, Mark Pattison, George Meredith, and T. H. Huxley, and to his vigorous polemics with contemporaries such as Thomas Carlyle, Matthew Arnold, A. C. Swinburne, and Hippolyte Taine. Chapters focus on Morley's activities as critic and editor of the influential *Fortnightly Review*; on his ambitious studies of French Enlightenment philosophers; on his use of popular, didactic biographies to promote a progressive and democratic understanding of Britain's national past; and on his work as an historian of contemporary politics who cast a peaceable solution to the 'Irish question' as the test case of a modern liberal polity. Significantly, de Waard locates Morley's work squarely in the British utilitarian tradition and challenges the pervasive idea that from c. 1860, the narrative histories of the early-Victorian period were replaced by more specialised and academic forms of historical writing.

### Liberal Intellectuals and Public Culture in Modern Britain, 1815-1914

Public life in Great Britain underwent a major transformation after the repeal of the Test and Corporation Acts in 1828 and the passage of the Catholic Relief Act of 1829, which eliminated the requirement that men in public positions swear to uphold the doctrines of the Anglican Church. According to Lubenow (Stockton College), these legislative changes initiated a fundamental reallocation of power, opening many careers to men of talent and educational qualifications, including those whose perspectives and intellectual dispositions led them to question the validity of uniform religious dogma. Lubenow identifies members of the Benson, Strachey, Balfour, Lyttelton, and Sitwell families among the "Men of Letters" who epitomized the 19th century's new secular meritocracy, noting that when religious uniformity was removed as a requirement for positions in the public sphere, religion became more important, if more fluid, in the lives of such Britons. Thus, men of intellectual merit, rather than only those from the more conservative landowning or military traditions, were able to rise in politics, civil service, the clergy, the professions, and the universities, taking their liberal values regarding liberty, moral cultivation, and philosophy into the wider public sphere. ### Speculative Biography

While speculation has always been crucial to biography, it has often been neglected, denied or misunderstood. This edited collection brings together a group of international biographers to discuss how, and why, each uses speculation in their work; whether this is to conceptualise a project in its early stages, work with scanty or deliberately deceptive sources, or address issues associated with shy or stubborn subjects. After defining the role of speculation in biography, the volume offers a series of work-in-progress case studies that discuss the challenges biographers encounter and address in their work. In addition to defining the 'speculative spectrum' within the biographical endeavour, the collection offers a lexicon of new terms to describe different types of biographical speculation, and more deeply engage with the dynamic interplay between research, subjectivity and that which Natalie Zemon Davis dubbed 'informed imagination'. By mapping the field of speculative biography, the collection demonstrates that speculation is not only innate to biographical practice but also key to rendering the complex mystery of biographical subjects, be they human, animal or even metaphysical.

### Ruskin's Culture Wars

In Ruskin's Culture Wars, Judith Stoddart provides the first sustained modern critical reading of *Fors Clavigera*, placing this classic work in the context of its Victorian contemporaries: art journals, liberal and working-class periodicals, and popular criticism. In recreating the intellectual climate, she demonstrates the sense of cultural crisis and change evident at the time. Rebelling against the tendency to treat Ruskin's letters as the prose lyric of a damaged psyche, Stoddart shows how the cumulative text of *Fors Clavigera* not only records but revises and redirects the preoccupations of his period. He was an integral part of Victorian discussions of literary tradition and of the roles of democracy and nationality in late-nineteenth-century Europe.

### Edmund Burke and the Invention of Modern Conservatism, 1830-1914

Between 1830 and 1914 in Britain a dramatic modification of the reputation of Edmund Burke (1730-1797) occurred. Burke, an Irishman and Whig politician, is now most commonly known as the "founder of modern conservatism" - an intellectual tradition which is also deeply connected to the identity of the British Conservative Party. The idea of "Burkean conservatism"--a political philosophy which upholds "the authority of tradition," the organic, historic conception of society, and the necessity

of order, religion, and property--has been incredibly influential both in international academic analysis and in the wider political world. This is a highly significant intellectual construct, but its origins have not yet been understood. This volume demonstrates, for the first time, that the transformation of Burke into the "founder of conservatism" was in fact part of wider developments in British political, intellectual, and cultural history in the nineteenth and early twentieth centuries. Drawing from a wide range of sources, including political texts, parliamentary speeches, histories, biographies, and educational curricula, *Edmund Burke and the Invention of Modern Conservatism* shows how and why Burke's reputation was transformed over a formative period of British history. In doing so, it bridges the significant gap between the history of political thought as conventionally understood and the history of the making of political traditions. The result is to demonstrate that, by 1914, Burke had been firmly established as a "conservative" political philosopher and was admired and utilized by political Conservatives in Britain who identified themselves as his intellectual heirs. This was one essential component of a conscious re-working of C/conservatism which is still at work today.

It demonstrates how John Stuart Mill, in particular, was combined with Marx in Britain; it illuminates other liberal influences which help to explain the sectarian attitude adopted by the Social Democratic Federation towards organised labour; and it establishes an alternative genealogy for Fabian socialism.

#### Suffrage and Beyond

The 1980s and 1990s have seen an unprecedented emphasis on global feminism, on the connectedness of women regardless of race, class, or geography. And yet, the status and position of women throughout the world remains enormously disparate. ### Primitive Marriage

Marriage is the novel's traditional subject matter. But what happens to the novel when another genre of writing lays claim to the novel's traditional material? *Primitive Marriage: Victorian Anthropology, the Novel, and Sexual Modernity* shows how the foundational ideas of the new discipline of anthropology gave late-Victorian novelists and social scientists ways of rethinking heterosexual romance by referring to a new kind of history, one in which marriage systems, sexual behavior, and reproductive practices were temporalized and given historical agency. Temporalizing sexual relations, locating them in evolutionary and historical time, anthropologists and the novelists who wrote after them began to think modernity in sexual terms. This transformation of politics into sexual politics put sexuality and gender at the center of liberal stories of progress. The Victorian theorists responsible for this transformation—from well-known figures like Charles Darwin and Sigmund Freud to lesser-known writers like John McLennan and Henry Maine—and the novelists who engaged them—Anthony Trollope, George Eliot, Henry James, Sarah Grand, H. Rider Haggard, Thomas Hardy—not only helped produce sexually modern subjects, but also the theories about sexuality, time, and politics that we still draw upon to think modernity today.

### The Organisation of Knowledge in Victorian Britain

This collection of essays explores the questions of what counted as knowledge in Victorian Britain, who defined knowledge and the knowledgeable, by what means and by what criteria. During the Victorian period, the structure of knowledge took on a new and recognizably modern form, and the disciplines we now take for granted took shape. The ways in which knowledge was tested also took on a new form, with the rise of written examinations. New institutions of knowledge were created: museums were important at the start of the period, universities had become prominent by the end. Victorians needed to make sense of the sheer scale of new information, to popularize it, and at the same time to exclude ignorance and error - a role carried out by encyclopaedias and popular publications. By studying the Victorian organization of knowledge in its institutional, social, and intellectual settings, these essays contribute to our wider consideration of the complex and much debated concept of knowledge.

### British Liberal Internationalism, 1880-1930

Faith in progress is a characteristic we often associate with the Victorian era. Victorian intellectuals and free-thinkers who believed in progress and wrote history from a progressive point of view--men such as Leslie Stephen, John Morley, W. E. H. Lecky, and James Anthony Froude--are usually thought to have done so because they were optimistic about their own times. Their optimism has been seen as the result of a successful Liberal campaign for political reform in the sixties and seventies, carried out in alliance with religious dissenters--a campaign that removed religion from the arena of public debate. Jeffrey Paul von Arx challenges this long-standing view of the Victorian intellectual aristocracy. He sees them as preoccupied with and even fearful of a religious resurgence throughout their careers, and demonstrates that their loss of confidence in contemporary liberalism began with their disillusionment over the effects of the Franchise Reform Act of 1867. He portrays their championing of the idea of progress as motivated not by optimism about the present, but by their desire to explain away and reverse if possible contemporary religious and political trends, such as the new mass politics in England and Ireland. This is the first book to explore how pessimism could be the psychological basis for the Victorians' progressive conception of history. Throughout, von Arx skillfully interweaves threads of religion, politics, and history, showing how ideas in one sphere cannot be understood without reference to the others.

Far be it from us to say anything against fishing, lawfully practised in any form but many pent up in our large towns will bear us out when we say that, on the whole, a days loch-fishing is the most convenient. One great matter is, that the loch-fisher is dependent on nothing but enough wind to curl the water, -and on a large loch it is very seldom that a dead calm prevails all day, -and can make his arrangements for a day, weeks beforehand whereas the stream-fisher is dependent for a good take on the state of the water and however pleasant and easy it may be for one living near the banks of a good trout stream or river, it is quite another matter to arrange for a days river-fishing, if one is looking forward to a holiday at a date some weeks ahead. Providence may favour the expectant angler with a good day, and the water in order but experience has taught most of us that the good days are in the minority, and that, as is the case with our rapid running streams, -such as many of our northern streams are, -the water is either too large or too small, unless, as previously remarked, you live near at hand, and can catch it at its best. A common belief in regard to loch-fishing is, that the tyro and the experienced angler have nearly the same chance in fishing, -the one from the stern and the other from the bow of the same boat. Of all the absurd beliefs as to loch-fishing, this is one of the most absurd. Try it. Give the tyro either end of the boat he likes give him a cast of ally flies he may fancy, or even a cast similar to those which a crack may be using and if he catches one for every three the other has, he may consider himself very lucky. Of course there are lochs where the fish are not abundant, and a beginner may come across as many as an older fisher but we speak of lochs where there are fish to be caught, and where each has a fair chance. Again, it is said that the boatman has as much to do with catching trout in a loch as the angler. Well, we don't deny that. In an untried loch it is necessary to have the guidance of a good boatman but the same argument holds good as to stream-fishing...

In the mid-Victorian era, liberalism was a practical politics: it had a party, it informed legislation, and it had adherents who identified with and expressed it as opinion. It was also the first British political movement to depend more on people than property, and on opinion rather than interest. But how would these subjects of liberal politics actually live liberalism? To answer this question, Elaine Hadley focuses on the key concept of individuation—how it is embodied in politics and daily life and how it is expressed through opinion, discussion and sincerity. These are concerns that have been absent from commentary on the liberal subject. *Living Liberalism* argues that the properties of liberalism—citizenship, the vote, the candidate, and reform, among others—were developed in response to a chaotic and antagonistic world. In exploring how political liberalism imagined its impact on Victorian society, Hadley reveals an entirely new and unexpected prehistory of our modern liberal politics. A major revisionist account that alters our sense of the trajectory of liberalism, *Living Liberalism* revises our understanding of the presumption of the liberal subject.

### Reordering the World

Before about 1840, there was little prestige attached to the writing of novels, and most English novelists were women. By the turn of the twentieth century, "men of letters" acclaimed novels as a form of great literature, and most critically successful novelists were men. In the book, sociologist Gaye Tuchman examines how men succeeded in redefining a form of culture and in invading a white-collar occupation previously practiced mostly by women. Tuchman documents how men gradually supplanted women as novelists once novel-writing was perceived as potentially profitable, in part because of changes in the system of publishing and rewarding authors. Drawing on unusual data ranging from the archives of Macmillan and company (London) to an analysis of the lives and accomplishments of authors listed in the *Dictionary of National Biography*, she shows that rising literacy and the centralization of the publishing industry in London after 1840 increased literary opportunities and fostered men's success as novelists. Men redefined the nature of a good novel and applied a double standard in critically evaluating literary works by men and by women. They also received better contracts than women for novels of equivalent quality and sales. They were able to accomplish this, says Tuchman, because they were to a large extent the culture brokers – the publishers, publishers' readers, and reviewers of an elite art form. Both a sociological study of occupational gender transformation and a historical study of writing and publishing, this book will be a rich resource for students of the sociology of culture, literary criticism, and women's studies.
