The price we pay for the new strategies in database marketing that closely track desirable customers, offering them benefits in return for personal information. We have all been to Web sites that welcome us by name, offering us discounts, deals, or special access to content. For the most part, it feels good to be wanted—to be valued as a customer. But if we thought about it, we might realize that we've paid for this special status by turning over personal information to a company's database. And we might wonder whether other customers get the same deals we get, or something even better. We might even feel stirrings of resentment toward customers more valued than we are. Robles deftly demonstrates Mexico's role in creating the borderlands, adding texture and depth to the story. Scholars and students of radio, Spanish-language media in the United States, communication studies, Mexican history, and border studies will see how Mexican radio shaped the region's development and how transnational listening communities used broadcast media's unique programming to carve out a place for themselves as consumers and citizens of Mexico and the United States.

Journalism and Truth in an Age of Social Media

Truth qualities of journalism are under intense scrutiny in today's world. Journalistic scandals have eroded public confidence in mainstream media while pioneering news media compete to satisfy the public's appetite for news. Still worse is the specter of "fake news" that looms over media and political systems

that underpin everything from social stability to global governance. This volume aims to illuminate the contentious media landscape to help journalism students, scholars, and professionals understand contemporary conditions and arm them to deal with a spectrum of new developments ranging from technology and politics to best practices. Fake news is among the greatest of these concerns, and can encompass everything from sarcastic or ironic humor to bot-generated, made-up stories. It can also include the pernicious transmission of selected, biased facts, the use of incomplete or misleadingly selective framing of stories, and photographs that editorially convey certain characteristics. This edited volume contextualizes the current "fake news problem." Yet it also offers a larger perspective on what seems to be uniquely modern, computer-driven problems. This book explores the features and implications of content that blends, merges and disguises material that is sponsored with material that is or appears to be independent editorial. The chapters range across countries and regions from China and Israel to Europe and North America. Following a general introduction, authors address political and commercial sponsorship across production, content and audience research, developing and combining these in innovative ways to advance the study of paid-for content in contemporary digital journalism. Animation and Advertising

Later in 1934 Hazrat Mirza Bashiruddin Mahmud Ahmad (r.a.) inaugurated Tahrik-e-Jadid to prepare the ground for the full implementation of the New World Order of the institution of Wasiyyat. In the present lecture he elaborates the aims and objectives of Tahrik-e-Jadid and claims that the New World Order in all its aspects, economic, social and religious, as introduced by Nizam-e-Wassiyat, will at the end prevail and a new and genuine revolution will take place.

The New World Order

My study of Islam is joined to a quest for truth that has been my companion from an early age. Even then it caused me to bite the many hands that fed me, hence, certain persons mentioned herein are subject to this beleaguering habit for which I apologize but without regret. I have done so because during the course of ceaseless studies I encountered contradictions in deed and doctrine for which no other remedy is possible, especially in light of the command given to Muslims to right that which is wrong and treat the enemies of Islam as such whenever possible. And though I have some reservations as I am yet a novice in the school of Islam's wisdom, I make this offering.

A History of Islam in America

Since the end of the Cold War and the 1990/91 Gulf war, the Middle East has been in the grip of dramatic changes. The region faces a host of problems urgently in need of solutions if a successful new world order is to be built on the ruins of the old. In this book, an international group of scholars addresses these issues and considers the options for the political and economic reconstruction of the Middle East. Themes covered include: democratization; the Arab state system in the new global environment; the end of Marxism in the Middle East; security structures; the Arab-Israeli conflict; the role of pan-Islamism and pan-Arabism; and the prospects for economic revival. Case-studies are drawn from the whole region, from North Africa to the Arabian Peninsula.

The cover image, "The Arrival of the Dutch at Patane," from Theodore de Bry, India Orientals, Part VIII (Frankfurt: W. Richteri, 1607) depicts the two key phases of global history that are covered by the essays. Muslim inhabitants of the town of Patane on the Malayan peninsula warily confront a Dutch landing party whose bearing

suggests that it is engaged in yet another episode in the saga of European overseas exploration and discovery. The presence of the Muslims in Malaya reflects an earlier process of expansion that saw Islamic civilization spread from Spain and Morocco in the west to the Philippines in the east in the millennium between the 7th and 17th centuries. The Dutch came by sea to an area on the coastal and island fringes of Asia, the one zone where their warships gave them a decisive edge in this era. The citizens of Patane had good reason to distrust the European intruders, since the Portuguese who had preceded the Dutch had used force whenever possible to control the formerly peaceful trade in the region and often to persecute Muslim Peoples. The New World Order

Eritrea, which formally became independent in May 1993, is Africa's youngest state. Its relations with Ethiopia, whose government is now dominated by the EPRDF, are very close and cooperative; but those with the Sudan have been strained ever since January 1994, when the EPLF government accused Khartoum of supporting Islamic fundamentalist incursions into Eritrea. This book examines, among other topics, the state of democracy in Eritrea under the EPLF regime, the nature of Eritrea's burgeoning ties with Israel, the basis of the alliance between the present regimes in Eritrea and Ethiopia, the politics behind the outrage of the Eritrean government against "Islamic fundamentalist" movements, and the ideals and problematics of political Islam. Through the focus of this book is on Eritrea, the political problems of Ethiopia and the Sudan are also explored. Ethiopia has been going through a process of democratisation which is increasingly beset with difficulties and controversies. In the Sudan, where an Islamist regime is in power, there is a bitter struggle over issues of democracy and human rights. The war in the Southern region is the country's most grave problem. These questions are considered in the context of the new world situation in which the US is the uni-super-power, at least in the military sense of the term. In this connection, the doctrine of the USSR attention has been concentrated on some "threats" in the developing world to justify policy of intervention, including military intervention. These "threats" are also briefly discussed in this book.

The Middle East in the New World Order

This text explores the long history of hostility between Islam and the West, as well as the profound intellectual and cultural influences they have on one another. In light of this history and in the wake of the September 11th attack, the author looks at the future, and offers a vision of a new political and religious world order.

The Global Game for a New World Order

The Challenge of Fundamentalism

Human rights lawyer Arsalan Iftikhar takes on Islamophobia through the lens of the brutal Christchurch slaughter. In March 2019, a heavily-armed white supremacist walked into two mosques in Christchurch, New Zealand and slaughtered fifty-one innocent Muslim worshippers while broadcasting on Facebook Live for the world to see. After the Christchurch mosque massacre, authorities found the white supremacist's seventy-four-page racist manifesto called "The Great Replacement," which railed against Muslims and the idea that brown Muslim folks were ultimately going to "replace" white people in his irrational "Fear of Muslim Planet." Fear of a Muslim Planet begins with the treacherous legacy of the white supremacist "Great Replacement" theory in the aftermath of the Christchurch massacre. One of the heroes for the Christchurch shooter was the infamous Norwegian anti-Muslim terrorist named Anders Breivik, who brutally murdered seventy-seven people in 2011 in Norway's worst terrorist attack ever and whose own 1,500-page fascist manifesto promoted thr "Great Replacement" worldview that Muslim immigrants posed a danger to Western societies. As the book further illustrates, minority victims of the "Great Replacement" conspiracy theory are not limited to Muslims alone. In October 2018, the Tree of Life synagogue in Pittsburgh was devastated when a white supremacist brutally executed eleven innocent Jewish congregants in a horrific act of anti-Semitic terrorism (it was the single deadliest attack exclusively targeting Jews ever to happen in the United States). The shooter later told police that he was inspired to commit these murders because Donald Trump was not doing enough to stop immigration. "Open your Eyes!" the shooter posted on social media in a disjointed anti-Semitic and Islamophobic manifesto. "It's the filthy EVIL jews Bringing the Filthy EVIL Muslims into the Country!!" The presidency of Donald Trump has only exacerbated the growth of Islamophobia in America today. Fear of a Muslim Planet outlines the blatantly anti-Muslim statements and policies of Trump and his closest political circle. From telling CNN's Anderson Cooper that "I think Islam hates us" to calling for a "complete and total shutdown" of Muslims entering the United States, the Trump presidency has only made the xenophobic specter of Islamophobia grow today. The book will also show that Islamophobia is not simply an American (or Western) problem either. Fear of a Muslim Planet will show the genocidal levels of Islamophobia in places like China and Myanmar. The European fixation on policing Muslim women's hijab (headscarf) is another focal point. The book ends with a clarion call for mutual understanding and coexistence among people of all backgrounds, if we have the courage to summon our better selves and look beyond each other's race, religion, and ethnic backgrounds.

The New World Order

Recent events have demonstrated that one of the most important fields of study in this century is world order. The contribution of this book to this field is that it attempts to lay the intellectual foundations for a reconsideration of what constitutes a truly Islamic world order. Perhaps the words of the late Professor Ismail al-Faruqi, in his scholarly introduction to this work, best describes the landmarks of such an order; "The world order of Islam would confer upon every person by virtue of birth and humanity, the ultimate right and honor, namely, the capacity to think and make up one's mind as to which millah one wishes to belong and hence, by which law one desires to order one's life and that of one's dependents."In dealing with his subject, the author has had to return to the sources of Islam, the Qur'an and the Sunnah, and develop a methodology for dealing with them in a creative and practicable manner. In

doing so, he examines the methodology developed by the early generations of Muslim scholars and finds it limited by its legalistic approach. Thus, much of the value of his work lies in its discussion of methodology and in the social sciences in general, by means of methodology developed from a purely Islamic perspective. Largely because of the cultural and political shift of the Enlightenment, Western societies emerged from sectarian conflict and embraced a more religiously moderate path. Islam, the Middle East, and the New Global Hegemony

As late as the last quarter of the twentieth century, there were expectations that Islam's political and cultural influence would dissipate as the advance of westernization brought modernisation and secularisation in its wake. Not only has Islam failed to follow the trajectory pursued by variants of Christianity, namely confinement to the private sphere and depoliticisation, but it has also forcefully re-asserted itself as mobilisations in its name challenge the global order in a series of geopolitical, cultural and philosophical struggles. The continuing (if not growing) relevance of Islam suggests that global history cannot simply be presented as a scaled up version of that of the West. Quests for Muslim autonomy present themselves in several forms — local and global, extremist and moderate,

conservative and revisionist — in the light of which the recycling of conventional narratives about Islam becomes increasingly problematic. Not only are these accounts inadequate for understanding Muslim experiences, but by relying on them many Western governments pursue policies that are counter-productive and ultimately hazardous for Muslims and non-Muslims alike. Recalling the Caliphate engages critically with the interaction between Islam and the political in context of a post colonial world that continues to resist profound decolonisation. In the first part of this book, Sayyid focuses on how demands for Muslim autonomy are debated in terms such as democracy, cultural relativism, secularism, and liberalism. Each chapter analyses the displacements and evasions by which the decolonisation of the Muslim world continues to be deflected and deferred, while the latter part of the book builds on this critique and attempts to accelerate the decolonisation of the Muslim Ummah.
