Speaking Frankly

How did a disheveled, intellectually combative gay Jew with a thick accent become one of the most effective (and funniest) politicians of our time? Growing up in Bayonne, New Jersey, the fourteen-year-old Barney Frank made two vital discoveries about himself: he was attracted to government, and to men. He resolved to make a career out of the first attraction and to keep the second a secret. Now, fifty years later, his sexual orientation is widely accepted, while his belief in government is embattled. Frank: A Life in Politics from the Great Society to Same-Sex Marriage is one man's account of the country's transformation—and the tale of a truly momentous career. Many Americans recall Frank's lacerating wit, whether it was directed at the Clinton impeachment ("What did the president touch, and when did he touch it?") or the pro-life movement (some people believe "life begins at conception and ends at birth"). But the contours of his private and public lives are less well-known. For more than four decades, he was at the center of the struggle for personal freedom and economic fairness. From the battle over AIDS funding in the 1980s to the debates over "big government" during the Clinton years to the 2008 financial crisis, the congressman from Massachusetts played a key role. In 2010, he coauthored the most far-reaching and controversial Wall Street reform bill since the era of the Great Depression, and helped bring about the repeal of Don't Ask, Don't Tell. In this feisty and often moving memoir, Frank candidly discusses the satisfactions, fears, and grudges that come with elected office. He recalls the emotional toll of living in the closet and how his public crusade against homophobia conflicted with his private accommodation of it. He discusses his painful quarrels with allies; his friendships with public figures, from Tip O'Neill to Sonny Bono; and how he found love with his husband, Jim Ready, becoming the first sitting member of Congress to enter a same-sex marriage. He also demonstrates how he used his rhetorical skills to expose his opponents' hypocrisies and delusions. Through it all, he expertly analyzes the gifts a successful politician must bring to the job, and how even Congress can be made to work. Frank is the story of an extraordinary political life, an original argument for how to rebuild trust in government, and a guide to how political change really happens—composed by a master of the art.

Frankly Speaking

Does the idea of equality for sexual minorities have as strong an influence as the media suggest? How often do politicians come out forthrightly in support of gay rights? Drawing on more than three hundred interviews with activists, politicians, officials, legislative aides, and journalists, David Rayside shows that gays, lesbians, and their political issues are still on the fringe of the political mainstream. His landmark study of political access demonstrates that, despite the overall tempering of anti-gay rhetoric in the 1990s, opponents of equality are formidable, and standing up for sexual minorities is still widely thought to be politically risky. Rayside documents a high-profile controversy in each of three countries: gays and lesbians in the military in the United States, sexual orientation and human rights legislation in Canada, and the age-of-consent battle in the United Kingdom. In addition, in-depth interviews of openly gay elected officials from three countries—U.S. Congressman Barney Frank, Canadian Member of Parliament Svend Robinson, and British M.P. Chris Smith—provide an inside look at the political

process: the negotiation of gay and lesbian policy issues on a daily basis, the attitudes of colleagues in various political parties, and the tensions created when grassroots and mainstream activism intersect with each other. The only major book to look at gay and lesbian politics in three culturally similar but politically disparate countries, *On the Fringe* explores the political workings and impact of a modern social movement.

There was a time, in this century, when liberals championed the working class, when Democrats were indisputably the party of those who worked rather than invested for a living. Today, however, most Americans have come to see liberals as drifting and aimless, somehow lacking in backbone and moral fiber, beholden to radical ideologies that have little to do with the average American's life. Few incidents cast this phenomenon into greater relief than George Bush's successful tarring of Michael Dukakis as a liberal in 1988--and, tellingly, Dukakis's subsequent flight from the liberal tradition. How has it come to this? Why have liberals allowed themselves to be so portrayed? In this book, Gordon MacInnes--state senator, fiscal conservative, frustrated Democrat, and a man who believes deeply in America's civic culture--reveals how progressive forces have retreated from the battle of ideas, at great cost. Squarely at the nexus of race, poverty, and politics, *Wrong for All the Right Reasons* charts the sources of liberal decline and the high costs of conservative rule. Tracing the origins of the liberal retreat to the fall-out over Senator Daniel Patrick Moynihan's report on the black family in the 1960s, MacInnes claims that white liberals have somewhere along the way stopped taking black people seriously enough to argue with them. Continuously put on the defensive, liberals have been unable to forge an aggressive, proactive agenda of that addresses the needs of working-class and poor Americans. This has led to a breakdown of honest dialogue which to this day continues to plague liberal Democrats, as evidenced by Bill Bradley's withdrawal from active party politics last fall. Finding room for optimism in the groundswell of grass-roots progressivism, *Wrong for All the Right Reasons* is a timely, necessary call to arms for liberal, progressive Democrats, outlining ways in which they can reverse their party's dangerous decline.

In fact, Rove became the first presidential aide to both provide political advice to a sitting president while at the same time controlling the policy levers inside the White House, especially as an advocate for his own agenda in the areas of domestic policy. Finally, Karl Rove is noteworthy for the scope of his ambitions: his goal for the Bush presidency was to create a durable Republican majority that would dominate American politics for the next several decades. Even though theories of party systems and realignments have received serious challenges, Karl Rove was a believer; providing a key insight into how he approached his work with the Bush presidency. Where previous realignments were the result of historical accidents and recognized only after the fact, Karl Rove believed he could engineer the next one. In *The Uses and Misuses of Politics* William G. Mayer analyzes Karl Rove's performance as presidential advisor: the roles he played, the advice he gave, and how the Republican Party fared with Rove as its principal strategist. His family background, his military service, his life experience before going into public life, and the various positions in government service are all reviewed by friends, colleagues, and objective observers. The end result is the most detailed examination ever attempted of Bush's character and its impact on his career.

What I Saw at the Revolution

The 1980s and early 1990s were remarkable for the triumph of conservatism in the United States and its closest allies. The victories of Presidents Ronald Reagan and George H.W. Bush in the United States were complemented by the electoral successes of Margaret Thatcher in the United Kingdom and Brian Mulroney in Canada. The relationship between Reagan and Bush and their conservative counterparts was particularly important in providing a united front on foreign policy, whether the target was the Soviet Union, Communist insurgencies in Africa or Latin America, or Iraqi dictator Saddam Hussein. The Reagan-Bush era witnessed some of the most dramatic events of the latter half of the twentieth century: the collapse of the Soviet Union, a presidential assassination attempt, political scandal, a stock market crash, military invasions, and the explosion of the space shuttle Challenger. Playing President

When George H. W. Bush took office in January 1989, he brought to the presidency an impressive resume. A former member of Congress, national party leader, CIA director, ambassador to China, and two-term vice president, he had the credentials and experience for a uniquely successful presidency. Less than four years later, the American electorate resoundingly proclaimed his administration a failure. Many pundits and scholars have echoed the voters' judgement. In a considered and balanced reassessment, Mark J. Rozell and Ryan J. Barilleaux ask whether the public and the pundits have applied the wrong criteria of presidential evaluation. Looking at the context in which Bush came into office, Rozell and Barilleaux argue that his strategy of incrementalism may indeed have been right for the times and the failure may have lain only in Bush's inability to convince the public of that. Moreover, the authors disagree with the common wisdom that Bush pursued incrementalism only in domestic policy, arguing that it characterized his foreign policy as well. *Power and Prudence* is a study in presidential evaluation. It represents a challenge to the conventional wisdom that has developed on the first Bush administration and presents an important reinterpretation of the leadership of a poorly-understood president. This thought-provoking analysis suggests that due to the circumstances of his presidency Bush may not have been in any position to articulate or achieve far-reaching policy objectives. These circumstances included the lack of an electoral mandate, Bush's succession to a very popular and ideological leader, his inheritance of a daunting budget deficit, and the situation of divided government. Interviews with members of Bush's White House staff and recourse to the limited archival record thus far opened to scholars inform the authors' interpretation of the Bush administration. A fascinating read into the workings of a contemporary presidency, *Power and Prudence* will appeal to presidential scholars as well as the politically-minded reader.

Framing the Sixties

'Right On?' presents an analysis of the ambitious and controversial agenda pursued by the George W. Bush administration at home and abroad.

Right On?

Although it lasted only a single term, the presidency of George H. W. Bush was an unusually eventful one, encompassing the fall of the Berlin Wall and the reunification of Germany, the dissolution of the Soviet Union, the invasion of Panama, the Persian Gulf War, and contentious confirmation hearings over Clarence Thomas and John Tower. Bush has said that to understand the history of his presidency, while "the documentary record is vital," interviews with members of his administration "add the human side that those papers can never capture." This book draws on interviews with senior White House and Cabinet officials conducted under the auspices of the Bush Oral History Project (a cooperative

effort of the University of Virginia's Miller Center and the George Bush Presidential Library Foundation) to provide a multidimensional portrait of the first President Bush and his administration. Typically, interviews explored officials' memories of their service with President Bush and their careers prior to joining the administration. Interviewees also offered political and leadership lessons they had gleaned as eyewitnesses to and shapers of history. The contributors to 41—all seasoned observers of American politics, foreign policy, and government institutions—examine how George H. W. Bush organized and staffed his administration, operated on the international stage, followed his own brand of Republican conservatism, handled legislative affairs, and made judicial appointments. A scrupulously objective analysis of oral history, primary documents, and previous studies, 41 deepens the historical record of the forty-first president and offers fresh insights into the rise of the "new world order" and its challenges.

Cabinet members, journalists who covered Washington in the 1980s, and scholars who have been reassessing the George H. W. Bush presidency detail his domestic policy. The key areas covered include the economy, the budget, the disabled, civil rights, health, science and technology. In addition, the volume examines his emphasis on volunteerism. As the essays make clear, Bush's domestic policy stands in vivid contrast to his foreign policy. While his stewardship in the latter area won him praise and popularity, many of his decisions in the domestic sphere brought criticism from both the left and right and proved politically disastrous, playing a key role in his 1992 election defeat. Although some accuse Bush of disengagement and disinterest in domestic affairs, the prevailing opinion voiced at the Bush Presidency Conference, which provided the basis for this and other companion volumes, was that the president's domestic policies were characterized by a deep commitment to principle and pursuit of the public interest, even at the expense of political considerations. Indeed, many argue that the Bush administration pursued policies that were both well intentioned and ultimately successful, but failed to communicate them successfully to the public. While some of the blame for this lies with a hostile news media and simple bad luck—especially the economic downturn beginning in 1991—much of the responsibility appears to rest with President Bush himself, a man reluctant to tout his successes and sully himself in partisan political combat. Thus, the picture that emerges of George H. W. Bush in this volume is that of a decent, principled man whose accomplishments in the domestic arena were unfairly devalued and widely misunderstood.

Principle Over Politics?

The White House spokesman for both President Reagan and President Bush presents his memoirs along with an account of the power of the press and its influence on the presidency in setting the national agenda.

Call the Briefing!

An April 1997 conference held at Hofstra University, titled "George Bush: Leading in a New World," brought together alumni of the first Bush administration, scholars, and journalists to assess the administration. The conference resulted in four volumes, of which this one addresses Bush's appointments, White House staffing, relations with Congress, and campaign and rhetorical style. The entirety of the proceedings appears to have been reproduced here, including transcripts of discussion panels and question and answer sessions.
