## Religion, Extremism and Violence in South Asia

The advent of two nuclear powers in South Asia, discoveries of nuclear trafficking, and insurgencies and terrorism that threaten important U.S. interests and objectives directly have transformed the region from a strategic backwater into a primary theater of concern for the United States. The United States, to a great extent free of the restrictions of earlier sanction regimes and attentive to the region's central role in the global war on terrorism (GWOT), has engaged the states of South Asia aggressively with a wide variety of policy initiatives. Despite the diversity of policy instruments, few are very powerful; indeed, only the U.S. military seems to offer many options for Washington to intensify further its security cooperation and influence in the region. This monograph highlights key factors in the region that imperil U.S. interests, and suggests how and where the U.S. military might play an expanded, influential role. The report notes that the current U.S. military force posture, disposition, and lines of command may not be optimal, given South Asia's new status in the U.S. strategic calculus, and suggests seven key steps the military might take to improve its ability to advance and defend U.S. interests, not only in South Asia, but beyond it, including the Middle East and Asia at large. Beyond the specifics, however, the broader message arising from this analysis is straightforward: the region's salience for U.S. policy interests has increased dramatically. It is therefore prudent to intensify Washington's involvement in the region and to devote the resources necessary to become more influential with the governments within the region. Given the area's potential for violence, it is also prudent to shape a part of the U.S. military to meet the potential crises emanating from South Asia, just as the United States once shaped its military presence in Western Europe for the contingencies of the Cold War.

This volume looks at human rights in independent India through frameworks comparable to those in other postcolonial nations in the Global South. It examines wide-ranging issues that require immediate attention such as those related to disability, violence, torture, education, LGBT, neoliberalism, and social justice. The essays presented here explore the discourse surrounding human rights, and engage with aspects linked to the functioning of democracy, security and strategic matters, and terrorism, especially post 9/11. # Religion and Political Conflict in South Asia

## Religious Radicalism and Security in South Asia

South Asia is home to a range of extremist groups from the jihadists of Pakistan to the Tamil Tigers of Sri Lanka. In the popular mind, extremism and terrorism are invariably linked to ethnic and religious factors. Yet the dominant history of South Asia is notable for tolerance and co-existence, despite highly plural societies. Deepa Ollapally examines extremist groups in Kashmir, Afghanistan, Northeast India, Pakistan, Bangladesh, and Sri Lanka to offer a fresh perspective on the causes of extremism. What accounts for its rise in societies not historically predisposed to extremism? What determines the winners and losers in the identity struggles in South Asia? What tips the balance between more moderate versus extremist outcomes? The book argues that politics, inter-state and international

relations often play a more important role in the rise of extremism in South Asia than religious identity, poverty, and state repression.

## Religion and Politics in South Asia

As in the cascading of water, violence and nonviolence can cascade down from commanding heights of power (as in waterfalls), up from powerless peripheries, and can undulate to spread horizontally (flowing from one space to another). As with containing water, conflict cannot be contained without asking crucial questions about which variables might cause it to cascade from the top-down, bottom up and from the middle-out. The book shows how violence cascades from state to state. Empirical research has shown that nations with a neighbor at war are more likely to have a civil war themselves (Sambanis 2001). More importantly in the analysis of this book, war cascades from hot spot to hot spot within and between states (Autesserre 2010, 2014). The key to understanding cascades of hot spots is in the interaction between local and macro cleavages and alliances (Kalyvas 2006). The analysis exposes the folly of asking single-level policy questions like do the benefits and costs of a regime change in Iraq justify an invasion? We must also ask what other violence might cascade from an invasion of Iraq? The cascades concept is widespread in the physical and biological sciences with cascades in geology, particle physics and the globalization of contagion. The past two decades has seen prominent and powerful applications of the cascades idea to the social sciences (Sunstein 1997; Gladwell 2000; Sikkink 2011). In his discussion of ethnic violence, James Rosenau (1990) stressed that the image of turbulence developed by mathematicians and physicists could provide an important basis for understanding the idea of bifurcation and related ideas of complexity, chaos, and turbulence in complex systems. He classified the bifurcated systems in contemporary world politics as the multicentric system and the statecentric system. Each of these affects the others in multiple ways, at multiple levels, and in ways that make events enormously hard to predict (Rosenau 1990, 2006). He replaced the idea of events with cascades to describe the event structures that 'gather momentum, stall, reverse course, and resume anew as their repercussions spread among whole systems and subsystems' (1990: 299). Through a detailed analysis of case studies in South Asia, that built on John Braithwaite's twenty-five year project Peacebuilding Compared, and coding of conflicts in different parts of the globe, we expand Rosenau's concept of global turbulence and images of cascades. In the cascades of violence in South Asia, we demonstrate how micro-events such as localized riots, land-grabbing, pervasive militarization and attempts to assassinate political leaders are linked to large scale macro-events of global politics. We argue in order to prevent future conflicts there is a need to understand the relationships between history, structures and agency; interest, values and politics; global and local factors and alliances.

#### The Politics of Extremism in South Asia

# Religion and Conflict in South and Southeast Asia

## The Cambridge World History of Violence

In this timely book Milton J. Esman surveys a recurrent and seemingly intractable factor in the politics of nations: ethnicity. As the author notes, virtually no contemporary nation-state is ethnically homogeneous. Most address the political effects of domestic ethnic difference, and many fail in the attempt—with devastatingly violent results. Esman focuses on ethnic mobilization and the management of conflict, on the ways ethnic groups prepare for political combat, and on measures that can moderate or control ethnic disputes, whether peaceful or violent. ## Rise of Extremism in South Asia

This is one of the first single-author comparisons of different South Asian states around the theme of religious conflict. Based on new research and syntheses of the literature on 'communalism', it argues that religious conflict in this region in the modern period was never simply based on sectarian or theological differences or the clash of civilizations. Instead, the book proposes that the connection between religious radicalism and everyday violence relates to the actual (and perceived) weaknesses of political and state structures. For some, religious and ethnic mobilisation has provided a means of protest, where representative institutions failed. For others, it became a method of dealing with an

Empirical analyses of women's roles in the Sri Lankan Tamil militant group, the LTTE and the logistical, ideological support women provide to militant groups active in Indian administered Kashmir suggest that these insurgent wars have their own gender dynamics in recruitment and operational strategies. # Afghanistan and Its Neighbors

Islamist militants based in Pakistan have played a major role in terrorism around the world and pose a significant threat to regional and international security. Although the Pakistan-militant connection has received widespread attention only in recent years, it is not a new phenomenon. Pakistan has, since its inception in the wake of World War II, used Islamist militants to wage jihad in order to compensate for severe political and material weakness. This use of militancy has become so important that it is now a central component of Pakistani grand strategy; supporting jihad is one of the principal means by which the Pakistani state seeks to produce security for itself. Contrary to conventional wisdom, the strategy has not been wholly disastrous. It has achieved important domestic and international successes, enabling Pakistan to confront stronger adversaries and shape its strategic environment without the costs and risks of direct combat, and to help promote internal cohesion to compensate for its weak domestic political foundations. Recently, however, these successes of Pakistan's militant strategy have given way to serious problems. The militant organizations that Pakistan nurtured over the decades are increasingly exceeding its control; continued support for jihad diverts scarce resources from pressing domestic projects, impeding the country's internal development; and the militant campaign's repeated provocations have led India to adopt a more aggressive conventional military posture. As Paul Kapur shows in Jihad as Grand Strategy, these developments significantly undermine Pakistani interests, threatening to leave it less politically cohesive and externally secure than it was before. Thus, despite its past benefits, the strategy has outlived its utility, and Pakistan will have to abandon it in order to avoid catastrophe. This will require not simply a change of policy, but a thoroughgoing reconceptualization of the Pakistani state.

## Women and Militant Wars

## **Talibanistan**

Political violence has remained an integral part of South Asian society for decades. The region has witnessed and continued to encounter violence for achieving political objectives from above and from below. Violence is perpetrated by the state, by non-state actors, and used by the citizens as a form of

resistance. Ethnic insurgency, religion-inspired extremism, and ideology-driven hostility are examples of violent acts that have emerged as challenges to the states which have responded with violence in the form of civil war and through violations of human rights disregarding international norms. The phenomenon is explored from historical, sociological, and political perspectives. This book will be useful as a supplementary text in courses on South Asian Studies in general and South Asian Politics in particular.

## Stability in South Asia

This study analyzes the ongoing conflicts in southern Thailand and southern Philippines between indigenous Muslim minorities and their respective central governments. In particular, it investigates and interrogates the ideological context and content of conflicts in southern Thailand and southern Philippines insofar as they pertain to Islam and radicalism in order to assess the extent to which these conflicts have taken on a greater religious character and the implications this might have on our understanding of them. In the main, the monograph argues that while conflicts in southern Thailand and southern Philippines have taken on religious hues as a consequence of both local and external factors, on present evidence they share little with broader radical global Islamist and Jihadist ideologies and movements, and their contents and contexts remain primarily political, reflected in the key objective of some measure of self-determination, and local, in terms of the territorial and ideational boundaries of activism and agitation. Furthermore, though both conflicts appear on the surface to be driven by similar dynamics and mirror each other, they are different in several fundamental ways.

## Religion, politics and ethnicity in iran: investigating the case of the sunni deobandis

An oft-neglected theme in studies on communal violence is the role of the state, particularly of its institutions of law enforcement and policing. Recent experience with religion-based violence in South Asia—particularly, the 2002 riots in Gujarat—has brought into sharp focus this relationship between communal violence and partisan state institutions. The seven essays in this anthology—written by eminent authors from diverse traditions of anthropology, history, politics and sociology—critically re-examine the symbolism, scale and nature of communal violence in South Asia in view of the state's changing image. Moving beyond cliched explanations of riots, the contributors: - Map the contemporary discourse on Hindu-Muslim violence and focus on the causes of communal violence as well as its long-term consequences - Situate the nation-state within the incidents of violence—variously termed ethnic, communal and everyday violence—that simultaneously frame and challenge the authority of the state - Locate the current discussion on violence and the state in Pakistan, and provide a general thematic overview of religion and state institutions in Pakistan - Expand various categories of violence to present a South Asian perspective vis-a-vis the current western discourse on `global terrorism`

#### Political Violence in South Asia

Lashkar-e-Taiba is among the most powerful militants groups in South Asia and increasingly viewed as a global terrorist threat on par with al-Qaeda. Considered Pakistan's most powerful proxy against India, the group gained public prominence after its deadly ten-person suicide assault on Mumbai in November 2008. By the time the last Lashkar terrorist was dead after nearly 60 hours, it appeared the world was facing a new menace. Boasting transnational networks stretching across several continents, there has

been serious debate since 9/11 of whether Lashkar is an al-Qaeda affiliate. The deliberate targeting of Westerners and Jews during the Mumbai attacks raised questions about whether Lashkar was moving deeper into al-Qaeda's orbit and perhaps on a trajectory to displace Osama bin Laden's network as the next major global jihadi threat. Lashkar's expansion has serious security implications for India, Pakistan, Europe and the United States and its activities threaten to damage US-Pakistan relations. Despite growing calls for action, Pakistan is yet to take any serious steps toward dismantling Lashkar for fear of drawing it further into the insurgency raging there and because of its continued utility against India. More than a militant outfit, Lashkar also controls a vast infrastructure that delivers necessary social services to the Pakistani populace, making it all the more difficult to dismantle. Storming the World Stage traces the evolution of Lashkar-e-Taiba over more than two decades to illustrate how the group grew so powerful and to assess the threat it poses to India, the West and to Pakistan itself. The first English-language book ever written about Lashkar, it draws on in-depth field research, including interviews with senior Lashkar leaders, rank-and-file members, and officials of the Pakistani security services--some of who have helped nurture the group over the years.
