The substitute pro gram is a uniform method of rating teachers, so that superintend ents shall be speaking a common language, when they endorse teachers to the State Department or to each other. The endorse ments now submitted in behalf of teachers come too often from those who know little about the ones endorsed, and they frequently omit the things we most wish to know. Before attempting to present a rating plan adapted to South Dakota conditions, we may remark upon the attitude taken toward rating plans where they are in use, and a few of the administrative questions that arise in that connection. Most of the systems using a score card for teachers report that the teachers are friendly to it. Of sixteen cities reporting on this, only two indicate general opposirion or skepticism on the part of the teaching force. This is nor strange.
