The fundamental argument this book is, first, that Richard Nixon, though not generally regarded as a charismatic or emotionally outgoing politician like Franklin Roosevelt or Ronald Reagan, did establish profound psychic connections with the American people, connections that can be detected both in the brilliant electoral success that he enjoyed for most of his career and in his ultimate defeat during the Watergate scandal; and, second and even more important, that these connections are symptomatic of many of the most important currents in American life. Was Richard Nixon actually a madman, or did he just play one? It was on a beach that summer that Nixon disclosed to his chief aide, H. R. Haldeman, one of his most notorious, risky gambits: the madman theory. Richard Nixon and the Quest for a New Majority

The "Silent Majority" Speech treats Richard Nixon's address of November 3, 1969, as a lens through which to examine the latter years of the Vietnam War and their significance to U.S. global power and American domestic life. The book uses Nixon's speech – which introduced the policy of "Vietnamization" and cited the so-called bloodbath theory as a justification for continued U.S. involvement in Southeast Asia – as a fascinating moment around which to build an analysis of the last years of the war. For Nixon's strategy to be successful, he requested the support of what he called the "great silent majority," a term that continues to resonate in American political culture. Scott Laderman moves beyond the war's final years to address the administration's hypocritical exploitation of moral rhetoric and its stoking of social divisiveness to achieve policy aims. Richard Nixon and His America

The Watergate scandal began with a break-in at the office of the Democratic National Committee at the Watergate Hotel on June 17, 1971, and ended when President Gerald Ford granted Richard M. Nixon a pardon on September 8, 1974, one month after Nixon resigned from office in disgrace. Effectively

removed from the reach of prosecutors, Nixon returned to California, uncontrite and unconvicted, convinced that time would exonerate him of any wrongdoing and certain that history would remember his great accomplishments - the opening of China and the winding down of the Vietnam War - and forget his "mistake," the "pipsqueak thing" called Watergate. In 1977, three years after his resignation, Nixon agreed to a series of interviews with television personality David Frost. Conducted over twelve days, they resulted in twenty-eight hours of taped material, which were aired on prime-time television and watched by more than 50 million people worldwide. Nixon, a skilled lawyer by training, was paid \$1 million for the interviews, confident that this exposure would launch him back into public life. Instead, they sealed his fate as a political pariah. James Reston, Jr., was David Frost's Watergate advisor for the interviews, and *The Conviction of Richard Nixon* is his intimate, behind-the-scenes account of his involvement. Originally written in 1977 and published now for the first time, this book helped inspire Peter Morgan's hit play *Frost/Nixon*. Reston doggedly researched the voluminous Watergate record and worked closely with Frost to develop the interrogation strategy. Even at the time, Reston recognized the historical importance of the Frost/Nixon interviews; they would result either in Nixon's de facto conviction and vindication for the American people, or in his exoneration and public rehabilitation in the hands of a lightweight. Focused, driven, and committed to exposing the truth, Reston worked tirelessly to arm Frost with the information he needed to force Nixon to admit his culpability. In *The Conviction of Richard Nixon*, Reston provides a fascinating, fly-on-the-wall account of his involvement in the Nixon interviews as David Frost's Watergate adviser. Written in 1977 immediately following these celebrated television interviews and published now for the first time, *The Conviction of Richard Nixon* explains how a British journalist of waning consequence drove the famously wily and formidable Richard Nixon to say, in an apparent personal epiphany, "I have impeached myself."

Best known as the 37th President of the United States, and the only president in American history to resign his office, Richard Nixon's lengthy political career would put him, during various times, at the center of regional, national and international politics for several decades. It was to be a career filled with unexpected twists and turns, high-profile defeats and unlikely resurrections, in which he made exhaustive efforts to reinvent himself in the public eye. From humble beginnings filled with disparate influences, Nixon's extraordinary intellect, strategic brilliance and imposing style of confrontation saw him through a stellar academic career at Duke Law School to seats in both the House and Senate, the vice-presidency and finally, the presidency, where he was and is considered by many to be among the strongest foreign policy presidents in the history of the United States. By 1972, Nixon appeared to be well on his way to reelection, and sure enough, he enjoyed one of the biggest landslides against George McGovern that year. However, despite the fact that Nixon's reelection seemed a cinch, the seeds of his destruction were being sown in the months leading up to the election. Increasingly and mistakenly viewed as a single scandal within the United States government, what is commonly referred to as the Watergate scandal serves as an overarching term for a series of scandals beginning in 1971 and extending through 1974, although more than any other, it refers to the specific break-in at the Watergate Hotel and office complex in Washington, D.C. The crisis, originating in a secretive battle between the two major political parties, the Nixon White House's paranoia, and the ensuing conflict concerning the release of confidential information to the public, induced senior government officials into committing crimes (most notoriously petty burglary) and coverups for the purposes of character assassination and inter-political espionage. Ultimately, Watergate resulted in the first and only resignation of a sitting American president, but only after Nixon had tried at seemingly every turn to hinder investigations and coverup crimes committed by senior officials in his own administration. Watergate has since become so synonymous with scandal that "gate" is typically added to the end of words associated with scandals even today. For the last 40 years, President Nixon has been mostly reviled, and understandably, he's ranked among the country's worst presidents, but this view of the President and the Watergate scandal was not and still is not necessarily unanimous. A growing number of Republicans, led by conservatives such as former Nixon speechwriter Pat Buchanan, describe the bringing down of the president as a quasi-coup generated by the press and liberal social forces from within the anti-war movement, which gravitated to the release of information on Vietnam, an increasingly unpopular war, and tapping the widespread campus unrest throughout the country. Paul Johnson, in his book, *Modern Times: A History of the World from the 1920s to the Year 2000*, referred to the whole affair as nothing more than "this Watergate witch hunt." *Richard Nixon and Watergate* examines the life and legacy of America's most controversial president, and provides a comprehensive analysis of the country's most famous political

Richard Nixon and Watergate

The U.S.-European relationship remains the closest and most important alliance in the world. Since 1945, successive American presidents each put their own touches on transatlantic relations, but the literature has reached only into the presidency of Lyndon Johnson (1963-9). This first study of transatlantic relations during the era of Richard Nixon shows a complex, turbulent period during which the postwar period came to an end, and the modern era came to be on both sides of the Atlantic in terms of political, economic, and military relations.

Richard Nixon and Europe

As historian and author John W. Malsberger writes in *The General and the Politician: Dwight Eisenhower, Richard Nixon and American Politics*, no two political figures could have taken more different routes to the Presidency than did America's 34th and 37th Commanders in Chief. Thrown together largely for political convenience by a Republican party struggling to reinvent itself through years of post-Depression, Democratic dominance, Dwight Eisenhower and Richard Nixon came to embody two radically different styles of leadership, simultaneously defining - for the American electorate - where American politics had been, and where they were headed. While debate has raged amongst historians over the level of hostility the two men were rumored to harbor for one another, there is - as Malsberger points out - a more accurate reading of their relationship available to us if we examine all the facts. Taken in a broader context, their relationship was much less a momentary collision of dissident styles and values than a genuine watershed moment in American politics, from which our current political spectrum and electorate can trace their roots. *The General and the Politician* thoroughly and accessibly details the intersection of two of 20th-Century America's most powerful figures, and examines their tenuous but transformative relationship to reveal the origins of political discussions and debates that we're still having today.

The General and the Politician

You must be over the age of 21 and you must have an identification card, with a photo to buy or drink alcohol.

In most states, it is illegal to buy cigarettes if you are under the age of 18 and often you can only smoke in certain places.

Americans are extremely informal and call most people by their first name or nickname.

Americans smile a lot and talk easily to strangers, sharing personal stories.

Asking "How are you?" is simply a greeting and is not a question about your health.

When Americans put their hands on their hips, they are usually relaxed; when they fold their arms tightly across their chests, they are angry or very serious (or cold). A

Americans don't push or stand too close to anyone in line. They always wait their turn.

In a restaurant, the server is usually very friendly and helpful and often will tell you his or her name

When the service is good, tipping is expected to be 15-20% of the bill.

Polite Americans eat with one hand while the other one is under the table on their laps. Usually, when friends meet at a restaurant they each pay their share of the bill or split the bill in half. It's called going Dutch.

If you have guests over to your house, turn off the television, make sure your music isn't too loud. Americans have parties for many reasons. Sometimes they are held for friends to get together and to meet new people.

When you meet Americans, be sure to look them in the eye, smile, and shake hands. Make small talk at the beginning of a conversation. After a few questions, you will be asked, "What do you do?" (This means what is your job?)

For weddings and showers, people register for gifts at a specific place. Americans open presents and cards in front of people.

Be sure you include a card with your gift. The person given the gift will send you a thank you card.

At an American funeral, it is not normal to make loud sad sounds. Americans try to keep strong emotions inside.

There is no traditional color or flower that symbolizes death. Any and all flowers can be used at funerals.

We do not give money at a funeral. Sometimes, we send flowers or plants to the ceremony.

After the funeral, there is usually a reception at the home of the family. There is usually a lot of food and sometimes alcohol.

Never ask Americans a direct question about their religion, age, money, salary, weight, or dress/suit size.

Do not make any racist or negative remarks about someone's religion, family background, or sexual preferences.

Men should not make any "sexist" remarks to or about women anything that would make women unequal to men.

Americans say that they don't want to talk about politics, but sometimes they do.

Never go to someone's house without calling first to see if it is convenient.

If you are invited to an American party, do not bring your children, friends, or family members without first asking the permission of the host.

Time is money. Never be late to classes, employment interviews, appointments, parties (especially your wedding!), etc.

Some Americans hug a lot. It is okay for women and men to hug even if they are not close friends. It is normal for American women to have male friends who are just friends (and vice versa).

It is not uncommon for American men and women to share an apartment as roommates and not have a sexual relationship with each other.

Most American women do not like possessive or jealous men.

Most American women do not feel comfortable having the man pay for everything all of the time.

Be careful: Meet new friends in a public place many times before you get into a car or give out your address.

American parents speak to their children as adults and teach them how to be responsible for their actions.

American parents encourage their children to question and always ask "Why?"

By shining a light on the inequalities these privileges create, Joshi highlights a way forward, urging readers to help remake America as a diverse democracy with a commitment to true religious freedom.

Carla Toney proves that, after the collapse of their resistance, many chose migration, not as individuals, but in migration clusters. She clearly elucidates the feudal patterns brought to the United States, the cultural fluidity of Indigenous nations, and migration as a form of resistance.

Hmong and American

Killing the Indian Maiden examines the fascinating and often disturbing portrayal of Native American women in film. Through discussion of thirty-four Hollywood films from the silent period to the present, M. Elise Marubbio examines the sacrificial role of what she terms the "Celluloid Maiden" -- a young Native woman who allies herself with a white male hero and dies as a result of that choice. Marubbio intertwines theories of colonization, gender, race, and film studies to ground her study in sociohistorical context all in an attempt to define what it means to be an American. As Marubbio charts the consistent depiction of the Celluloid Maiden, she uncovers two primary characterizations -- the Celluloid Princess and the Sexualized Maiden. The archetype for the exotic Celluloid Princess appears in silent films such as Cecil B. DeMille's *The Squaw Man* (1914) and is thoroughly established in American iconography in Delmer Daves's *Broken Arrow* (1950). Her more erotic sister, the Sexualized Maiden, emerges as a femme fatale in such films as DeMille's *North West Mounted Police* (1940), King Vidor's *Duel in the Sun* (1946), and Charles Warren's *Arrowhead* (1953). The two characterizations eventually combine to form a hybrid Celluloid Maiden who first appears in John Ford's *The Searchers* (1956) and reappears in the 1970s and the 1990s in such films as Arthur Penn's *Little Big Man* (1970) and Michael Apted's *Thunderheart* (1992). *Killing the Indian Maiden* reveals a cultural iconography about Native Americans and their role in the frontier embedded in the American psyche. The Native American woman is a racialized and sexualized other -- a conquerable body representing both the seductions and the dangers of the frontier. These films show her being colonized and suffering at the hands of Manifest Destiny and American expansionism, but Marubbio argues that the Native American woman also represents a threat to the idea of a white America. The complexity and longevity of the Celluloid Maiden icon -- persisting into the twenty-first century -- symbolizes an identity crisis about the composition of the American national body that has played over and over throughout different eras and political climates. Ultimately, Marubbio establishes that the ongoing representation of the Celluloid Maiden signals the continuing development and justification of American colonialism.
