He argues that the individual seeks an absolutely unique, personal meaning that cannot be presented to him by a teacher. He thus resolves to carry on his quest alone. Siddhartha crosses a river and the generous ferryman, whom Siddhartha is unable to pay, merrily predicts that Siddhartha will return to the river later to compensate him in some way. Venturing onward toward city life, Siddhartha discovers Kamala, the most beautiful woman he has yet seen. Kamala, a courtesan, notes Siddhartha's handsome appearance and fast wit, telling him that he must become wealthy to win her affections so that she may teach him the art of love. Although Siddhartha despised materialistic pursuits as a Shramana, he agrees now to Kamala's suggestions. She directs him to the employ of Kamaswami, a local businessman, and insists that he have Kamaswami treat him as an equal rather than an underling. Siddhartha easily succeeds, providing a voice of patience and tranquility, which Siddhartha learned from his days as an ascetic, against Kamaswami's fits of passion. Thus Siddhartha becomes a rich man and Kamala's lover, though in his middle years he realizes that the luxurious lifestyle he has chosen is merely a game that lacks spiritual fulfillment. Studies in Two Literatures

IN the past so much of the finest criticism has been J- purely the result of the occasion offered, that it is pedantic to complain of the same phenomenon in the present. The school of great critics of the beginning of the century would scarcely have made a mark but for the accident that Hazlitt and Coleridge were called upon to lecture, De Quincey and Lamb to contribute to an ephemeral journal. The formation of literary opinion is the work of coral insects. Here one builds a fragment, and there another confirms it, and these volunteers are often of more signal service than the professional historians who endeavor to follow impartially the growth of literature. Mr. Symons is of the former type; one feels that he has written largely as opportunity came to him. His subjects are fragmentary, and have been selected by others under the modification of his own fancy. This is strikingly the case with the opening section of his volume, the studies in the Elizabethan age, but it is partly true in all. The volume is a selection of what seemed most durable in the miscellaneous work of some ten or twelve years of apprenticeship to the press. Let it be said at once that Mr. Symons bears the test of republication remarkably well. There is a solidity, a unity in his view of literary objects which gives him an advantage over almost all other critics of his particular generation. He is guided, almost obstinately, by certain principles of aesthetic judgment; he adopts the same attitude towards all literary products; he is above all entirely candid, and engaged, so far as can be perceived, in "rolling" no "log." All this combines to form an intellectual austerity, which may occasionally irritate us in a single article or review, but which, in the course of a volume which is instinct with it, has an attractive side. Mr. Arthur Symons impresses the reader by his rectitude. Whether his opinions are correct must be decided by closer inquiry; but we get that satisfaction which is given by a writer who, though guite modest in delivery, is perfectly clear about his destination and entirely certain that he knows the road. In his eloquent letter of dedication he lays down the law of his own mind, and he has an amusing phrase. Having confessed himself a firm believer in a principle which is excessively questioned, he adds, naively:— "One forgets sometimes that it has entered into the brains of men to doubt anything so obvious."First come seven studies on plays of Shakespeare, followed by essays on Massinger and Day. These do not appear to us to call for particular notice here. The Shakespeare essays formed part of the "Henry Irving" edition of the poet, issued and fully noticed many years ago. Mr. Symons has done well to separate these from the rest of a bulky enterprise, and they are worth preserving, although somewhat juvenile in manner and showing to some excess the influence of Mr. Swinburne. The essay on Massinger is full and competent; but Mr. Symons does not strike us as having been much interested in the subject; while that on John Day suffers from the difficulty of treating a writer whose outlines are all nebulous and vague. For instance, Mr. Symons quotes a pretty line, and says that it "bears the very sign and seal of Day." But how can we know what the sign and seal are of a dramatist four-fifths of whose works are lost, and who survives on the score of a single lyrical extravaganza of great, but probably not especially characteristic, beauty? This is the traditional way of talking about the Jacobean poets, which Mr. Swinburne, following Charles Lamb, has carried to such dangerous extremes....—The Saturday Review

Reading shapes our identities. How we read shapes who we are. Reading also shapes our conceptions of what the law is,

because the law is also a practice of reading. Focusing on the works of key Victorian writers closely associated with legal practice, this book addresses the way in which the identity of the reader of law has been modelled on the identity of the political elite. At the same time, it shows how other readers of law have been marginalised. The book thus shows how a construction of the law has emerged from the ordering of a power that discriminates between different readers and readings. More specifically, and in response to the emerging media of photography – and, with it, potentially subversive ideas of exposure and visibility – the book shows that there have been dominant, hidden and unrecognised guides to legal reading and to legal thought. And in making these visible, the book also aims to make them contestable. This secret history of law will appeal to legal historians, legal theorists, those working at the intersection of law and literature and others with interests in law and the visual.

The eight works included in this anthology were chosen to illustrate important legal themes and to show the way in which the law forces individuals to confront existential dilemmas and the questing for right answers.

Law in Literature

Law in the Courts of Love traces the literary history and diversity of past legal systems. These 'minor jurisprudences' range from the spiritual laws of the courts of conscience to the code and judgements of love handed down by women's courts in medieval France. Unlike the other three books in this series, Law in Literature: An Annotated Bibliography of Law-Related Works is not useful as a textbook for a law in literature course. In an academic setting, it is useful to professors seeking to assign works for reading by the students. Students who are interested in the topic might want to obtain the book as a reference tool to discover works for further reading. Also, the book is intended to reach an audience of those engaged in the legal system and to anyone interested in exploring the rich stories annotated in this volume.

Law in Literature

In this book the authors work on an innovative comparison between law and literature, starting from the modes in which law and literature function: they read law and literature as arts of compromising.

A Theory of Law and Literature

Man's fascination with story-telling and with the law is nowhere more apparent than in the plays which are representative of any place or time in history. This anthology commences with the Greek plays The Eumenides by Aeschylus and Antigone by Sophocles, plays which give us a glimpse of Greek thoughts on justice and which offer insight into their contemplation of obedience to Divine and positive laws. These plays are followed by Shakespeare's The Merchant of Venice and Measure for Measure, plays dealing with British concepts of justice. Massinger's The Fatal Dowry and Lillo's The London Merchant then provide a later look at English notions of crime and its causes. Finally Susan Gaspell's Trifles and Lou Rivers' This Piece of Land show 20th century America dealing with notions of equality and discrimination. Each play is followed by short comments and questions raised by the reading of these plays.
