Chronicles of the Hedges

John Richard Jefferies (1848-1887) was an English nature writer, essayist and journalist. He wrote fiction mainly based on farming and rural life. From early in life he showed a great love of the countryside, but was temperamentally unsuited to follow his father as a farmer, and in 1866 he found employment as a newspaper reporter for the North Wiltshire Herald and the Swindon Advertiser. In late 1877 he moved to Surbiton to be nearer the hub of literary England. His new surroundings defined him, as a country writer. Articles drawing on Jefferies' Wiltshire experiences were snapped up by the Pall Mall Gazette, then published in book form as *The Gamekeeper at Home* in 1878, to be followed by similar collections of essays, like *Round About a Great Estate* (1880). About this time he wrote his extraordinary autobiography, *The Story of My Heart: An Autobiography* (1883). Other works include: *The Amateur Poacher* (1879), *Hodge and His Masters* (1880), *Nature Near London* (1883), *After London; or, Wild England* (1884), *The Life of the Fields* (1884), *The Open Air* (1885), and *Field and Hedgerow* (1889).

The Long Ago

"It was the spirit of the garden that crept into my boyheart and left its fragrance, to endure through the years. Hence the necessity for a polemic against it. A polemic is designed to be the prose equivalent of a small explosive device placed under your E-Z-Boy lounge. It won't injure you (well not severely); it's just supposed to shake things up and rattle a few convictions.

Conceptions of Knowledge

The volume *Conceptions of Knowledge* collects current essays on contemporary epistemology and philosophy of science. The essays are primarily concerned with pragmatic and contextual extensions of analytic epistemology. The key concepts include epistemic abilities, forms of knowledge, and contexts of knowledge.

Explaining Knowledge

The "Gettier Problem" has shaped most of the fundamental debates in epistemology for more than fifty years. Before Edmund Gettier published his famous 1963 paper (reprinted in this volume), it was generally presumed that knowledge was equivalent to true belief supported by adequate evidence. Gettier presented a powerful challenge to that presumption. These led to the development and refinement of many prominent epistemological theories: internalism, externalism, evidentialism, reliabilism, and virtue epistemology. The debate about the appropriate use of intuition as providing evidence in all areas of philosophy began as a debate about the epistemic status of the "Gettier intuition". The differing accounts of epistemic luck are all rooted in responses to the Gettier Problem. The discussions about the role of false beliefs in the production of knowledge are directly traceable to Gettier's paper, as are the debates between fallibilists and infallibilists. The "knowledge first" view was, in large part, provoked by the supposed failure of all solutions to the Gettier Problem. Indeed, it is fair to say that providing a satisfactory response to the Gettier Problem has become a litmus test of any adequate account of knowledge - even those accounts that hold that the Gettier Problem rests on mistakes of various sorts. Knowing Art

Artworks potentially convey two kinds of knowledge: knowledge of art itself as well as general empirical knowledge, especially knowledge of human psychology. This book collects ten essays written by leading philosophers who distill and build upon recent work at the intersection of aesthetics and epistemology. The volume also explores the challenges that art poses for theories of knowledge as well as the challenges that artistic knowledge poses to traditional views about art.

Knowledge, Virtue, and Action

The prospects of virtue-theoretic analyses of knowledge depend crucially on our ability to give some independent account of what epistemic virtues are and what they are for. The contributions here ask how epistemic virtues matter apart from any narrow concern with defining knowledge; they show how epistemic virtues figure in accounts of various aspects of our lives, with a special emphasis on our practical lives. In essence, the essays here put epistemic virtues to work.

The Conditions of Knowing

This is the first collection of essays exclusively devoted to knowledge from non-knowledge and related issues. It features original contributions from some of the most prominent and up-and-coming scholars working in contemporary epistemology. There is a nascent literature in epistemology about the possibility of inferential knowledge based on premises that are, for one reason or another, not known. The essays in this book explore if and how epistemology can accommodate cases where knowledge is generated from something other than knowledge. Can reasoning from false beliefs generate knowledge? Can reasoning from unjustified beliefs generate knowledge? Can reasoning from gettiered beliefs generate knowledge? Can reasoning from propositions one does not even believe generate knowledge? The contributors to this book tackle these and other questions head-on. Together, they advance the debate about knowledge from non-knowledge in novel and interesting directions. *Illuminating Errors* will be of interest to researchers and advanced students working in epistemology and philosophy of mind.

Illuminating Errors

This special issue documents the results of a workshop on and with Alvin Goldman at the University of Düsseldorf in May, 2008. The topic was *Reliable Knowledge and Social Epistemology*. The volume contains the written versions of all papers given at the workshop, divided into five chapters and followed by Alvin Goldman's replies in the sixth and final chapter. The contributions of the first chapter (E. Brendel, C. Jäger, and G. Schurz) address general questions of social epistemology, veritism and externalism, including critical reflections on Goldman's notion of 'weak knowledge'. The subsequent chapter (T. Grundmann and P. Baumann) examines problems which are involved in the search for an adequate explication of reliabilism. In the third chapter, E. Olsson, J. Horvath, C. Piller and M. Werning discuss Goldman and Olsson's account of the problem of the value of knowledge. In the fourth chapter (M. Baumann & G. Brennan, and O. Scholz) two specific aspects of the social dimension of knowledge are investigated: the relation between knowledge and democracy as well as the definition and recognition of expertise. The fifth chapter (A. Newen & T. Schicht) discusses another part of Goldman's cognitive epistemology, namely his simulation theory of mindreading. Goldman gives detailed replies to all parts of the papers in the final chapter. He thereby clarifies the many aspects of his philosophy and proposes amendments of earlier positions of his.

Reliable Knowledge and Social Epistemology

Virtue epistemology is an exciting, new movement receiving an enormous amount of attention from top epistemologists and ethicists; this pioneering volume reflects the best work in that vein. Featuring superb writing from contemporary American philosophers, it includes thirteen never before published

essays that focus on the place of the concept of virtue in epistemology. In recent years, philosophers have been debating how this concept functions in definitions of knowledge. They question the extent to which knowledge is both normative (i.e., with a moral component) and non-normative, and many of them dispute the focus on justification, which has proven to be too restrictive. Epistemologists are searching for a way to combine the traditional concepts of ethical theory with epistemic concepts; the result is a new approach called virtue epistemology—one that has established itself as a particularly favorable alternative. Containing the fruits of recent study on virtue epistemology, this volume offers a superb selection of contributors—including Robert Audi, Simon Blackburn, Richard Foley, Alvin Goldman, Hilary Kornblith, Keith Lehrer, Ernest Sosa, and Linda Zagzebski—whose work brings epistemology into dialogue with everyday issues.

Virtue Epistemology

Epistemic Justification collects twelve distinguished and influential essays in epistemology by William P. Alston taken from a body of work spanning almost two decades. They represent the gradual development of Alston's thought in epistemology. He concentrates on topics that are central to contemporary epistemology and provides a much-needed and useful map to these issues by explicitly distinguishing and interrelating concepts of justification used in epistemology. More important, he develops and defends his own distinctive epistemic view throughout the volume. Notably, he argues for an account of justification that combines both internalist and externalist features. In addition, he discusses various forms of foundationalism and supports a moderate form. Finally, Alston demonstrates that the epistemic circularity that often plagues our attempts to validate our basic sources of belief does not prevent our showing that they are reliable sources of knowledge.

Epistemic Justification

Epistemic norms play an increasingly important role in current debates in epistemology and beyond. In this volume a team of established and emerging scholars presents new work on the key debates. They consider what epistemic requirements constrain appropriate belief, assertion, and action, and explore the interconnections between these standards.

Epistemic Norms

Originally published in 1961. Michael Polanyi was a polymath who influenced economics and the sciences as well as philosophy. His wide-ranging research in physical science is as well-known as his work on freedom and knowledge and his arguments against positivism and reductionism. This collection of essays written for him touches on all aspects of his influence but rotates around his published lectures *Personal Knowledge: Towards a Post-Critical Philosophy*. The contributors address four areas – The Scientist as Knower, Historical Perspectives, The Knowledge of Society and the Knowledge of Living Things.

Knowing and Being

Epistemological theories of knowledge and justification draw a crucial distinction between one's simply having good reasons for some belief and one's actually basing one's belief on good reasons. While the most natural kind of account of basing is causal in nature—a belief is based on a reason if and only if the belief is properly caused by the reason—there is hardly any widely accepted, counterexample-free account of the basing relation among contemporary epistemologists. Further inquiry into the nature of the basing relation is therefore of paramount importance for epistemology. Without an acceptable account of the basing relation, epistemological theories remain both crucially incomplete and vulnerable to errors that can arise when authors assume an implausible view of what it takes for beliefs to be held on the basis of reasons. *Well-Founded Belief* brings together 16 essays written by leading epistemologists to explore this important topic in greater detail. The chapters in this collection are divided into two broad categories: (i) the nature of the basing relation; and (ii) basing and its applications. The chapters in the first section are concerned, principally, with positively characterizing the epistemic basing relation and criticizing extant accounts of it, including extant accounts of the relationship between epistemic basing and propositional and doxastic justification. The latter chapters connect epistemic basing with other topics of interest in epistemology as well as ethics, including: epistemic disjunctivism, epistemic injustice, agency, epistemic conservatism, epistemic grounding, epistemic genealogy, practical reasoning, and practical knowledge.

The Logic of Personal Knowledge

Gila Sher approaches knowledge from the perspective of the basic human epistemic situation—the situation of limited yet resourceful beings, living in a complex world and aspiring to know it in its full complexity. What principles should guide them? Two fundamental principles of knowledge are epistemic friction and freedom. Knowledge must be substantially constrained by the world (friction), but without active participation of the knower in accessing the world (freedom) theoretical knowledge is impossible. This requires a grounding of all knowledge, empirical and abstract, in both mind and world, but the fall of traditional foundationalism has led many to doubt the viability of this 'classical' project. The book challenges this skepticism, charting a new foundational methodology, foundational holism, that differs from others in being holistic, world-oriented, and universal (i.e., applicable to all fields of knowledge). Using this methodology, *Epistemic Friction* develops an integrated theory of knowledge, truth, and logic. This includes (i) a dynamic model of knowledge, incorporating some of Quine's revolutionary ideas while rejecting his narrow empiricism, (ii) a substantivist, non-traditional correspondence theory of truth, and (iii) an outline of a joint grounding of logic in mind and world. The model of knowledge subjects all disciplines to robust norms of both veridicality and conceptualization. The correspondence theory is at once robust, universal, and flexible, allowing multiple patterns of correspondence, including complex and indirect patterns. Logic's systematic grounding brings it in line with other disciplines without neglecting its strong necessity, generality, and normativity, which are explained by its semantic formality.

Epistemic Friction

Written by an international team of leading scholars, this collection of thirteen new essays explores the implications of semantic externalism for self-knowledge and skepticism, bringing recent developments in the philosophy of mind, the philosophy of language, and epistemology to bear on the issue. Structured in three parts, the collection looks at self-knowledge, content transparency, and then meta-semantics and the nature of mental content. The chapters examine a wide range of topics in the philosophy of mind and the philosophy of language, including 2D semantics, transparency views of self-knowledge, and theories of linguistic understanding, as well as epistemological debates on contextualism, contrastivism, pragmatic encroachment, anti-luminosity arguments and testimony. The scope of the volume will appeal to graduate students and researchers in epistemology, philosophy of mind, philosophy of language, cognitive science, psychology and linguistics.

Knowledge and Inquiry

Epistemology or theory of knowledge has always been one of the most important -if not the most important -field of philosophy. New arguments are constantly brought to bear on old views, new variants are marshalled to revive ancient stands, new concepts and distinctions increase the sophistication of epistemological theories. There are a great many excellent textbooks, monographs as well as anthologies consisting of articles in epistemology. Similarly, there are useful philosophical dictionaries which contain a great number of relatively short entries, and general philosophical handbooks which also touch epistemological issues. This volume of 27 essays grew out from the interest to see a handbook which is devoted entirely to the historical roots and systematic development of theory of knowledge. It is not intended to compete but to supplement the already existing literature. It aims at giving both beginners and more advanced students as well as professionals in epistemology and other areas of philosophy an overview of the central problems and solutions of epistemology. The essays are self-contained and still often rather extensive discussions of the chosen aspects of knowledge. The contributions presuppose very little familiarity with previous literature and only a few of them require the mastery of even elementary logical notation. This, we hope, makes the volume also accessible to the philosophically interested wider audience. The contributors were asked to provide substantial, up-to-date, self-contained and balanced surveys of the various subareas and more specific topics of epistemology, with reference to literature.

Externalism, Self-Knowledge, and Skepticism

Bertrand Russell famously distinguished between "knowledge by acquaintance" and "knowledge by description". For much of the latter half of the twentieth century, many philosophers viewed the notion of acquaintance with suspicion, associating it with Russellian ideas that they would wish to reject. However in the past decade or two the concept has undergone a striking revival in mainstream "analytic" philosophy - acquaintance is, it seems, respectable again. This volume showcases the great variety of topics in philosophy of mind, epistemology, and philosophy of language for which philosophers are currently employing the notion of acquaintance. It is the first collection of new essays devoted to the topic of acquaintance, featuring chapters from many of the world's leading experts in this area. Opening with an extensive introductory essay, which provides some historical background and summarizes the main debates and issues concerning acquaintance, the remaining thirteen contributions are grouped thematically into four sections: phenomenal consciousness, perceptual experience, reference, and epistemology.

Handbook of Epistemology

Finally, the third group of essays extends the framework of epistemological disjunctivism to other forms of knowledge, such as testimonial knowledge, knowledge of other minds, and self-knowledge. Epistemological Disjunctivism is a timely collection that engages with an increasingly important topic in philosophy. It will appeal to researchers and graduate students working in epistemology, philosophy of mind, and philosophy of perception.
