The national nodes of the BCH and the Central Portal of the BCH are used to facilitate the exchange of scientific, technical environmental and legal information on LMOS

Countries are also actively promoting awareness-raising and public consultation on biosafety issues Developing and implementing a communication strategy is essential to promote public awareness, education and participation including access to information
