# Global Governance, Poverty and Inequality

# Global Governance and the Emergence of Global Institutions for the 21st Century

Globalization has affected everyone's lives, and the reactions to it have been mixed. Legal scholars and political scientists tend to emphasize its harmful aspects, while economists tend to emphasize its benefits. Those concerned about human rights have more often been among the critics than among the supporters of globalization. In Can Globalization Promote Human Rights? Rhoda Howard-Hassmann presents a balanced account of the negative and positive features of globalization in relation to human rights, in both their economic and civil/political dimensions. # Social Justice and Development

Globalization and Poverty provides the more nuanced understanding necessary to move that debate beyond the slogans.

# Poverty and Inequality in Middle Income Countries

Neoliberalism and austerity have led to a growing inequality gap and increasing levels of poverty and social harm. In this short form book, part of the Critical and Radical Debates in Social Work series, Chris Jones and Tony Novak look at consequences of poverty and inequality and the challenge they pose to the engaged social work academic and practitioner. There are many studies of poverty that look at competing definitions (and some of the consequences) of poverty in modern society. Here the authors argue that, especially for a profession with a claimed commitment to values based on equality, social justice and meeting human need, poverty and immiserisation impose a requirement on social workers to speak out and not to collude with social policies that make the plight of the impoverished even harder and their lives even worse.

# Globalization and Poverty

This book puts forward a new and original idea - that, for the sake of humankind, the countries of the world should share sovereignty. Unless this is done we will not be able to address global threats. These include global warming, poverty, inequality, terrorism, war and conflict, the proliferation of nuclear weapons, the outsourcing of jobs, the instability of the international financial system, the accumulation of power by corporations, the migration of peoples, the depletion of natural resources, the violation of human rights and the spread of pandemics. The first part of the book diagnoses what is wrong with the present system by which the world governs itself. It shows that the United Nations is ineffective and that some states are failing. The author demonstrates that both of these problems stem from the same cause: the world is largely Hobbesian. In other words, humankind is caught up in a 'war of all states against all states'. In the second part the author asks: what can be done? He explores the United Nations. He asks if regional organisations, NATO, the European Union, or the G8 could become a governing body at the global level. Could the United States become an enlightened global hegemon? It is not realistic to expect any of these things to happen. Instead the world needs to create a new organisation. The third part proposes a 'global union of democracies' and outlines its functions, principles and design. It shows how such an organisation could make it possible for us to address the many threats that we are facing.

# Poverty and inequality

Governance through Development locates the Poverty Reduction Strategy Paper (PRSP) framework within the broader context of international law and global governance, exploring its impact on third world state engagement with the global political economy and the international regulatory norms and institutions which support it. The PRSP framework has replaced the controversial structural adjustment

programmes, as the primary mechanism through which official development financing is channelled to low-income developing countries. It has changed the regulatory landscape of international development financing, signalling a wider paradigmatic shift in the cartography of aid and, consequently, in the nature of north-south relations. Governance through Development documents and analyses this change within the legacy of postcolonial economic relations, revealing the wider legal, economic and geo-political significance of the PRSP framework. Celine Tan argues that the PRSP framework establishes a new regulatory regime that builds upon the disciplinary project of structural adjustment by embedding neoliberal economic conditionalities within a regime of domestic governance and public policy reform. The book will be of interest to scholars, researchers and students of law, political science and international relations, sociology and development studies.

# The Uniting of Nations

Why are some people poor? Why does absolute poverty persist despite substantial economic growth? What types of late economic development or 'catch-up' capitalism are associated with different poverty outcomes? Global Poverty addresses these apparently simple questions and the extent to which the answers may be shifting. One might expect global poverty to be focused in the world's poorest countries, usually defined as low-income countries, or least developed countries, or 'fragile states'. However, most of the world's absolute poor by monetary or multi-dimensional poverty - up to a billion people - live in growing and largely stable middle-income countries. At the same time, poverty has not fallen as much as the substantial economic growth would warrant. As a consequence, and as domestic resources have grown, much of global poverty has become less about a lack of domestic resources and more about questions of national inequality, social policy and welfare regimes, and patterns of economic development pursued.

# Governance through Development

In this book Edward and Sumner argue that to better understand the impact of global growth on poverty it is necessary to consider what happens across a wide range of poverty lines. Starting with the same datasets used to produce official estimates of global poverty, they create a model of global consumption that spans the entire world's population. They go on to demonstrate how their model can be utilised to understand how different poverty lines imply very different visions of how the global economy needs to work in order for poverty to be eradicated.

# **Global Poverty**
