Pliny the Book-maker

Pliny the Younger (c. 60-112 C.E.)--senator and consul in the Rome of emperors Domitian and Trajan, eyewitness to the eruption of Vesuvius in 79, and early 'persecutor' of Christians on the

Black Sea--remains Rome's best documented private individual between Cicero and Augustine. No Roman writer, not even Vergil, ties his identity to the regions of Italy more successfully than Pliny. His individuality can be captured by focusing on the range of locales in which he lived: from his hometown of Comum (Como) at the foot of the Italian Alps, down through the villa and farms he owned in Umbria, to the senate and courtrooms of Rome and the magnificent residence he owned on the coast near the capital. Organized geographically, *Man of High Empire* is the first full-scale biography devoted solely to the Younger Pliny. Reserved, punctilious, occasionally patronizing, and perhaps inclined to overvalue his achievements, Pliny has seemed to some the ancient equivalent of Mr. Collins, the unctuous vicar of Jane Austen's *Pride and Prejudice*. Roy K. Gibson reveals a man more complex than this unfair comparison suggests. An innovating landowner in Umbria and a deeply generous benefactor in Comum, Pliny is also a consul who plays with words in Rome and dispenses summary justice in the provinces. A solicitous, if rather traditional, husband in northern Italy, Pliny is also a literary modernist in Rome, and--more surprisingly--a secret pessimist about Trajan, the 'best' of emperors. Pliny's life is a window on to the Empire at its zenith. The book concludes with an archaeological tour guide of the sites associated with Pliny.

Reading the Letters of Pliny the Younger

Letters are famously easy to recognise, notoriously hard to define. Both real and fictitious letters can look identical to the point that there are no formal criteria which can distinguish one from the other. This has long been a point of anxiety in scholarship which has considered the value of an ancient letter to be determined by its authenticity, necessitating a strict binary opposition of genuine as opposed to fake letters. This volume challenges this dichotomy directly. Rather than defining epistolary fiction as a literary genre in opposition to 'genuine' letters or reducing it down to fixed rhetorical features, it argues that fiction is an inherent and fluid property of letters which ancient writers recognised and exploited. This volume contributes to wider scholarship on ancient fiction by demonstrating through the multiplicity of genres, contexts, and time periods discussed how complex and multifaceted ancient awareness of fictionality was. As such, this volume shows that letters are uniquely well-placed to unsettle disciplinary boundaries of fact and fiction, authentic and spurious, and that this allows for a deeper understanding of how ancient writers conceptualised and manipulated the fictional potential of letters.

The large collection of letters by Pliny the Younger includes a number of women among its addressees, and Pliny also gives us plentiful information about many women of his acquaintance. This book brings together this material to build up a portrait of a peer-group of women in their social setting.

The Women of Pliny's Letters

Many new and fruitful avenues of investigation open up when scholars consider forgery as a creative act rather than a crime. We invited authors to contribute work without imposing any restrictions beyond a willingness to consider new approaches to the subject of ancient fakes, forgeries, and questions of authenticity. The result is this volume, in which our aim is to display some of the many possibilities available to scholarship. The exposure of fraud and the pursuit of truth may still be valid scholarly goals, but they implicitly demand that we confront the status of any text as a focal point for matters of belief and conviction. Recent approaches to forgery have begun to ask new questions, some intended purely for the sake of debate: Ought we to consider any author to have some inherent authenticity that precludes the possibility of a forger's successful parody? If every fake text has a real context, what can be learned about the cultural circumstances which give rise to forgeries? If every real text can potentially engender a parallel history of fakes, what can this alternative narrative teach us? What epistemological prejudices can lead us to swear a fake is genuine, or dismiss the real thing as inauthentic? Following *Splendide Mendax* and *Animo Decipiendi?*, this is the latest installment of an ongoing inquiry, conducted by scholars in numerous countries, into how the ancient world - its literature and culture, its history and art - appears when viewed through the lens of fakes and forgeries, sincerities and authenticities,

genuine signatures and pseudepigrapha. How does scholarship tell the truth if evidence doesn't? But *fabula docet*: The *falsum* does not simply make the great, annoying stone before the door of the truth (otherwise this here would really be a "council of antiquarians and paleographers"). The *falsum* makes a delicate, fine tissue. It allows the *verum* to shine through, in nuances and reliefs that were less noticeable without its counterpart, really tied at the head. And, treated differentiated, it becomes even itself *perlucidum*, shines out with "hidden values."

Paul's Letters and Contemporary Greco-Roman Literature

This is a wide-ranging collection of essays on ancient Roman literary careers and their reception in later European literature, with contributions by leading experts. Starting from the three major Roman models for constructing a literary career - Virgil (the *rota Vergiliana*), Horace and Ovid - the volume then looks at alternative and counter-models in antiquity: Propertius, Juvenal, Cicero and Pliny. A range of post-antique responses to the ancient patterns is examined, from Dante to Wordsworth, and including Petrarch, Shakespeare, Milton, Marvell, Dryden and Goethe. These chapters pose the question of the continuing relevance of ancient career models as ideas of authorship change over the centuries, leading to varying engagements and disengagements with classical literary careers. The volume also

considers other ways of concluding or extending a literary career, such as bookburning and figurative metempsychosis.

Classical Literary Careers and their Reception

Questions on identity have been often the main focus of Classical Studies. The starting point of this book is that identity is not a monolithic idea. Instead of exploring what exactly 'identity' is, the contributors here examine how the concept of 'self-presentation' can facilitate our understanding of how individuals present their identities. Moreover, the interpretation of the means and character of this self-presentation itself enables more general conclusions to be drawn. Topics covered in this volume include identities shaped through the self-presentation of authors in Latin literature, and explorations on epigraphy and historical analyses. Overall, using the theme of self-presentation, the contributors offer a glimpse into various subjects and suggest new ways for students and scholars to approach the different forms of individual and communal identities.

Self-Presentation and Identity in the Roman World

The 13 essays presented here shed new light on the role of panegyric in the western and eastern Roman Empire in the late antique world. Introductory chapters give an overview of panegyric theory and practice, followed by studies of major writers of the early empire and the anonymous *Panegyrici latini*. The core of the volume deals with prose and verse panegyric under the Christian Roman Empire (4th-7th century): key themes addressed are social and political context, the 'hidden agenda', and the impact of Christianity on the pagan tradition of the panegyric, including the portrayal of patriarchs and holy men.

A History of Roman Literature

This is an original collection of essays that contribute to a developing appreciation of persuasion across ancient genres (mainly oratory, historiography, poetry) and a wide diversity of interdisciplinary topics (performance, language, style, emotions, gender, argumentation and narrative, politics).

The Propaganda of Power

Imitation was central to Roman culture, and a staple of Latin poetry. But it was also fundamental to prose. As a young man Pliny had studied with Quintilian. In the *Epistles* he meticulously transforms and subsumes his teacher's masterpiece, together with poetry and prose ranging from Homer to Tacitus' *Dialogus de oratoribus*. In teasing apart Pliny's rich intertextual weave, this book reinterprets Quintilian through the eyes of one of his sharpest readers, radically reassesses the *Epistles* as a work of minute textual artistry, and makes a major intervention in scholarly debates on intertextuality, imitation and rhetorical culture at Rome. The result is a landmark study with far-reaching implications for how we read Latin literature.

The Ancient Art of Persuasion across Genres and Topics

This unique study considers the exegetical and hermeneutical possibilities of analyzing the entire letter of 1 Thessalonians as a letter of consolation. Abraham Smith maintains that Paul wrote 1 Thessalonians with a full knowledge of the tradition of Greco-Roman letters of consolation and chose this genre to sustain members of the Thessalonian church. Smith explicates the social and literary conventions of this tradition and fully discloses why this particular rhetoric of care was employed. Showing how Paul's letter of consolation was understood in Paul's world and by subsequent generations, Smith demonstrates the usefulness of Paul's rhetoric of comfort for modern society.

The Arts of Imitation in Latin Prose

The renowned Gallic poet Pacatus Drepanius journeyed to Rome in the summer of AD 389 to deliver a speech to the Emperor Theodosius; both men stood for the first time before the Roman Senators. This edition provides a complete Latin text and English translation, with extensive introduction and full commentary.

Comfort One Another

The construction of a new Latin library between the end of the Republic and the Augustan Principate was anything but an inhibiting factor. The literary flourishing of the Flavian age shows that awareness of this canon rather stimulated creative tension. In the changing socio-cultural context, daring innovations transform the genres of poetry and prose. This volume, which collects papers by influential scholars of early Imperial literature, sheds light on the productive dynamics of the ancient genre system and can also offer insightful perspectives to a non-classicist readership.

A Commentary on Panegyrici Latini II(12)

In 89 BC, Roman legionaries intervened in the Black Sea region to curb the ambitions of Mithridates VI of Pontus. Over the next two centuries, the Roman presence on the Black Sea coast was slowly, but steadily increased. This volume deals with the Roman impact on the indigenous population in the Black Sea region and touches on the theme of romanisation of that area. Nine different contributors discuss several aspects of Roman identity and the cultural interaction - one article even compares the situation to the American presence in Iraq - though at the same time, it also looks at the resistance to the Roman Empire and the Roman problems of creating peace in the region after the colonisation. Romanisation and becoming Roman in a Greek world is a very popular field of discussion about which a lot has already been written. This book, however, encircles three important themes - the domination, the romanisation and the resistance. It covers two different sides of the Roman presence in the area and shows both the perspective of a Roman just arrived, Pliny the Younger, and a native seeing the Romans coming, the historian Memnon of Herakleia. Furthermore it describes how multi-identity cultures manage to live together because becoming Roman not necessarily means becoming less Greek (or less Gaulish, less Scythian, less Bosporan, etc.). The diversity of the different chapters in this book creates reflection on the cultural change in the traditionalist, yet cosmopolitan environment that was the Roman Black Sea Region.

The book also explores the strategies of politeness employed by Cicero and his correspondents when making requests and dispensing advice, and when engaging in epistolary disagreements. (His exchanges with Appius Claudius Pulcher, Munatius Plancus, and Mark Antony receive particular emphasis.) Its detailed analysis of specific letters places the reader at the very heart of Late Republican political negotiations and provides a new critical approach to Latin epistolography.

That said, this book-length essay is still worth reading as a fascinating social history of its times and for its warm evocation of the elements of the English character, some of which linger on, some of which have disappeared.

From the time they spent in a tiny village tending goats and chickens, through the Spanish Civil War, to the couple's narrow escape from the destruction of their London flat during a German bombing raid, and their adoption of a baby boy, Eileen is the first account of the Blairs' nine-year marriage. It is also a vivid picture of bohemianism, political engagement, and sexual freedom in the 1930s and '40s. even more so. 'Doublethink' features in *Nineteen Eighty-Four* and it is the forerunner to 'Fake News'. He foresaw the creation of the EU and more significantly he predicted that post-Imperial xenophobia would cause Britain to leave it. His struggle with his own antisemitism could serve as a lesson to today's Labour Party and while the Soviet Union is gone, China has taken its place as a totalitarian superpower.
