#### Literary Retranslation in Context

This book proposes a new model for the translation-oriented analysis of multimodal source texts. She openly challenges the traditional view that sees translators focusing their attention mostly on the linguistic aspect of source material in their work. The central theoretical pivot around which the analytical model revolves is that multimodal texts communicate through individual images and linguistic units, as well as through the interaction among textual resources and the text's interaction with its context of reference. This three-dimensional view offers a holistic understanding of multimodal texts and their potential translation issues to help translators improve the way they communicate multimodally across languages and cultures. *Mineral Water: From Basic Research to Clinical Applications*, written by a multi-disciplinary group of educators, researchers and medical doctors, gathers a timely review on the effects of mineral waters upon several aspects of human biology and pathophysiology, as it gives an overview of how mineral

### Multimodal Pragmatics and Translation

*Quantifiers: Logics, Models and Computation* is the first concentrated effort to give a systematic presentation of the main research results on the subject, since the modern concept was formulated in the late '50s and early '60s. The majority of the papers are in the nature of a handbook. All of them are self-contained, at various levels of difficulty. The Introduction surveys the main ideas and problems encountered in the logical investigation of quantifiers. The Prologue, written by Per Lindström, presents the early history of the concept of generalised quantifiers. The volume then continues with a series of papers surveying various research areas, particularly those that are of current interest. Together they provide introductions to the subject from the points of view of mathematics, linguistics, and theoretical computer science. The present volume has been prepared in parallel with *Quantifiers: Logics, Models and Computation, Volume Two. Contributions*, which contains a collection of research papers on the subject in areas that are too fresh to be summarised. The two volumes are complementary. For logicians, mathematicians, philosophers, linguists and computer scientists. Suitable as a text for advanced undergraduate and graduate specialised courses in logic.

### Mineral Water

This book argues that narrative literature very often, if not always, include significant amounts of what appears to be extra-literary material – in form and in content – and that we too often ignore this dimension of literature. It offers an up to date overview and discussion of intermedial theory, and it facilitates a much-needed dialogue between the burgeoning field of intermedial studies on the one side and the already well-developed methods of literary analysis on the other. The book aims at working these two fields together into a productive working method. It makes evident, in a methodologically succinct way, the necessity of approaching literature with an intermedial terminology by way of a relatively simple but never the less productive three-step analytic method. In four in-depth case studies of Anglophone texts ranging from Nabokov, Chandler and Tobias Wolff to Jennifer Egan, it demonstrates that medialities matter.

### Quantifiers: Logics, Models and Computation

How do media inform our representations of the Other and how does this influence intercultural / international relations? While officially dialogues between different national societies are conducted by diplomats in bilateral and multilateral settings, in practice journalists also participate every day in such dialogues through the phenomenon of the “international media echo” in which they report on each others’ societies. Until now, media have only been investigated for their potential role in the foreign policy of specific states. In a case study involving media in three national cultures and languages (French, American and Russian), this book presents an interdisciplinary framework that combines quantitative and qualitative analyses for the study of the international media echo in an intercultural / international relations perspective. In particular, the fundamental functioning of “spirals of anti-Other rhetoric”, i.e. media wars, is examined in a Critical Discourse Analysis approach completed with Social Identity Theory and International Relations theories.

## The Intermediality of Narrative Literature

These papers constitute the proceedings of a conference held in March 2003, the object of which was to build bridges between animal research and clinical approaches for studying mental health and disorders in children and adolescents. There are 28 papers and 15 posters altogether.
