only the EU Commission can propose directives or legally binding regulations.

The way it works, the EU Commission listens to views across Europe

At this stage, MEPs are involved in the process, often adopting recommendations.

Since 2012, EU citizens can also directly request new draft laws.

the European Commission finally presents its bill.

This is the start of a long, legislative process that generally takes 12-18 months.

The draft is then sent to the EU Council, representing the States

In 80% of cases, the two institutions have equal power.

Before being adopted they go through the institutional mill.

There are two possible scenarios: either the two institutions find a compromise

and the draft law can be adopted by MEPs after a vote

If the negotiations fail once, the clock starts ticking

When there is agreement, the new EU law is officially adopted

Sometimes Member States receive what is known as a derogation
