## Tess of the D'Urbervilles

The co-ordinating theme of this study is that Hardy designed Tess of the d'Urbervilles to be controversial, and it has surpassed his design. An initial biographical chapter relates Tess to Hardy's career: the novel caused scandal but brought him wealth. Next, the work's process of composition is discussed, and differences between the censored serial and the book versions are explained. An analysis of the plot gives particular attention to its ironic strategies, and a further section deals with problematic aspects of characterisation, including the views of the narrator. Various themes and contexts are explored, notably Hardy's attitudes to religion, evolution, politics and sexuality. There follows a discussion of selected literary aspects: naturalism and realism, leitmotifs and thematic patterns, optical effects and defamiliarisation, and the use of specialised vocabularies. Hardy's descriptive powers when rendering the rural world receive particular analysis. A critical survey then summarises critical approaches to this novel between Hardy's day and the present.

## Thomas Hardy: 'Tess of the d'Urbevilles'

The first comprehensive look at how Victorian fiction and British psychoanalysis shaped each other *Novel Relations* engages twentieth-century post-Freudian British psychoanalysis in an unprecedented way: as literary theory. Placing the writing of figures like D. W. Winnicott, W. R. Bion, Michael and Enid Balint, Joan Riviere, Paula Heimann, and Betty Joseph in conversation with canonical Victorian fiction, Alicia Christoff reveals just how much object relations can teach us about how and why we read. These thinkers illustrate the ever-shifting impact our relations with others have on the psyche, and help us see how literary figures—characters, narrators, authors, and other readers—shape and structure us too. For Christoff, novels are charged relational fields. Closely reading novels by George Eliot and Thomas Hardy, Christoff shows that traditional understandings of Victorian fiction change when we fully recognize the object relations of reading. It is not by chance that British psychoanalysis illuminates underappreciated aspects of Victorian fiction so vibrantly: Victorian novels shaped modern psychoanalytic theories of psyche and relationality—including the eclipsing of empire and race in the construction of subject. Relational reading opens up both Victorian fiction and psychoanalysis to wider political and postcolonial dimensions, while prompting a closer engagement with work in such areas as critical race theory and gender and sexuality studies. The first book to examine at length the connections between British psychoanalysis and Victorian fiction, *Novel Relations* describes the impact of literary form on readers and on twentieth- and twenty-first-century theories of the subject.

First published serially in 1891 in "The Graphic," an illustrated British newspaper, "Tess of the d'Urbervilles" is one of the last novels written by Thomas Hardy. It is the titular story of Teresa "Tess" Durbeyfield, the oldest child of John and Joan Durbeyfield. The Durbeyfields are a poor family living in rural England who are led to believe by a local parson that they may actually be related to the d'Urbervilles, a noble Norman family. Trying to capitalize on this knowledge the Durbeyfields send a reluctant Tess to work at the d'Urberville's estate, a rural mansion in the nearby town of Trantridge. Tess is able to secure a position as a poultry keeper on the estate when she draws the interest of the family's libertine son, Alec. Tess dislikes Alec but endures his unwanted advances in order to help her family, a compromise that will ultimately lead to her ruin. Because it challenged the sexual morals of late Victorian England, "Tess of the d'Urbervilles" was harshly criticized following its initial publication,

however since that time it has come to be regarded by many as Thomas Hardy's fictional masterpiece. This edition is printed on premium acid-free paper.

Thomas Hardy (1840-1928) was an English novelist and poet. A Victorian realist in the tradition of George Eliot, he was influenced both in his novels and in his poetry by Romanticism, especially William Wordsworth and Charles Dickens. Like Dickens, he was highly critical of much in Victorian society, though Hardy focused more on a declining rural society. While Hardy regarded himself primarily as a poet, initially he gained fame as the author of novels, including *Far from the Madding Crowd*, *Tess of the d'Urbervilles* and *Jude the Obscure*. Most of his fictional works were set in the semi-fictional region of Wessex. They explored tragic characters struggling against their passions and social circumstances.

### The Future of the Nineteenth-Century Dream-Child

This study seeks to develop a new context for reading later Victorian fiction and for understanding the process of 'secularization'. Norman Vance explores how the novels of George Eliot, Thomas Hardy, Mary Ward, and Rider Haggard acquired greater cultural centrality, just as the authority of the scriptures and of traditional religious teaching seemed to be declining, and offered a new forum for the exploration of religious and moral themes.
