Waiting on the Spirit of Promise is a study of the life and ministry of Abraham Cheare (1626-1668), containing selections from Cheare's works, and rescuing an important seventeenth-century Baptist from obscurity. Cheare has been overshadowed by other more celebrated Baptist contemporaries, but as the pastor of the Particular Baptist work in Plymouth, Devon, Cheare played a key role in the advance of the Baptist cause in the West Country in the 1650s. His Sighs for Sion is an excellent illustration of early Baptist piety. With the Restoration of the monarchy in 1660, Cheare, like many other Dissenters, suffered arrest for his refusal to give up preaching. Cheare's prison writings reveal both a sturdy faith in God and a deep-seated piety. Despite the fact that he was incarcerated in a series of "nasty prisons," Cheare used this time of suffering to deepen his walk with God and so provide a model for his congregation of Christian integrity and joy in the midst of trial. To the very end of his life, Cheare eagerly awaited further outpourings of the Spirit of Promise upon the Church and looked forward to that day when his Lord Jesus would make all things right.

America, as we know it today, came precariously close to not existing; the tipping point was the arrival of one man, the much-travelled Squanto, who became the fragile link between a group of starving English refugees, Shakespeare's London and the native population. Nearly 400 years later, Sir Ian McKellen is giving a lecture on Shakespeare in America, when a member of the audience shows him a signature that piques his interest. A few words on old parchment take him on a voyage back in time that completely overturns everything he thought he knew about the origins of Thanksgiving. A visually spectacular story, massive in scope that revisits the debate about refugees, not only from a historical perspective but around the very issues that confront us today. The decisions our ancestors made were not just a reaction to what they were confronted with in the here and now but of what they wanted to happen tomorrow. The Pilgrims had a very particular vision of the new world they wanted to create, and the clashes between the vastly different perspectives of natives and refugees had an enormous long-term impact. This book is based on detailed research and all the historical characters from 1620 are real people. This novel simply asks questions about Squanto's travels and how several hundred years of interaction between America and Europe prior to 1620 would have influenced the fate of the Pilgrim refugees.

The contributors to this book have explored various aspects of urban imagination, so intimately related to a peculiar social environment. They are historians and geographers, linguists and cultural students. Their methodologies are very different, their sources poles apart. And yet, they address the same object of study, social and spatial segregation and urban eruptions, though severally defined: from epidemics to anarchist scares, urban uprisings to mental maps, or the reverberations of urban memories in song, novels and museums. Case studies consider the towns of Liverpool, London, Hull, New York, Salvador de Bahia, or more generally France and America. The networks created among intellectuals and labourers, anarchists and migrants, or the lack of communication between those who feel oppressed (rioters, strikers, anti-vaccination protesters) and those in control, are a further common denominator. In a way, urban epidemics were the epitome of the repulsive character large cities possessed in the eyes even of their own inhabitants. If they were the receptacle of so many foreigners, and shady political characters, if they were the scenes of social and ethnic conflict, and violence, and promiscuity, and prostitution, and drunkenness, and pauperism, they were of necessity a festering sore which nothing could eradicate. It is strange that something of this fear should linger on today—otherwise, how can one explain the lacunae in the official memory of museums?—despite the cultural efforts produced in the opposite direction, with Ackroyd's love for East-End London, with the revival of a Little Italy in every major American city, with the nostalgic folklorisation of past miseries in Salvador de Bahia and in popular song. What sense of belonging can be generated by an obliteration of the past, what dynamic local culture can spring from an absence, from a hole in collective memory? This book goes some way to filling those gaps.
