The importance of technology in our day to day lives is something that few people would deny. At home and in the office, in business and in politics, the effects of technology are pervasive. In this important new study, Anthony DiFilippo examines one specific aspect of this issue: the forces of political economy that direct the course of industrial technology. At the same time, foreign nations have improved their technological capacities through comprehensive, civilian-supported industrial policies. To improve U.S. competitiveness, manufacturing, productivity, and, ultimately, the standard of living, DiFilippo shows that technological resources must be shifted to the civilian sector. He examines a wide range of issues surrounding the topic, from the demise of the post-industrial economy and the conventional explanations for competitive decline to the resource drain of advanced warfare and the industrial policies of Japan, West Germany, and France. An extensive set of charts and tables support DiFilippo's argument and point out some of the serious economic problems the U.S. approach to high technology has caused. A bibliography of selected works is also provided. With its pertinence to current economic, political, and technological issues, From Industry to Arms will be a valuable resource for courses in government and business, political economy, policy analysis, and science and technology. #### Sources of Industrial Leadership

This book describes and analyzes how seven major high-tech industries evolved in the United States, Japan, and Western Europe. By reconsidering the previously accepted explanation of the economic impact of the British defence effort during the immediate post-war period, this book convincingly suggests that British foreign policy-makers retained a large defence budget to offset a sense of increased national vulnerability, brought about by a reduction in Britain's economic strength due to her war effort. Furthermore, it is shown that although this level of military spending may have slightly hampered post-war recovery, it was not in itself responsible for the decline of the British economy.

#### American Studies

## The Economics of Conflict and Peace

German industry in particular is a central focus for studying technical and organizational changes in industry due to its pivotal position in international markets, its technological sophistication and its well-established training systems. Originally published in 1992, this study brings together contributions which contain both theoretical approaches and extensive empirical studies, on the manufacturing industry in Germany, including comparisons to other european countries. It looks at the developments

of new technology, identifying trends in rationalization and the influences they have on organizational behaviour. As it discusses the relationships between technology and the work-force it includes discussion on flexible specialization, labour processes, union relations, small and large firms and training processes.

## Technology and Work in German Industry

What does the future hold for the UN? # The Future of the United Nations System

## The Economics of Defence, Disarmament, and Peace

This paper on the numerically controlled (NC) machine tool industry is part of a broader study conducted by the RAND Graduate School's Civil and Military Technology Workshop led by Dick Neu. The class efforts were directed towards analyzing the relationship between research and development (R & D) investment in the military and civilian sectors of the U.S. economy. That is, we addressed the topic of how military R & D investments might have a synergistic or spillover effect upon the civilian economy, or relatedly, how military investments might be used to overcome existing market failures in dual military/civilian industries. Additionally, we looked for evidence to suggest that military investments have had a negative impact on civilian technological development, by crowding out civil investments and raising the market prices of inputs. Each student wrote a substantial case study of an industry to evaluate the governments's role in its success or failure. Besides NC machine tools, the industries included airframes, parallel processing, the early development of computers, and semiconductors. (kr).

## The U.S. Machine Tool Industry and the Defense Industrial Base

This title was first published in 2000: Steven Nivin analyzes a process vital to economic development - technological change. He furthers understanding of the processes driving innovation, so that we may gain a deeper insight into the development of economies. Specifically, the study explores the concept of innovation potential and the factors that result in variations in innovation potential across metropolitan areas, using the US machine tool industry as a case study. To provide a comparison, the same models are also estimated for the semiconductor industry. The findings indicate that urbanisation

economies, localization economies, human capital, universities, and invention-derived knowledge are significant factors. The study assesses the contributions of three different skill levels of human capital; college-educated, graduate degree, and locally produced PhD's in mechanical and electrical engineering. Only the graduate and PhD degree measures are found to be significant, indicating the importance of having a highly skilled pool of labour within the region. The influences of the factors appear to be similar across industries, with some slight differences. The transfer of knowledge through patents is also studied. It is found that the transmission of this knowledge is slower between different industries, relative to the transmission within the same industry.

## Growth and Decline of American Industry

The 1970s and 1980s witnessed growing concern in the United States regarding the relative decline of the American economy and, for defense planners, the military's growing dependence on foreign production of weapons' parts and subcomponents—the guts of many critical weapons systems. The period also witnessed growing interest in industrial policy as a tool for promoting U.S. international competitiveness, defense sectors proving to be particularly attractive candidates for government economic intervention. This study traces the evolution of defense dependence and the U.S. government's response to this dilemma by examining policy ideas and experiments in four defense industries—machine tools, semiconductor manufacturing, ball bearings, and high-definition television technologies—explaining successes and failures, and reviewing prospects for expansion.

#### Responding to Defense Dependence

On February 4, 1986, the lives of thousands of workers changed in ways they could only begin to imagine. On that day, United Technologies Corporation ordered the closure of the 76-year-old American Bosch manufacturing plant in Springfield, Massachusetts, capping a nearly 32-year history of job loss and work relocation from the sprawling factory. The author, a former Bosch worker and the business agent for the union representing nearly 1,200 Bosch employees when the plant closed, interjects his personal recollections into the story. For more than 150 years Springfield stood at the center of a prosperous 200-mile industrial corridor along the Connecticut River, between Bridgeport, Connecticut, and Springfield, Vermont, populated with hundreds of machine tool and metalworking plants and thousands of workers. The closure marked the watershed for large-firm metalworking and metalworking unions in the Connecticut River Valley. The book also describes how the United States, in a ten-year period from the mid-1970s to the mid-1980s, went from being the world's leading exporter of machine tools to its leading importer, and how that sharp decline affected the region's leading city, Springfield, Massachusetts, which by 2005 was in danger of bankruptcy.

## Corporate Governance and Sustainable Prosperity

For five decades the American economy has devoted some of its best resources to waging the Cold War. By the 1990s, this investment had not only made the United States the world's high-tech cop but had also successfully launched many new industries--computing, chip-based electronics, and satellite communications.
