## Balancing Work and Family in a Changing Society

Both research and policy on balancing work and family life have tended to focus on mothers' lives. There has been a general lack of comparative research to the complex intersection between old and new forms of masculinity; and between fatherhood, work-life balance, gender relations and children's well-being. As a result, men's fathering roles and their struggle with work-life balance have often been neglected. These cultural challenges should be better theorized within family and social policy

research. This volume examines how fathers fulfill their roles both within the family and at work and what institutional support could be of most benefit to them in combining these roles.

### Father Involvement in the Early Years

Jean-Jaques Rousseau's "Emile" argues against distant, unfamiliar carers to teach children because the only genuinely reputable education can come from a father. As much as one may agree with this, reality must be faced: Firstly, no dad has the time anymore to fully provide for his child's learning. Secondly, friendship and strong supporting interpersonal bonds are on the decline since members of Western societies are increasingly able to survive just on their own. Keeping these facts in mind, one may evaluate the current situation in Great Britain in research, politics, and practice on how fathers can be included into their children's education with the help of nursery settings.

### Parenting Matters

Decades of research have demonstrated that the parent-child dyad and the environment of the family—which includes all primary caregivers—are at the foundation of children's well-being and healthy development. From birth, children are learning and rely on parents and the other caregivers in their lives to protect and care for them. The impact of parents may never be greater than during the earliest years of life, when a child's brain is rapidly developing and when nearly all of her or his experiences are created and shaped by parents and the family environment. Parents help children build and refine their knowledge and skills, charting a trajectory for their health and well-being during childhood and beyond. The experience of parenting also impacts parents themselves. For instance, parenting can enrich and give focus to parents' lives; generate stress or calm; and create any number of emotions, including feelings of happiness, sadness, fulfillment, and anger. Parenting of young children today takes place in the context of significant ongoing developments. These include: a rapidly growing body of science on early childhood, increases in funding for programs and services for families,

changing demographics of the U.S. population, and greater diversity of family structure. Additionally, parenting is increasingly being shaped by technology and increased access to information about parenting. Parenting Matters identifies parenting knowledge, attitudes, and practices associated with positive developmental outcomes in children ages 0-8; universal/preventive and targeted strategies used in a variety of settings that have been effective with parents of young children and that support the identified knowledge, attitudes, and practices; and barriers to and facilitators for parents' use of practices that lead to healthy child outcomes as well as their participation in effective programs and services. This report makes recommendations directed at an array of stakeholders, for promoting the wide-scale adoption of effective programs and services for parents and on areas that warrant further research to inform policy and practice. It is meant to serve as a roadmap for the future of parenting policy, research, and practice in the United States.

### Father-Daughter Relationships

How fathers affect their daughters' social, academic, intellectual, athletic, and psychological development is then considered. Factors that can weaken father-daughter relationships, such as divorce, including various theoretical perspectives, are explored in chapters 5 and 6. Father-daughter relationships of racial or ethnic minorities and an array of potentially destructive situations that affect these relationships are the focus of chapters 7 and 8. The impact of fathers who are incarcerated, abusive, alcoholics, gay, or sperm donors are considered. The book concludes with suggestions on where we go from here.

### Comparative Perspectives on Work-Life Balance and Gender Equality

The book brings together three major theoretical strands: social policy, in particular the literature on comparative leave policy developments; family and gender studies, in particular the analysis of gendered divisions of work and care and recent shifts in parenting and work-family balance; critical studies of men and masculinities, with a specific focus on fathers and fathering in contemporary western societies and life-courses. Drawing on empirical data from in-depth interviews with fathers across eleven countries, the book shows that the experiences and social processes associated with fathers' home alone leave involve a diversity of trends, revealing both innovations and absence of change, including pluralization as well as the constraining influence of policy, gender, and social context. As a theoretical and empirical book it raises important issues on modernization of the life course and the family in contemporary societies. The book will be of particular interest to scholars in comparing western societies and welfare states as well as to scholars seeking to understand changing work-life policies and family life in societies with different social and historical pathways.

### New Research on Parenting Programs for Low-Income Fathers

This book presents state-of-the-art findings of research on fatherhood programs, funded by the Fatherhood Research and Practice Network (FRPN), which advance knowledge and practice in the fathering field. New Research on Parenting Programs for Low-Income Fathers includes research on how to engage mothers to support father-child contact and to successfully employ social media and online technology for practice. It offers findings on how to increase paternal engagement and parenting skills and to include fathers in policies and programs for children and families. It discusses the importance

of providing staff training and resources to practitioners who work directly with fathers. Chapters also provide summaries of key implications for evidence-based practice and future directions for research that encourage effective fatherhood practice. This book is an excellent resource for therapists, social workers, fatherhood educators, fatherhood practitioners, researchers, and policy makers on how to inspire positive father engagement with children and healthy coparenting relationships.

### Social Work with Fathers

The majority of fathers, father-substitutes and father figures wish to do well by their children. However, as a number of high profile cases testify, fathers often feel that they receive poor treatment at the hands of the social care system. Recent research points to the value of involved parenting by fathers while government policy initiatives, such as the Gender Equality Duty in Scotland, have attempted to stress the importance of involving fathers in their child care. Gary Clapton proposes a father sensitive, father aware social work practice and suggests that any social care system that adopts a default position that child care is the responsibility of women alone is hampered by its failure to acknowledge the positive potential of fathers. The arguments advanced in this book concentrate on children and family practice but do not neglect the importance of fatherhood in social work with vulnerable adults, fathers as carers, or in the criminal justice system. Social Work with Fathers will assist those working within social care and children's services, students of social care and social work and policy makers.

### Conceptualizing and Measuring Father Involvement

After decades of focusing on the mother's role in parenting, family studies researchers have turned their attention to the role of the father in parenting and family development. The results shed new light on childhood development and question conventional wisdom by showing that beyond providing the more traditional economic support of the family, fathers do indeed matter when it comes to raising a child. Stemming from a series of workshops and publications sponsored by the Family and Child Well-Being Network, under the federal fatherhood initiative of the National Institute of Child Health and Development, this comprehensive volume focuses on ways of measuring the efficacy of father involvement in different scenarios, using different methods of assessment and different populations. In the process, new research strategies and new parental paradigms have been formulated to include paternal involvement. Part V explores the fatherhood service delivery system by engaging fathers in culturally competent services, measuring the father's involvement, and the initiatives to support fathering. The context, practice, and gaps in responsible fatherhood programs are discussed. This informative and sensitive book will be useful for researchers, students, and professionals in the field of social work, health, family counseling, and human services. ### Fathers, Families and Relationships

Debates about the future of fatherhood have been central to a range of conversations about changing family forms, parenting and society. Law has served an important, yet often neglected, role in these discussions, serving as an important focal point for broader political frustrations, playing a central role in mediating disputes, and operating as a significant, symbolic, state-sanctioned account of the scope of paternal rights and responsibilities. *Fragmenting Fatherhood* provides the first sustained engagement with the way that fatherhood has been understood, constructed and regulated within English law. Drawing on a range of disparate legal provisions and material from diverse disciplines, it sketches the major contours of the figure of the father as drawn in law and social policy, tracing shifts in legal and broader understandings of what it means to be a 'father' and what rights and obligations should accrue to that status. In thematically linked chapters cutting across substantive areas of law, the book locates fatherhood as a key site of contestation within broader political debates regarding the family and gender equality. Multiple visions of fatherhood, evolving unevenly over time across diverse areas of law, emerge from this analysis. Fatherhood is revealed as an essentially fragmented status and one which is intertwined in complex ways with the legal, cultural and political contexts in which discourses of parenthood are produced. *Fragmenting Fatherhood* provides an important and unique resource, speaking to debates about fatherhood across a range of fields including law and legal theory, sociology, gender studies, social policy, marriage and the family, women's studies and gender studies.

### Fragmenting Fatherhood

Patterns of family life are changing rapidly and; with them, the role of fathers in parenting. Fatherhood and fathering are an important concern for every practitioner, whether they are working with fathers directly, with children, couples and families, or with individuals discussing their own fathers. Yet fathers are often neglected in research and overlooked in professional practice. This book synthesises existing and original research to provide a wide-ranging overview of the salient theoretical and practical issues inherent in working with fathers. Setting its analysis in a clear context of social and cultural change, the book highlights the importance of keeping fathers in mind at all times in therapeutic work. In particular, it:

- Considers the practical challenges of engaging fathers in clinical work
- Addresses issues of difference, whether of culture, class or domestic living arrangements
- Draws on systemic, narrative and attachment theory to illuminate some of the key issues for practice
- Discusses working with fathers from a variety of angles, including mental health issues in men, domestic violence, group work and working with fathers in prisons
- Provides vivid and illuminating vignettes to illustrate issues for practice

With its strong focus and emphasis on reflective practice, this is an essential book full of thoughtful and accessible guidance for trainees and practitioners in clinical psychology, psychotherapy, family therapy, social work and related fields.

### Working with Fathers

Much of contemporary scholarship on fathers comes from a deficit model, focusing on men's inadequacies as parents. This edited volume assembles a group of prominent scholars who go beyond a deficit model of fatherhood to what the editors call a generative fathering perspective. The generative fathering approach, inspired by the developmental theories of Erik Erikson and building on the pioneering research of John Snary, sees the work fathers do for their children in terms of caring for and contributing to the life of the next generation. The editors describe generative fathering, placing it in

contrast to the role-inadequacy perspective of fatherhood. Contributors then elaborate on generative fathering in terms of gender, ethnicity, and historical perspectives and present research that helps us understand generative fathering in challenging life circumstances, such as special-needs children, teenage fathering, and divorce and remarriage. Applications for the generative fathering perspective are presented in terms of family life education, clinical work, and scholarly discourse. The editors conclude the volume with a chapter on ways to teach about generative fathering in college courses. Supported by both qualitative and quantitative research, this book goes beyond the frequent identification of fathers as primarily absent, abusive, deadbeat, deficient, or unnecessary, and helps us to understand fathers as men working to build caring bridges across generations.

### Generative Fathering

This book focuses on issues of family, work, and gender, with a focus on gender inequality. Women are disadvantaged in both paid and domestic work, due in large part to being primarily responsible for duties within the domestic sphere. The COVID-19 pandemic has exacerbated these inequalities, making the issue of reducing gender inequality even more pressing. Fathers play an important role in contributing to, and perhaps reducing, gender inequality, but barriers to their involvement in family life have received less attention than detailing challenges that mothers face. If men were equally involved in all aspects of domestic life (i.e., were fully engaged dads), women's burdens would be reduced and perceptions of who is responsible for parenting may change, resulting in greater gender equality. *Father Involvement and Gender Equality in the United States* focuses on the key issue of father involvement, seeking to understand why fathers are less involved at home than mothers despite an increased desire for fathers to be more engaged parents. This book utilizes recent national survey data, interviews with fathers, and insights from the author's personal experience as a father to identify current norms of fatherhood within the United States, barriers to father involvement, and strategies to overcome these barriers. Overall, this book argues that by establishing the expectation that fathers will be fully engaged dads as a cultural norm, and by providing structural opportunities for fathers to meet this cultural standard, greater gender equality can be achieved within the United States. The arguments presented in this book are valuable for scholars in the areas of family, work, and gender, policymakers and business leaders who seek to promote gender equality and work-family balance, and parents who are interested in achieving a more egalitarian division of labor within their own families.

### Father Involvement and Gender Equality in the United States

For too long, we've thought of fathers as little more than sources of authority and economic stability in the lives of their children. Yet cutting-edge studies drawing unexpected links between fathers and children are forcing us to reconsider our assumptions and ask new questions: What changes occur in men when they are "expecting"? Do fathers affect their children's language development? What are the risks and rewards of being an older-than-average father at the time the child is born? What happens to a father's hormone levels at every stage of his child's development, and can a child influence the father's health? Just how much do fathers matter? In *Do Fathers Matter?* the award-winning journalist and father of five Paul Raeburn overturns the many myths and stereotypes of fatherhood as he examines the latest scientific findings on the parent we've often overlooked. Drawing on research from neuroscientists, animal behaviorists, geneticists, and developmental psychologists, among others, Raeburn takes us through the various stages of fatherhood, revealing the profound physiological connections between children and fathers, from conception through adolescence and into adulthood—and the importance of the relationship between mothers and fathers. In the process, he challenges the legacy of Freud and mainstream views of parental attachment, and also explains how we can become better parents ourselves. Ultimately, Raeburn shows how the role of the father is distinctly different from that of the mother, and that embracing fathers' significance in the lives of young people is something we can all benefit from. An engrossing, eye-opening, and deeply personal book that makes a case for a new perspective on the importance of fathers in our lives no matter what our family structure, *Do Fathers Matter?* will change the way we view fatherhood today.

### Do Fathers Matter?

This book covers the underexplored subject of 'fathering' in India. It delves into the shared aspirations of men in India to nurture their children in sensitively attuned ways within the culturally prescriptive context that governs men's roles as providers and caregivers. This work is based on over two decades of intensive research in India on how different groups construct and experience fatherhood and fathering

under changing circumstances. It unmask the heterogeneity that exists within fathering in India through conversations with fathers across diverse contexts—in privileged economic situations and those in difficult home and family circumstances, having children with disability, single-parent fathers and fathers in the military. A separate section discusses fathering daughters and shared parenting. Images and role models in fathering are brought alive through analysis of Hindi films, the media, children's literature and classical literature. The conceptual analysis moves beyond the power and control dimensions commonly used to describe Indian men and fathers, to highlight their resilience, adaptability, positive involvement and developmental trajectories. This volume is for scholars, researchers and practitioners in developmental psychology, human development and family science, sociology, early childhood education and psychiatry, pediatrics, community medicine and allied fields.

### Fathering in India

Fatherhood is gaining ever more public and political attention, stimulated by the increasing prominence of fathers' rights groups and the introduction of social policies, such as paternity leave. *Intimate Fatherhood* explores discourses of contemporary fatherhood, men's parenting behaviour and debates about fathers' rights and responsibilities. The book addresses the extent to which fatherhood has changed by examining key dichotomies - culture versus conduct, involved versus uninvolved and public versus private. The book also looks at longstanding conundrums such as the apparent discrepancy between fathers' acceptance of long hours spent in paid work combined with a preference for involved fathering. Dermott maintains that our current view of good fatherhood is related to new ideas of intimacy. She argues that in order to understand contemporary fatherhood, we must recognise the centrality of the emotional father-child relationship, that the importance of breadwinning has been overstated and that flexible involvement is viewed as more important than the amount of time spent in childcare. Drawing on original qualitative interviews and large-scale quantitative research, *Intimate Fatherhood* presents a sociological analysis of contemporary fatherhood in Britain by exploring our ideas of good fatherhood in relation to time use, finance, emotion, motherhood and policy debates. This book will interest students, academics and researchers in sociology, gender studies and social policy.

### Intimate Fatherhood

This book is the first of its kind to focus specifically on children's attachment to fathers, and explores the connections among fathering, family dynamics, and attachment relationships. It includes theoretical, methodological and research reports written by an interdisciplinary group of researchers from around the globe. The purpose of this book is to familiarize the reader with the conceptualization, measurement and provisions of the attachment bond between children and their fathers, from infancy through young adulthood and across diverse individual, family, community, and cultural systems. Recent empirical findings suggest that new methods of measuring child-father attachment are warranted, and that attachment to fathers may be unique from, but complementary to attachment to mothers. These findings also suggest that attachment to fathers uniquely predicts children's healthy developmental outcomes, and these findings are robust across various contexts, but these predictive relationships are best understood within context. This book provides a summary of current scholarly knowledge of fathering and attachment, and describes future directions to be explored by professionals, policy makers and practitioners within family services, education, and social work settings. It is also of interest to the general public. This book was published as a special issue of *Early Child Development and Care*.

### Emerging Topics on Father Attachment

This handbook provides a comprehensive review of the impact of fathers on child development from prenatal years to age five. It examines the effects of the father-child relationship on the child's neurobiological development; hormonal, emotional and behavioral regulatory systems; and on the systemic embodiment of experiences into the child's mental models of self, others, and self-other relationships. The volume reflects two perspectives guiding research with fathers: Identifying positive and negative factors that influence early childhood development, specifying child outcomes, and emphasizing cultural diversity in father involvement; and examining multifaceted, specific approaches to guide father research. Key topics addressed include: Direct assessment of father parenting (rather than through maternal reports). The effects of father presence (in contrast to father absence). The full diversity of father involvement. Father's impact on gender role differentiation. Father's role in triadic interactions of family dynamics. Father involvement in psychotherapeutic family interventions. This handbook draws from converging perspectives about the role of fathers in very early child development,



summarizes what is known, and, within each chapter, draws attention to the critical questions that need to be answered in coming decades. The Handbook of Fathers and Child Development is a must-have resource for researchers, graduate students, and clinicians, therapists, and other professionals in infancy and early child development, social work, public health, developmental and clinical child psychology, pediatrics, family studies, neuroscience, juvenile justice, child and adolescent psychiatry, school and educational psychology, anthropology, sociology, and all interrelated disciplines.

### Handbook of Fathers and Child Development

We've all heard that a father's involvement enriches the lives of children. But how much have we heard about how having a child affects a father's life? As Peter Gray and Kermyt Anderson reveal, fatherhood actually alters a man's sexuality, rewires his brain, and changes his hormonal profile. His very health may suffer—in the short run—and improve in the long. These are just a few aspects of the scientific side of fatherhood explored in this book, which deciphers the findings of myriad studies and makes them accessible to the interested general reader. Since the mid-1990s Anderson and Gray, themselves fathers of young children, have been studying paternal behavior in places as diverse as Boston, Albuquerque, Cape Town, Kenya, and Jamaica. Their work combines the insights of evolutionary and comparative biology, cross-cultural analysis, and neural physiology to deepen and expand our understanding of fatherhood—from the intense involvement in childcare seen in male hunter-gatherers, to the prodigality of a Genghis Khan leaving millions of descendants, to the anonymous sperm donor in a fertility clinic. Looking at every kind of fatherhood—being a father in and out of marriage, fathering from a distance, stepfathering, and parenting by gay males—this book presents a uniquely detailed picture of how being a parent fits with men's broader social and work lives, how fatherhood evolved, and how it differs across cultures and through time.

### Fatherhood

This new edition focuses more directly on the five questions fathers commonly ask. There is a new chapter reviewing the latest research demonstrating the impact fathers have on their children. Greater recognition is given to the emerging group of men who are actively seeking to be highly involved as fathers. More options are provided for this group. Greater emphasis is given to family patterns where both parents share paid work and caring. New material has been added to the team parenting and couple relationship sections. The chapter on integrating work and family has been substantially revised and covers the latest trends and options for men to take either parental or paternity leave. It seems that what new fathers are wanting has continued to change over the last five years. The authors show that contemporary men want to: have a strong and enduring relationship with their children; be actively involved in the day-to-day care of their children; share the parenting and paid work equally with their partner; take extended leave from paid work to be the primary caregiver for a period of time; and reduce their hours of work (for example, to part-time) to be highly involved in caring for their child.

### First-Time Father

This book examines community group settings for young men who are fathers, with particular emphasis on the role of gender within the groups and the possibilities of such groups for the 'un-doing' of gender. Young men who are fathers are often marginalized and negatively portrayed within society. Groups allow them space and opportunity for peer support with other young men, to gain confidence and skills, and to positively develop their fatherhood identities. They offer young fathers opportunities to encounter new role models and can therefore help to reimagine young men who are fathers, challenging stereotypes and offering support for young men and their families. Supporting Young Men as Fathers will be of interest to students and scholars in the areas of sociology, social work, health promotion and youth work as well as practitioners working within family settings or who may encounter young men who are parents within their professional roles.

### Supporting Young Men as Fathers

This timely study explores the experiences of fathers who take on equal or primary care responsibilities for young children. Offering academic insight and practical recommendations, this will be key reading for researchers, policymakers, practitioners and students interested in contemporary families.

### Sharing Care

The *Family Context of Parenting in Children's Adaptation to Elementary School* is a result of a longitudinal prevention study of 100 families begun the year before their first children entered kindergarten. Each family went through an assessment and then a subset was randomly chosen for group intervention. The children in both groups were then studied as they progressed through kindergarten and first grade to assess the quality of their adaptation to the school environment. The text focuses on how parent-child relationships are only one determinant of a child's academic competence, social competence, and behavior. Rather, these relationships must be understood in the context of the role they play within the family as a system. It also addresses the recent challenges to claims about the impact of parents on their children's development. The book sheds additional light on family influences within the larger social environment as a key determinant of the quality of children's adjustment to schooling. It appeals to scientists, professionals, and parents alike.
