For many years I have desired to do this work, and published instalments in "The Fortnightly" and the "Athenaeum," 1909, but the decision of the Shakespeare League to raise a Memorial to them in Shoreditch, determined me to do so at once, in order to help that Memorial Scheme. Therefore the collection, arrangement and publication of my materials, have at the last been rather more hurried than I would have liked, and some details may have been left in a state of comparative incompleteness which more leisure would have remedied. I would have liked to have said something of the lives of other contemporaries, such as Edward Alleyn, "who was Esquire made," and Ben Jonson, who criticized and praised Shakespeare; and to have aired some of my theories regarding the dramatic history of the time. But I did not wish, by presenting too many interesting people in the background, to distract my readers' attention from the central figures, or to divert their thoughts from the facts presented, to any discussion of my views. I may now, however, make some trifling suggestions regarding the facts on which I have so long dwelt. It may be noticed, by those who read my Note 28, the list of "the performances for 80 years of the Burbage Company," that there is a gap during which they do not perform at court, i.e., between 1563 and 1572. The wholesome tendency to return to the original methods of production for guidance would be more effectual if a distinction were made between what is still applicable in those original methods and what is not. The author's argument is provocative and amusing throughout; it begins with detailed complaints and ends with detailed remedies. A generous amount of information about Elizabethan precedents and traditions is included. Alfred Harbage has published numerous books which have become cornerstones in Shakespearean scholarship: Annals of English Drama, 975-1700; Shakespeare's Audience; As They Liked It; and Shakespeare and the Rival Traditions. He has prepared new editions of The Tempest and As You Like it, is General Editor of the American Pelican Shakespeare, had published articles in learned journals, and has held editorial and advisory posts.

#### Shakespeare's Globe

The beginning of the English drama dates from a late period in the history of this country. Until the reign of Elizabeth, dramatic literature was really non-existent. During the Middle Ages, the religious drama held complete sway over the populace, producing such an abiding effect that no other kind of performance was tolerated. In England the first germs of a dramatic nature emanated from the church, chiefly in connection with the festival at Eastertide. At this time of the year the ritual was solemnized in a highly theatrical fashion. Processions marched round the sacred edifice, various scenes from the Gospels were introduced, accompanied by music and song. The festivals of Christmas and Corpus Christi were observed with great enthusiasm, sacred episodes taken from church history were acted with such fervour and ecstasy that the congregation remained spellbound during the service. The next development in the evolution of the drama is the representation of the liturgical play, written in Latin, gradually being superseded by the religious play written in the vernacular; the scenes depicted consisted chiefly of episodes in connection with the Birth of the Saviour, also of events narrating the Lives of the Saints, together with other legendary characters. All these scenes were called Miracle Plays, a name by which in this country all religious dramas were known, regardless of the origin of their source. In course of time these first offshoots of the ordinary service had grown to such dimensions that it was found impracticable that these spectacles should be presented inside the church, consequently, a larger space outside was deemed more convenient, but still remaining within the precincts. Even this innovation was not entirely successful, as the ground allotted for the performance was not extensive enough for the numerous throng that assembled on these occasions. Then a further step was taken by transferring the scene of action from the sacred precincts to the open spaces within the town. The development of the drama was greatly accelerated by this innovation. During the period that these plays formed part of the religious service, the clergy only were allowed the privilege of assuming the different characters, but when spectacular episodes were added to the ordinary ritual they became secularized by calling in the aid of the various guilds, assisted by professional entertainers. By these means the plays gradually lost their religious significance, finally being regarded as a popular form of amusement. By an act of Pope Gregory in 1210, the priests were forbidden to officiate in these interludes in any capacity, even if held inside the church. After the act had been confirmed by the Council of Trent in 1227, the clergy were strictly prohibited from joining the open-air performance.

Meanwhile, Dick seems to win Fancy's heart, and she discovers an effective strategem to overcome her father's objection to the potential marriage. After the two are engaged secretly, however, vicar Maybold impetuously asks Fancy to marry him and lead a life of relative affluence; racked by guilt and temptation, she accepts. The next day, however, at a chance meeting with the as-yet-unaware Dick, surprised Maybold learns from him of his engagement to Fancy. The vicar follows by prompting her by letter, while expressing being taken aback by such news, to be honest to Dewy and withdraw her commitment to him if she indeed intended to become married to Maybold. Fancy responds by withdrawing her consent to marry Maybold and asking him to keep her initial acceptance of his proposal forever a secret. Maybold replies by urging her again to be honest with Dick and admit she accepted the vicar despite having already committed herself to the young tranter, assuring her she would be forgiven. However, as she marries Dewy who is so in love he readily dismisses what he previously (rightly) considered exhibits of her fickleness and rejoices at what he perceives at the prospect of a happy union based on honesty, given Fancy's effusive and seemingly frank admission to some (minor) infidelities, while he assumes they would never keep any secrets from each other, she resolves never to disclose the truly incontrovertible and damning evidence against her character in her having so readily accepted Maybold despite her engagement to Dewy. The novel ends with a humorous portrait of Reuben, William, Mr. Day, and the rest of the Mellstock rustics as they celebrate the couple's wedding day. The mood is joyful, but at the end of the final chapter, the reader is reminded that Fancy has married with "a secret she would never tell" (her final flirtation and brief engagement to the vicar). While Under the Greenwood Tree is often seen as Hardy's gentlest and most pastoral novel, this final touch introduces a faint note of melancholy to the conclusion.....
