And yet Asad's is an intensely human life, one suffused with dreams and desires and a need to leave something of permanence on this earth.

Man and Africa

While masculinity studies enjoys considerable growth in the West, there is very little analysis of African masculinities. After a year-and-a-half of steady progress, the ex-president and the African nationalist realize they have miscalculated the costs of irrigating the African tropical savannas,

and the project stalls. A brilliant, young, autistic project employee, originally hired to oversee the use of Africa's natural resources, solves the irrigation problem, allowing the plan to continue moving forward. The autistic project employee later comes to the rescue once again when he clears the name of the ex-president, who had been falsely accused of bribery. The author believes the fictional narrative of this unique story will show the need to stabilize Africa's social order, infrastructure, and land use, which would result in an economic rejuvenation of the continent, eventually turning Africa into an agricultural giant.

Voice in the Night

Africa is the cradle of mankind and the first traces of modern man come from South Africa. But the country has also experienced waves of inward migration from the earliest times, and the turmoil and wars that accompany them. Dutch settlers landed at Table Bay in 1652. In the young colony inter-racial marriages were common but the segregationist trend was soon clear. The 19th century saw the rise of several African states, notably the Zulus under their leader Shaka; the Zulu wars; the discovery of diamonds and then gold. And then in 1899 the Boer War, with its bitter aftermath. After 1918 Afrikaner nationalism began to gather momentum and in 1948 apartheid became official policy. But soon the ANC had its own momentum. After Sharpeville came the Rivonia trial, the Soweto uprising, the death of Steve Biko and the United Democratic Front. But it was economic problems and the end of the Cold War which finally finished apartheid and released Nelson Mandela in 1990. Since 1994 crime, unemployment and inequality have flourished alongside the callousness of Thabo Mbeki's regime. The author delivers frank and devastating judgements both on the apartheid years and government by the new ANC elite. For this is a country that still awaits a government who will govern for the whole nation.

One White Man in Black Africa

Memory Against Forgetting

Looking at decolonization in the conditional tense, this volume teases out the complex and uncertain ends of British and French empire in Africa during the period of 'late colonial shift' after 1945. Africa must

have dependable electricity that services all homes and businesses. Africa's tropical savannas' land, which contains 63% of the worlds arable farm land, must be restructured to allow for optimal farming while at the same time protecting native wildlife. The pope's project, Build Africa Together, will be responsible for implementing these basic goals, which will eventually allow Africans to build a strong African middle-class society. Many people have ideas for changing the world, but not many people would be brave enough to put those ideas in a novel and release it to the world. However, that is exactly what author Peter D. Cimini was willing to do in order to share his thoughts with others. He believes that it is possible to rejuvenate Africa's economy and turn it into "an agriculture giant," and in order to get that point across, he wrote The Man Who Transformed Africa as a fictional narrative to tell the story of how this might happen.
