Nations, Identity, Power

This is an inspirational book that sheds new light on old subjects, equally relevant for both public and private sector policy makers alike.

The roots of nationalism

This collection brings together scholars from a wide range of disciplines to offer perspectives on national identity formation in various European contexts between 1600 and 1815. Contributors challenge the dichotomy between modernists and traditionalists in nationalism studies through an emphasis on continuity rather than ruptures in the shaping of European nations in the period, while also offering an overview of current debates in the field and case studies on a number of topics, including literature, historiography, and cartography.

Nation and National Identity

The resilience of nationalism in contemporary Europe may seem paradoxical at a time when the nation state is widely seen as being 'in decline'. In addition to these chapters, the volume also collects a number of thematically related group sections from the ICLA congress, preserving their original context.

The American Nation, National Identity, Nationalism

Connecting identities assesses how nations can bridge physical distance, water barriers, or sovereign boundaries. Grappling with National Identity

This book looks at the fundamental components of national identity as understood by ordinary nation members, and the way in which it is mobilised by political elites. Drawing on an original case comparison between Wales and the Basque Country, the author suggests there are many commonalities between these two nations, particularly around the fundamentals of their national identities. However, differences occur in terms of degree of intensity of feeling and around the politicisation of identity, with more entrenched and hostile political positioning in the Basque Country than Wales. Through a multi-level comparison, the book generates insights into national identity as a theoretical concept and in a 'stateless nation' context. It argues for national identity's intangible, yet polemical, nature, looking at the primordialist way it is understood, its permanence and importance, coupled with its lack of everyday salience and consequent obligations.

Rethinking Stateless Nations and National Identity in Wales and the Basque Country

Now in paperback, this global bestseller is an engaging and informative read on the history of a diverse array of countries. Global histories tend to be written from the limited viewpoint of a single author and a single perspective, which results in an inevitable bias. In this book, however, twenty-eight different writers and scholars from around the world contribute, giving engaging, often passionate accounts of their own nation's history. The countries featured in Histories of Nations have been selected to represent every continent and type of state: large and small; mature democracies and religious autocracies; states that have existed for thousands of years and those born as recently as the twentieth century. Each of these countries has a different relationship with history. In the United States, for example, the myth of the nation's "historylessness" remains strong, but in China history is seen to play a crucial role in legitimizing three thousand years of imperial authority. "History wars" over the content of textbooks rage in countries as diverse as Australia, Russia, and Japan. Some countries, such as Iran or Egypt, are blessed—or cursed—with a glorious ancient history that the present cannot equal; others, such as Germany, must find ways of approaching and reconciling the pain of the recent past. Original, thought-provoking, and handy in its new paperback format, Histories of Nations is a crucial primer for the Global Age.

Remaking the Nation

Spanish identity in the age of nations offers the first comprehensive account in any language of the formation and development of Spanish national identity from ancient times to the present. Much has

been written on French, British and German nationalism, but remarkably little has been published on Spanish nationalism. Paradoxically, even in Spain there is much more on Basque, Catalan and other regional nationalisms than on Spanish identity. As a result, this study fills an enormous gap in the literature on Spanish history. This book traces the emergence and evolution of an initial collective identity within the Iberian Peninsula from the Middle Ages to the end of the ancien regime based on the Catholic religion, loyalty to the Crown and Empire. The adaptation of this identity to the modern era, beginning with the Napoleonic Wars and the liberal revolutions, forms the crux of this study. None the less, the book also embraces the highly contested evolution of the national identity in the twentieth century, including both the Civil War and the Franco Dictatorship. Histories of Nations

The Shaping of French National Identity

If nationalism is the assertion of legitimacy for a nation and its effectiveness as a political entity, why do many nations emphasize images of their own defeat in understanding their history? Using Israel, Serbia, France, Greece and Ghana as examples, the author argues that this phenomenon exposes the ambivalence that lurks behind the passions nationalism evokes. Symbols of defeat glorify a nation's ancient past, while reenacting the destruction of that past as a necessary step in constructing a functioning modern society. As a result, these symbols often assume a foundational role in national mythology. Threats to such symbols are perceived as threats to the nation itself and consequently are met with desperation difficult for outsiders to understand.

The Nation Made Real

After six decades of protracted refugeehood, patterns of social identification are changing among the young people of the fourth refugee generation in the Palestinian refugee camp Burj al-Shamali in Southern Lebanon. Though their identity as Palestinian refugees remains the same compared to older refugee generations, there is an important shift in the young refugees' relationship towards the homeland, their status as refugees, Islam, the camp society, as well as in their relationship towards religious or ethnic "others" in and outside Lebanon. This ePaper examines how technology, globalisation and outside influences have impacted the young Palestinians' interpretation of their identity and their understanding of Palestinianness. The author concludes with reflections on the young refugees' attitudes towards their Palestinian identity in the diaspora, which, as she argues, can only survive when the young refugees see their identity as a virtue rather than as a hindrance.
