The Ancien Régime

The Tio Kingdom of The Middle Congo

This book addresses theoretical problems concerning legal evidence. The concept of evidence is expected to fulfill a number of distinct roles in science and philosophy, but also in legal theory and law, some of which are complementary, while others are conflicting. In their profession, lawyers have to deal with evidence and proof. Yet the legal concept of evidence is constantly changing, and the debate concerning the distinction between a legal concept of evidence, the ordinary concept of evidence and the concept of evidence in science is far from being settled. What is more, the problem of evidence is central to both epistemology and the philosophy of science, and by extension to our academic thinking on law. In short, legal theorists' interest in evidence may include such diverse objects as a bloody knife, sensory data, linguistic entities or psychologically recognized beliefs. The book surveys selected theoretical roles that the concept of evidence plays and explores their relations and interconnections. The content is divided into three parts, investigating: (1) evidence in epistemology and the philosophy of science, which focuses on evidence methodologies and the problem of proof in legal scholarship; (2) evidence in legal theory and legal philosophy, where particular attention is paid to the interplay between evidence, legal reasoning and the binding force of such reasoning; and (3) evidence in law, where theoretical problems pertaining to witnesses, expert opinions, explanations of the accused, statistical evidence and neuroscientific evidence are examined.

Britain and the Congo in the Nineteenth Century

The 1960s were perhaps a decade of confusion, when scientists faced difficulties in dealing with imprecise information and complex dynamics. A new set theory and then an infinite-valued logic of Lotfi A. Zadeh were so confusing that they were called fuzzy set theory and fuzzy logic; a deterministic system found by E. N. Lorenz to have random behaviours was so unusual that it was lately named a chaotic system. Just like irrational and imaginary numbers, negative energy, anti-matter, etc., fuzzy logic and chaos were gradually and eventually accepted by many, if not all, scientists and engineers

as fundamental concepts, theories, as well as technologies. In particular, fuzzy systems technology has achieved its maturity with widespread applications in many industrial, commercial, and technical fields, ranging from control, automation, and artificial intelligence to image/signal processing, pattern-recognition, and electronic commerce. Chaos, on the other hand, was considered one of the three monumental discoveries of the twentieth century together with the theory of relativity and quantum mechanics. As a very special nonlinear dynamical phenomenon, chaos has reached its current outstanding status from being merely a scientific curiosity in the mid-1960s to an applicable technology in the late 1990s. Finding the intrinsic relation between fuzzy logic and chaos theory is certainly of significant interest and of potential importance. The past 20 years have indeed witnessed some serious explorations of the interactions between fuzzy logic and chaos theory, leading to such research topics as fuzzy modeling of chaotic systems using Takagi–Sugeno models, linguistic descriptions of chaotic systems, fuzzy control of chaos, and a combination of fuzzy control technology and chaos theory for various engineering practices.

Miscellany/Mixtures

Theory of Legal Evidence - Evidence in Legal Theory

In contemporary philosophy, substantive moral theories are typically classified as either consequentialist or deontological. Standard consequentialist theories insist, roughly, that agents must always act so as to produce the best available outcomes overall. Standard deontological theories, by contrast, maintain that there are some circumstances where one is permitted but not required to produce the best overall results, and still other circumstances in which one is positively forbidden to do so. Classical utilitarianism is the most familiar consequentialist view, but it is widely regarded as an inadequate account of morality. Although Professor Scheffler agrees with this assessment, he also believes that consequentialism seems initially plausible, and that there is a persistent air of paradox surrounding typical deontological views. In this book, therefore, he undertakes to reconsider the rejection of consequentialism. He argues that it is possible to provide a rationale for the view that agents need not always produce the best possible overall outcomes, and this motivates one departure from consequentialism; but he shows that it is surprisingly difficult to provide a satisfactory rationale for the view that there are times when agents must not produce the best possible overall outcomes. He goes on to argue for a hitherto neglected type of moral conception, according to which agents are always permitted, but not always required, to produce the best outcomes.

Andre Vachon is clearly traditional in his choice of theme, selection of material, and the historical methods that he adopts. He expounds an older interpretation that accounted for the expansion of New France in terms of missionary zeal, the geographic imperative, economic necessity, and military security. Nothing is said that reflects the historical revisionism of the last two decades with its emphasis on self-interest and the personal pecuniary motive. The heroes are familiar: Cartier, Champlain, Talon, and Laval, but not Frontenac. The author raises no serious doubts about the desire on the part of these individuals for the expansion of New France, but he is forced to admit that by 1700 the colony had become too big and too fragile. Hardly a soul is criticized in the entire text. The general reader might be amused by knowing how cunning Amerindians duped Jacques Cartier or that Champlain never learned an Indian language and judged their conduct by the standards of French law rather than according to native customs he could never appreciate. ..."-- from review by T.A.
