## Presidential Impeachment and the New Political Instability in Latin America

#### The New Faces of Fascism

What is fascism in the twenty first century? What does Fascism mean at the beginning of the twenty-first century? When we pronounce this word, our memory goes back to the years between the two world wars and envisions a dark landscape of violence, dictatorships, and genocide. These images spontaneously surface in the face of the rise of radical right, racism, xenophobia, islamophobia and terrorism, the last of which is often depicted as a form of "Islamic fascism." Beyond some superficial analogies, however, all these contemporary tendencies reveal many differences from historical fascism, probably greater than their affinities. Paradoxically, the fear of terrorism nourishes the populist and racist rights, with Marine Le Pen in France or Donald Trump in the US claiming to be the most effective ramparts against "Jihadist fascism". But since fascism was a product of imperialism, can we define as fascist a terrorist movement whose main target is Western domination? Disentangling these contradictory threads, Enzo Traverso's historical gaze helps to decipher the enigmas of the present. He suggests the concept of post-fascism--a hybrid phenomenon, neither the reproduction of old fascism nor something completely different--to define a set of heterogeneous and transitional movements, suspended between an accomplished past still haunting our memories and an unknown future.

## The Re-invention of the European Radical Right

Political commentators were surprised at the re-emergence of right-wing parties in Western Europe in the 1970s and early 1980s given that right-wing extremists had largely disappeared from successful electoral politics after the end of the Second World War. Since their resurgence, such parties have become permanent fixtures across Europe. The Re-invention of the European Radical Rightexamines what accounts for their initial rise and their continued success as well as how they should be classified: are they fascist, neo-fascist, radical, extreme, or populist? Combining an in-depth case study of the Italian Northern League with a comparative focus on other parties, Andrej Zaslove employs a socio-economic, institutional, and ideological analysis to argue that the new wave of right-wing parties in Western Europe converged into a radical right populist party family in the 1990s. He examines the transformation of the Northern League from its regionalist roots while focusing on the party's

nationalism, authoritarianism, support for a market economy, opposition to globalization, and scepticism regarding Italian integration into the European Union. He also scrutinizes the Northern League's participation in political power between 2001 and 2006 and its influence on federalism, immigration, economic policy, and European integration. Our Unsustainable Life: Why We Can't Have Everything We Want With the concept of the Imperial Mode of Living, Brand and Wissen highlight the fact that capitalism implies uneven development as well as a constant and accelerating universalisation of a Western mode of production and living. The logic of liberal markets since the 19th Century, and especially since World War II, has been inscribed into everyday practices that are usually unconsciously reproduced. The authors show that they are a main driver of the ecological crisis and economic and political instability. The Imperial Mode of Living implies that people's everyday practices, including individual and societal orientations, as well as identities, rely heavily on the unlimited appropriation of resources; a disproportionate claim on global and local ecosystems and sinks; and cheap labour from elsewhere. This availability of commodities is largely organised through the world market, backed by military force and/or the asymmetric relations of forces as they have been inscribed in international institutions. Moreover, the Imperial Mode of Living implies asymmetrical social relations along class, gender and race within the respective countries. Here too, it is driven by the capitalist accumulation imperative, growth-oriented state policies and status consumption. The concrete production conditions of commodities are rendered invisible in the places where the

commodities are consumed. The imperialist world order is normalized through the mode of production and living.

## EU External Relations Law and Policy in the Post-Lisbon Era

# The Right in the Twentieth Century

After decades of intense interest and rivalry with the USA, the end of the Cold War and the dismantling of the USSR officially marked a period of significant retreat of Russia from the Middle East and North Africa (MENA). However, with Russia's economic recovery and the entrenchment of President Vladimir Putin, Russia's interest in the region has risen anew. Once again seen as a battleground to contest US hegemony, Russia has expanded its political, military and (to a lesser extent) economic relationships across the region. Most apparent in the military intervention in Syria, Russia has also been engaged with traditional rivals Iran, Saudi Arabia and Turkey, stepping into the vacuum left by the US Obama Administration. Is Russia's reengagement part of a strategy, or is it mere opportunism? Authors with different backgrounds, experiences and origins examine this question via an analysis of the historical drivers of Russian interest in the MENA region and the factors underlying current Russian policies.

#### Russia in the Middle East and North Africa

Less than a decade after the advent of democracy in South Africa, tabloid newspapers have taken the country by storm. One of these papers -- the Daily Sun -- is now the largest in the country, but it has generated controversy for its perceived lack of respect for privacy, brazen sexual content, and unrestrained truth-stretching. Instead, hungry to coin the next Big Idea, they are in the business of advancing simplistic, glib mythologies. The result is that Americans are often presented with a fantasy world of nightmare scenarios rather than with explanations that lead to rational choices. Taking to task such well-known figures as Samuel Huntington, Noam Chomsky, and Jeffrey Sachs, Halper and Clarke argue for a revival of integrity within our foreign policy elite so that America's standing in the world can be restored. A book that pulls no punches, The Silence of the Rational Center is both a penetrating diagnosis and a stirring call to reform in what is possibly the most important area of American political life.

#### The Silence of the Rational Center

In the 1980s and 1990s, Nicolas Jabko suggests, the character of European integration altered radically, from slow growth to what he terms a "quiet revolution." In this book he traces the political strategy that underlay the move from the Single Market of 1986 through the official creation of the European Union in 1992 to the coming of the euro in 1999. The official, shared language of the political forces behind this revolution was that of market reforms—yet, as Jabko notes, this was a very strange "market" revolution, one that saw the building of massive new public institutions designed to regulate economic activity, such as the Economic and Monetary Union, and deeper liberalization in economic areas unaffected by external pressure than in truly internationalized sectors of the European economy. What held together this remarkably diverse reform movement? Precisely because "the market" wasn't a single standard, the agenda of market reforms gained the support of a vast and heterogenous coalition. The "market" was in fact a broad palette of ideas to which different actors could appeal under different circumstances. It variously stood for a constraint on government regulations, a norm by which economic activities were (or should be) governed, a space for the active pursuit of economic growth, an excuse to discipline government policies, and a beacon for new public powers and rule-making. In chapters on financial reform, the provision of collective services, regional development and social policy, and economic and monetary union, Jabko traces how a coalition of strange bedfellows mobilized a variety of market ideas to integrate Europe.

## Playing the Market

In the course of the twentieth century, there occurred a development unique in the story of humankind. States, which had defined themselves from Thucydides to Bismarck by their claims to sovereign independence, gradually came together to create international organizations to promote peace, curb aggression, regulate diplomatic affairs, devise an international code of law, encourage social development and foster prosperity. The emergence of this network of global governance was not straightforward and the debate about its role is just as heated today as it was generations ago. In this long-awaited new book, Paul Kennedy, probably the best-selling historian now living, examines this key development in the history of our century. Beginning with the earliest forms of international organization, he goes on to trace the creation and changing role of the UN in the postwar era, and finally suggests how, in the face of new threats to security and the continued vigour of at least some nation states, the institution will need to change over the course of the twenty-first century, arguing that we all share the responsibility to make the only world organization we possess work as well as possible.

# **Governing America**

This book provides a detailed analysis of the policy-making processes of EU strategies in foreign and security policy and external action. It uses the European Security Strategy and the EU Global Strategy to assess their policy-making dynamics both before and after the Lisbon Treaty. Inter-institutional relations in strategy-making are put into the context of current debates in European integration, questioning the assumption that the EU is a body increasingly ruled by intergovernmentalism - as reflected by the new intergovernmentalism literature. The book also provides a categorisation of EU strategies and considers them as policy-inspiration documents, acting as frameworks for policy-making. This reading of strategies lies behind the analysis of the policy-making processes of the ESS and the EUGS, unpacked into four phases: agenda-setting, policy formulation, policy output and implementation. By looking at the shifting policy-making dynamics from foreign and security policy to external action, the author sheds light on the current shape of EU integration.
