When he set out northward from Savannah with 60,000 veteran soldiers in January 1865, he was more convinced than ever that the bold application of his ideas of total war could speedily end the conflict. Caudill and Ashdown argue that these myths have been employed by groups as disparate as those endorsing the Old South aristocracy and its "Lost Cause," and by others who saw the March as evidence of the superiority of industrialism in modern America over a retreating agrarianism. Home front and battle front merged in 1865 when General William T. Sherman occupied Savannah and then marched his armies north through the Carolinas. Although much has been written about the military aspects of Sherman's March, Jacqueline Campbell reveals a more complex story. Integrating evidence from Northern soldiers and from Southern civilians, black and white, male and female, Campbell demonstrates the importance of culture for determining the limits of war and how it is fought. Sherman's March was an invasion of both geographical and psychological space. The Union army viewed the Southern landscape as military terrain. But when they brought war into Southern households, Northern soldiers were frequently astounded by the fierceness with which many white Southern women defended their homes. Campbell argues that in the household-centered South, Confederate women saw both ideological and material reasons to resist. While some Northern soldiers lauded this bravery, others regarded such behavior as inappropriate and unwomanly. Campbell also investigates the complexities behind African Americans' decisions either to stay on the plantation or to flee with Union troops. Black Southerners' delight at the coming of the army of "emancipation" often turned to terror as Yankees plundered their homes and assaulted black women. Ultimately, When Sherman Marched North from the Sea calls into question postwar rhetoric that represented the heroic defense of the South as a male prerogative and praised Confederate women for their "feminine" qualities of sentimentality, patience, and endurance. Campbell suggests that political considerations underlie this interpretation--that Yankee depredations seemed more outrageous when portrayed as an attack on defenseless women and children. Campbell convincingly restores these women to their role as vital players in the fight for a Confederate nation, as models of self-assertion rather than passive self-sacrifice.

Sherman contributed a great deal to the war, and was partially responsible for the war ending when it did. He conducted one of the most brilliant military campaigns in modern history (actually, they were three campaigns--Atlanta, Savannah, and the Carolinas) and accomplished what many considered to be the impossible. His policy of total war, applied in the South, was utilized by Sheridan in the Shenandoah, and was later slightly modified to be used against the Indians. Thanks to his memoirs, we have a step-by-step account of how this policy developed. Sherman's work is engaging and very to the point. He is meticulous almost to a fault in his quest for accuracy and detail. His writing is very, very good, and easy to read. He endeavored to be objective in his evaluations. Quick to give praise and slow to censure, he was not afraid to record the failures of his subordinates. William T. Sherman is a very colorful figure in Civil War history. He may well be one of the most complex and intriguing individuals of the war. To some, he is a barbarian; to others, a deliverer. He is immensely quotable, and was very opinionated and outspoken. Far from being a dry account of a man's recollections, this is a very engaging and very worthwhile autobiography, and any student of the war will profit by reading it. Smith's and Wade Sokolosky's *To Prepare for Sherman's Coming*: The Battle of Wise's Forks, March 1865 erases this misconception and elevates this combat and its related operations to the historical status it deserves. By March 1865, the Confederacy was on its last legs. Its armies were depleted, food and resources were scarce, and morale was low. General Lee was barely holding on to his extended lines around Richmond and Petersburg, and Gen. William

T. Sherman was operating with nearly complete freedom in North Carolina on his way north to form a junction with Union forces in Virginia. As the authors demonstrate, the fighting that is the subject of this book came about when Lt. Gen. Ulysses S. Grant initiated a broad military operation to assist Sherman. The responsibility for ensuring a functioning railroad from New Bern to Goldsboro rested with Maj. Gen. Jacob D. Cox. On March 2, 1865, Cox ordered his hastily assembled Provisional Corps to march toward Goldsboro. In response to Cox's movement, Confederate Gen. Joseph E. Johnston executed a bold but risky plan to divert troops away from Sherman by turning back Cox's advance. Under the command of the aggressive but controversial Gen. Braxton Bragg, the Confederates stood for four days and successfully halted Cox at Wise's Forks. This delay provided Johnston with the precious time he needed to concentrate his forces and fight the large and important Battle of Bentonville. To Prepare for Sherman's Coming is the result of years of careful research in a wide variety of archival sources, and relies upon official reports, diaries, newspapers, and letter collections, all tied to a keen understanding of the terrain. Sokolosky and Smith, both career army officers, have used their expertise in military affairs to produce what is not only a valuable book on Wise's Forks, but what surely must be the definitive study of one of the Civil War's overlooked yet significant battles. Outstanding original maps by Mark A. Moore coupled with period photographs reinforce the quality of this account and the authors' commitment to excellence.

Memoirs of Gen. William T. Sherman -

Often hailed as a stroke of military genius, General William T. Sherman's decision to divide his command and his subsequent, infamous march through the interior of Georgia to the Atlantic coast inaugurated the final phase of the war. General Jacob D. Cox (1828–1900) played key roles in most of the decisive actions that followed. Left with Generals Schofield and Thomas to delay Hood's advance, Cox led his men through the night and at Spring Hill; he supervised the construction of the fortifications that proved so effective against Hood's assaulting columns at Franklin; at Nashville his division joined the attack on the crucial Confederate position at Shy's Hill; and later he finished his service with Sherman in North Carolina. It was Cox's self-professed qualities of "a bold heart, a cool head, and practical common-sense" that subsequently earned him the command of the entire Twenty-third Corps and the rank of major general. After the war, Cox applied those same attributes to his books, Sherman's Battle for Atlanta, and Sherman's March to the Sea, two volumes in the landmark series Campaigns of the Civil War. If readers are seeking concise, astute, and balanced accounts of Sherman's march to the sea, the burning of Columbia, the bloody battles of Franklin and Nashville, the oft-overlooked assault on Fort Fisher (which sealed the Confederacy from Europe), and the surrender of Johnston's Army, Cox's single volume provides all the scope, detail, and color that these critical campaigns demand.

Major-General Sherman's Reports

Hailed as a prophet of modern war and condemned as a harbinger of modern barbarism, Sherman is the most controversial general of the Civil War. "War is cruelty, you cannot refine it," he wrote in fury to the Confederate mayor of Atlanta, and his memoir is filled with dozens of such wartime exchanges and a fascinating, eerie account of the famous march through the Carolinas. Sure the memoirs remained controversial. W. T. Sherman's memoirs are still controversial, even today. He is either a great general, or an overrated one. He is either "hailed as a prophet of modern war or condemned as a modern barbarism." The historical value of these memoirs is enormous. Sherman contributed a great deal to the war, and was partially responsible for the war ending when it did. He conducted one of the most brilliant military campaigns in modern history (actually, they were three campaigns--Atlanta, Savannah, and the Carolinas) and accomplished what many considered to be the impossible. His policy of total war, applied in the South, was utilized by Sheridan in the Shenandoah, and was later slightly modified to be used against the Indians. Thanks to his memoirs, we have a step-by-step account of how this policy developed. Sherman's work is engaging and very to the point. He is meticulous almost to a fault in his quest for accuracy and detail. His writing is very, very good, and easy to read. He endeavored to be objective in his evaluations. Quick to give praise and slow to censure, he was not afraid to record the failures of his subordinates. William T. Sherman is a very colorful figure in Civil War history. He may well be one of the most complex and intriguing individuals of the war. To some, he is a barbarian; to others, a deliverer. He is immensely quotable, and was very opinionated and outspoken. If you're contemplating studying the Civil War, do not be put off by this book's length. Far from being a dry account of a man's recollections, this is a very engaging and very worthwhile autobiography, and any student of the war will profit by reading it. Volume 2 covers the Atlanta Campaign (including Nashville, Chattanooga, Kennesaw Mountain, and other battles around Atlanta), the pursuit of General Hood, the

"March to the Sea" from Atlanta to Savannah, chapters about Savannah and Pocotaligo, the Campaign of the Carolinas, the end of the war (from Goldsboro to Raleigh and Washington), and military lessons of the war, and the aftermath of the war.
