Structuring Inequality

How inequality was forged, fought over, and forgotten through public policy in metropolitan Chicago. As in many American metropolitan areas, inequality in Chicagoland is visible in its neighborhoods. These inequalities are not inevitable, however. They have been constructed and deepened by public policies around housing, schooling, taxation, and local governance, including hidden state government policies. Steffes shows how metropolitan inequality in Chicagoland was structured, contested, and naturalized over time even as reformers tried to change it through school desegregation, affordable housing, and property tax reform. While these efforts had modest successes in the city and the suburbs, reformers faced significant resistance and counter-mobilization from affluent suburbanites, real estate developers, and other defenders of the status quo who defended inequality and reshaped the policy conversation about it. Grounded in comprehensive archival research and policy analysis, *Structuring Inequality* examines the history of Chicagoland's established systems of inequality and provides perspective on the inequality we live with today.

Business Elites and Urban Development

During the Reagan era, responsibility for urban planning and development was transferred from government to private business. This private sector hegemony over urban development differs markedly from the liberal policy initiatives of the 1960s and 1970s. Through a series of case studies, this book examines these shifting trends and shows that private sector efforts to revitalize America's central cities have not been uniformly successful. The contributors, who are among America's leading social scientists, utilize neo-Marxist urban theory to explain the conditions under which private initiative enhances or erodes downtown redevelopment.

China's New Business Elite

The transition from a planned to a market economy that began in China in the late 1970s unleashed an extraordinary series of changes, including increases in private enterprise, foreign investment, the standard of living, and corruption. Another result of economic reform has been the creation of a new class—China's new business elite. Margaret M. Pearson considers the impact that this new class is having on China's politics. She concludes that, contrary to the assumptions of Westerners, these groups are not at the forefront of the emergence of a civil society; rather, they are part of a system shaped deliberately by the Chinese state to ensure that economic development will not lead to democratization.

Elites in an Egalitarian Society

Based on two unique survey studies of elites in Norway, this book examines whether elite attitudes towards central national issues have changed in the wake of international and national events and developments since 2000. The chapters examine elite integration and relations between elites and citizens in Norway as a means to discuss the continued viability of the Nordic welfare state model. This insight into how elites relate to central issues in Norwegian society and how they look upon citizens' political interest and competence in general, will be of interest to academics within sociology and political science, as well as journalists and commentators and policy makers.

Clash of Spirits

This text illuminates the oral traditions of the Philippines and the convergence of capitalism and the indigenous spirit world. The author examines the social relations, cultural meanings and political struggles surrounding the rise of sugar haciendas on Negros during the late Spanish colonial period, and their subsequent transformation under the aegis of the American colonial state. Drawing on oral

history, interviews and a wide array of sources culled from archives in Spain, the United States, the United Kingdom and the Philippines, the author reconstructs the emergence of a sugar-planter class and its strategic maneuvers to attain hegemony. The book portrays local actors taking an active role in shaping the external forces that impinge on their lives. It examines hacienda life from the indigenous perspective of magic and spirit beliefs, reinterpreting several critical phases of Philippine history in the process. By analyzing mythic tales as bearers of historical consciousness, the author explores the complex interactions between local culture, global interventions, and capitalist market forces.

Case Studies of City-County Consolidation

Facing cutbacks in federal and state assistance and a new wave of taxpayer revolts, local governments have renewed interest in local government consolidation as a way of achieving efficiencies of scale in response to citizen demands for services. Yet the vast majority of consolidation efforts fail, either during the process of drafting a charter or once they reach the ballot - only five have passed since 1990; only thirty-two have been successfully implemented since the first, when the city of New Orleans merged with Orleans Parish in 1805. Israel/Palestine and the Politics of a Two-State Solution

Its ferocious crews of gunmen grew around burly founder Sam Christian, the most feared man on Philly's streets. They developed close ties with the influential Nation of Islam and soon were executing rivals, extorting bookies connected to the city's powerful Cosa Nostra crew, and cowing local gangs. The Black Mafia was responsible for over forty killings, the most chilling being the 1973 massacre of two adults and five children in Washington,

D.C. Despite the arrests that followed, they continued their rampage, exploiting their ties to prominent lawyers and civil rights leaders. A heavy round of convictions and sentences in the 1980's shattered their strength â" only for the crack-dealing Junior Black Mafia to emerge in their wake. Researched with scores of interviews and unique access to informant logs, witness statements, wiretaps and secret FBI files, *Black Brothers, Inc.* is the most detailed account ever of an African-American organized crime mob, and a landmark investigation into the modern urban underworld. In this mission, Feagin fails more than he succeeds- partially because to get to his substantive argument a reader has to get through a chapter or two of sociological jargon, and another chapter or two of mind-numbing factual detail about every business leader who has ever lived in Houston. This book would have been better had it been about half its size. When he gets to substance, his attack on Houston fails because he shows nothing more than that Houston has problems just like other cities- pollution, congestion, poverty, sprawl. So Houston isn't utopia. So what? Feagin fails because he makes little effort to compare Houston to other cities, except for a stray remark here and there. So he really didn't persuade me that Houston's problems were due to its allegedly small government, or that more socialistic policies would be more successful. Moreover, Feagin is utterly blind to the unintended consequences of government action. For example, he praises Houston for enacting minimum parking requirements and setback regulations, overlooking the possibility that such regulations contribute to the ills that he complains about by forcing pedestrians to walk through seas of parking to get to buildings. He complains that Houston has less public housing than other cities- but how many Cabrini-Greens and similar fiascoes does a city need? He praises Minneapolis as a role model- overlooking the small fact that Minneapolis has lost a fourth of its 1950 population, while Houston keeps growing. One thing Feagin does right: he points out that Houston is

hardly a laissez-faire paradise, in that government has consistently subsidized its business elite through spending on roads, port facilities, convention centers, etc.

Private Wealth and Public Revenue

As the first elected black mayor of a major U.S. city, Cleveland's Carl B. Stokes embodied the transformation of the civil rights movement from a vehicle of protest to one of black political power. In this wide-ranging political biography, Leonard N. Moore examines the convictions and alliances that brought Stokes to power. Impelled by the problems plaguing Cleveland's ghettos in the decades following World War II, Stokes and other Clevelanders questioned how the sit-ins and marches of the civil rights movement could correct the exclusionary zoning practices, police brutality, substandard housing, and de facto school segregation that African Americans in the country's northern urban centers viewed as evidence of their oppression. As civil unrest in the country's ghettos turned to violence in the 1960s, Cleveland was one of the first cities to heed the call of Malcolm X's infamous "The Ballot or the Bullet" speech. Understanding the importance of controlling the city's political system, Cleveland's blacks utilized their substantial voting base to put Stokes in office in 1967. Stokes was committed to showing the country that an African American could be an effective political leader. He employed an ambitious and radically progressive agenda to clean up Cleveland's ghettos, reform law enforcement, move public housing to middle-class neighborhoods, and jump-start black economic power. Hindered by resistance from the black middle class and the Cleveland City Council, spurned by the media and fellow politicians who deemed him a black nationalist, and unable to prove that black leadership could thwart black unrest, Stokes finished his four years in office with many of his legislative goals unfulfilled. Focusing on Stokes and Cleveland, but attending to themes that affected many urban centers after the second great migration of African Americans to the North, Moore balances Stokes's failures and successes to

provide a thorough and engaging portrait of his life and his pioneering contributions to a distinct African American political culture that continues to shape American life.
